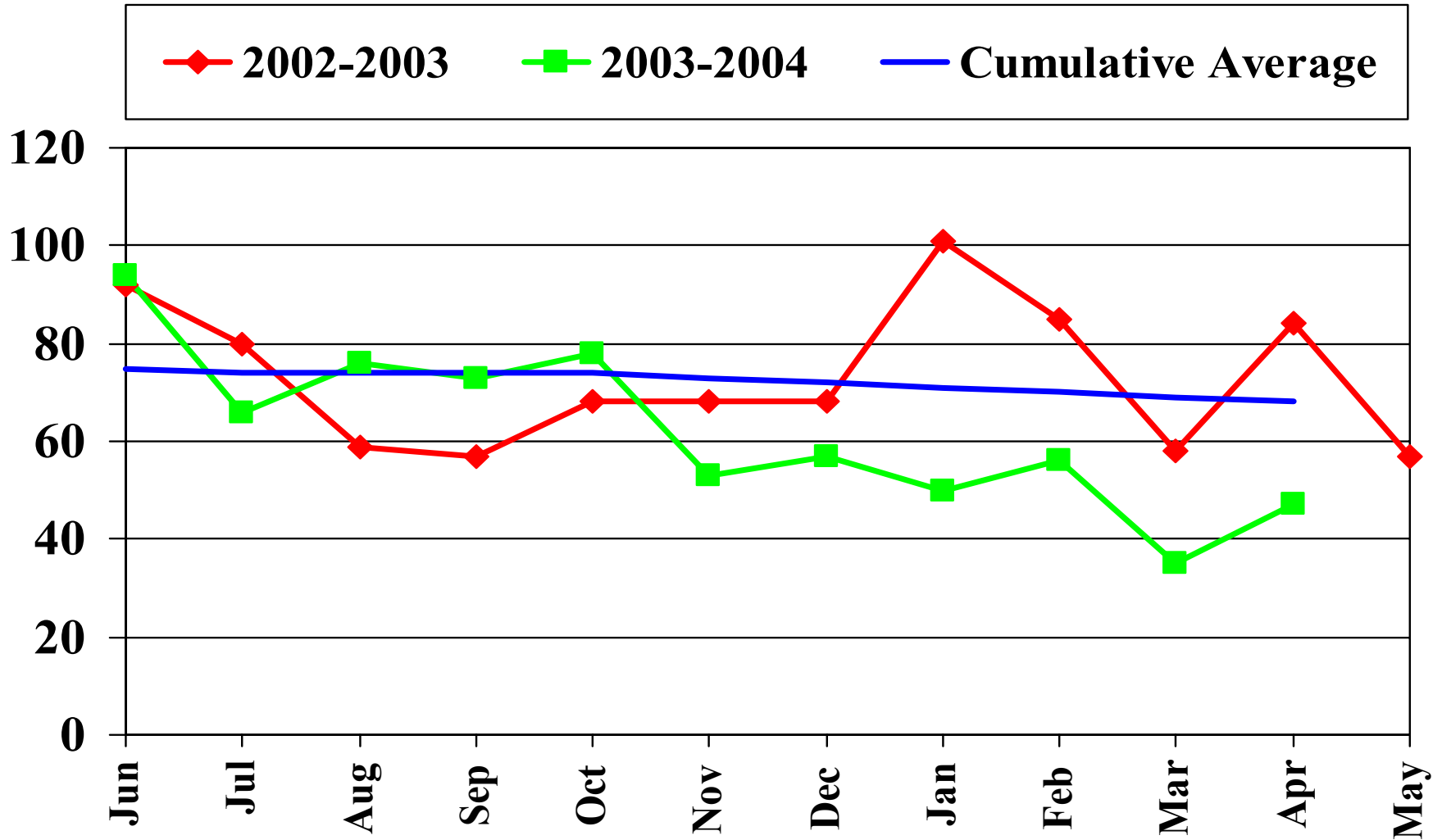

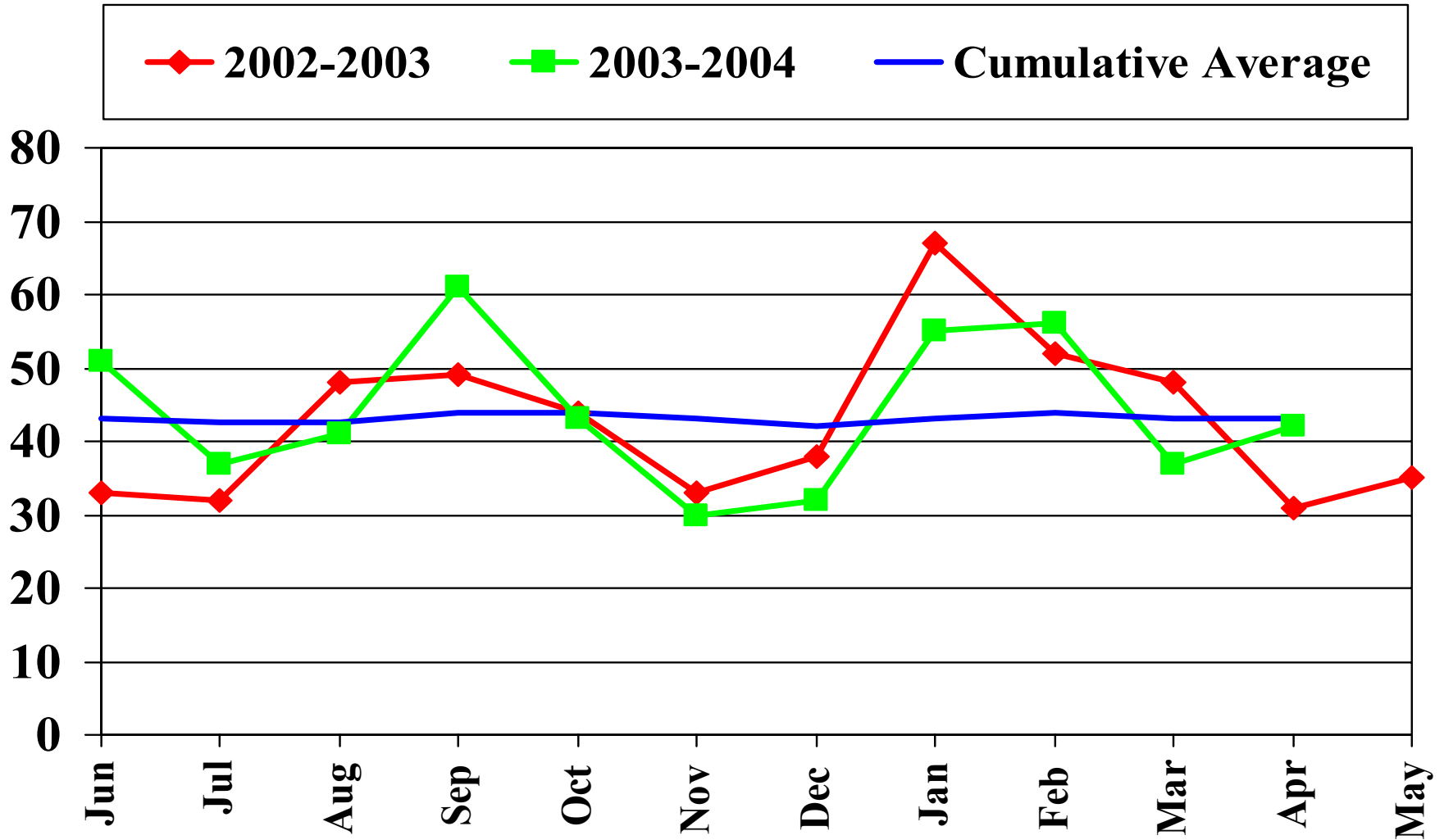

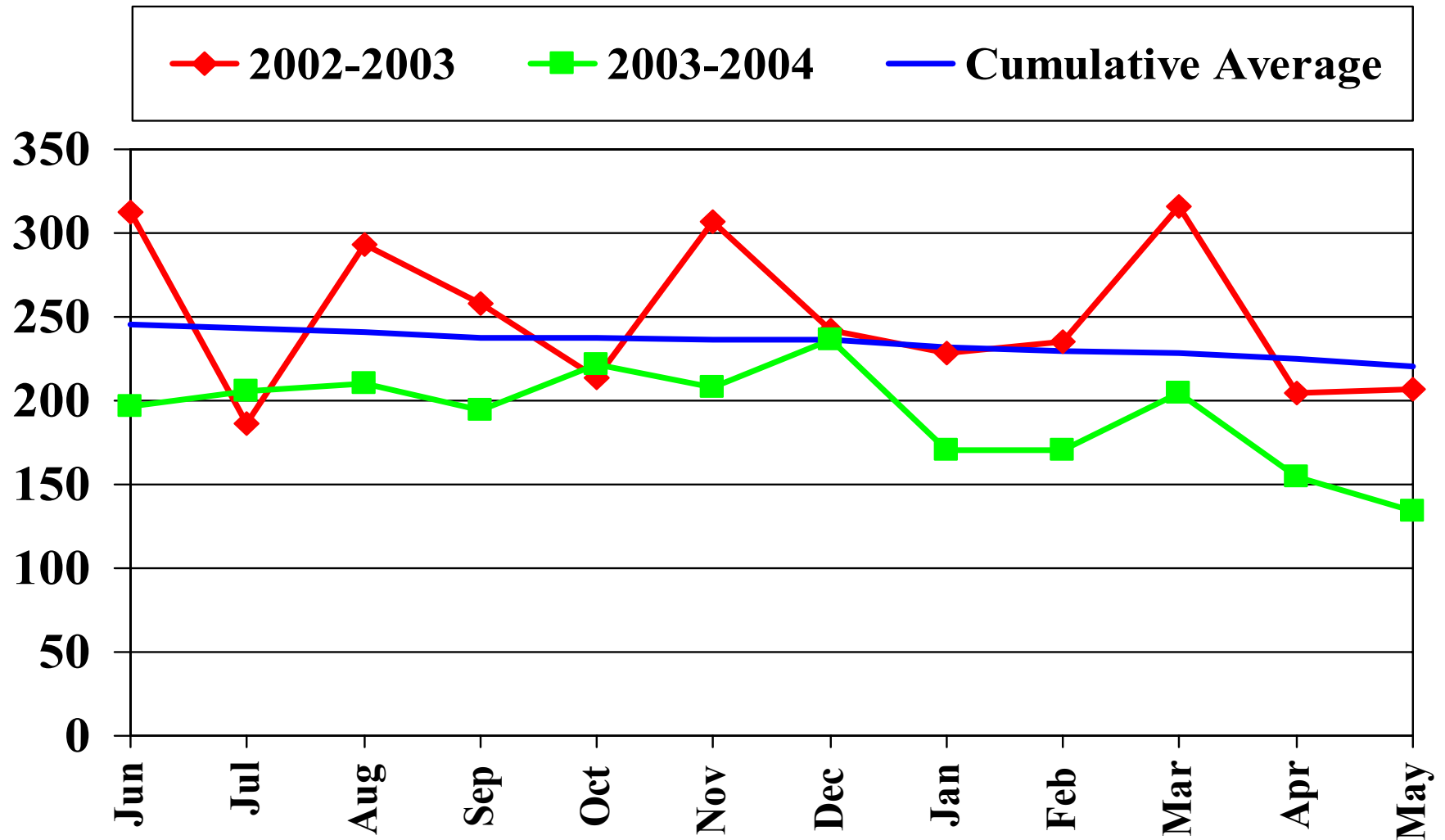

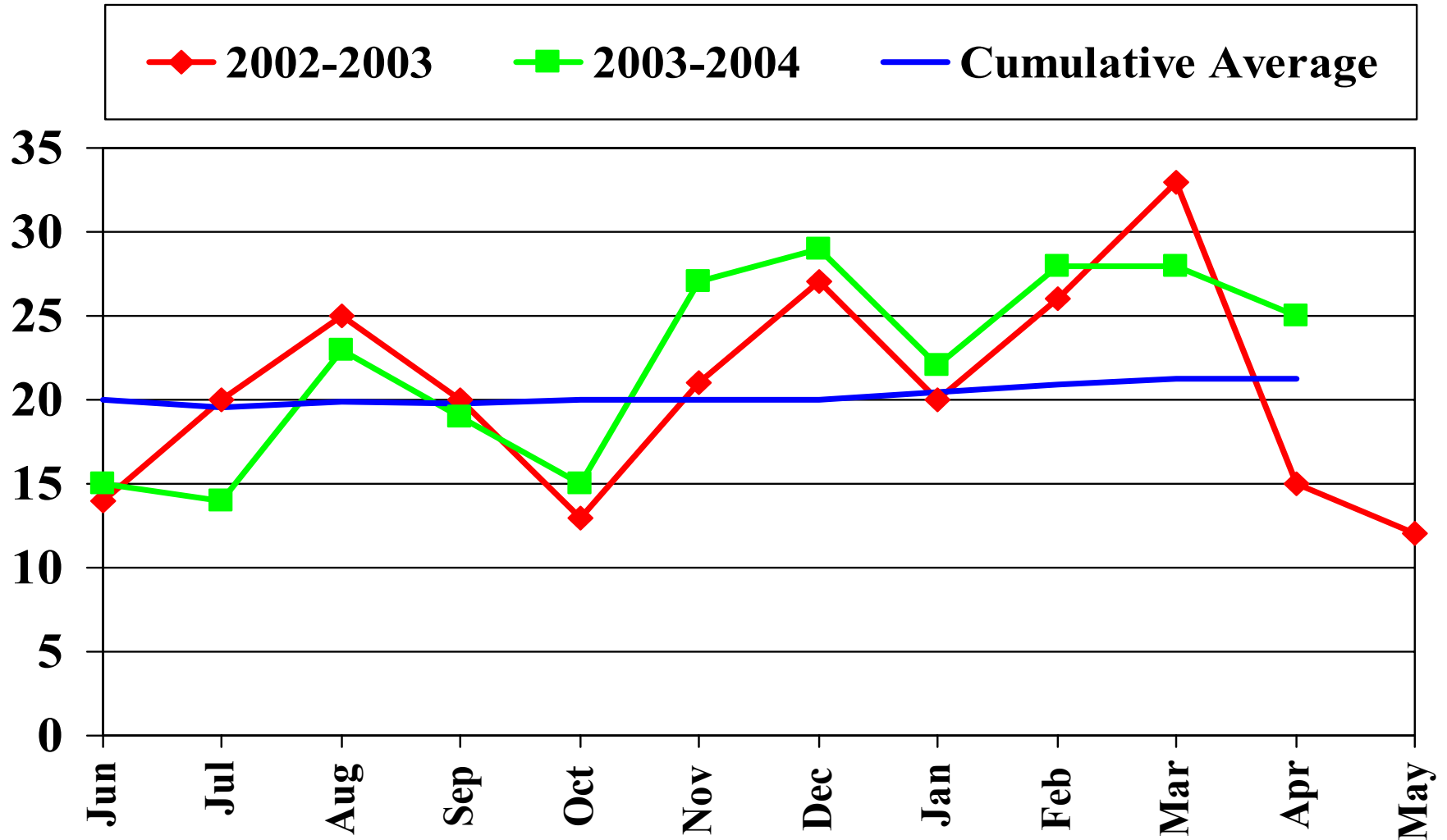

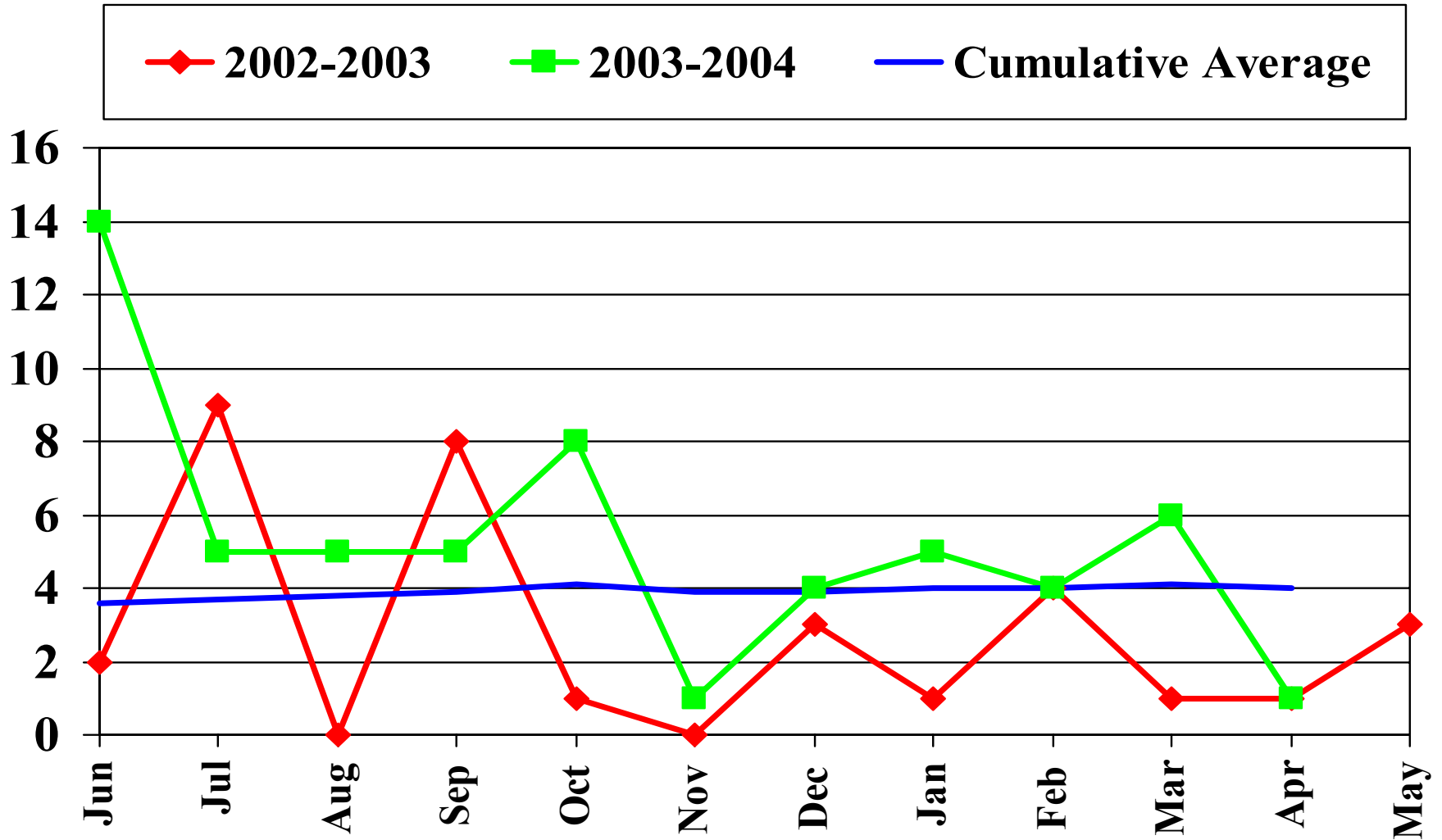

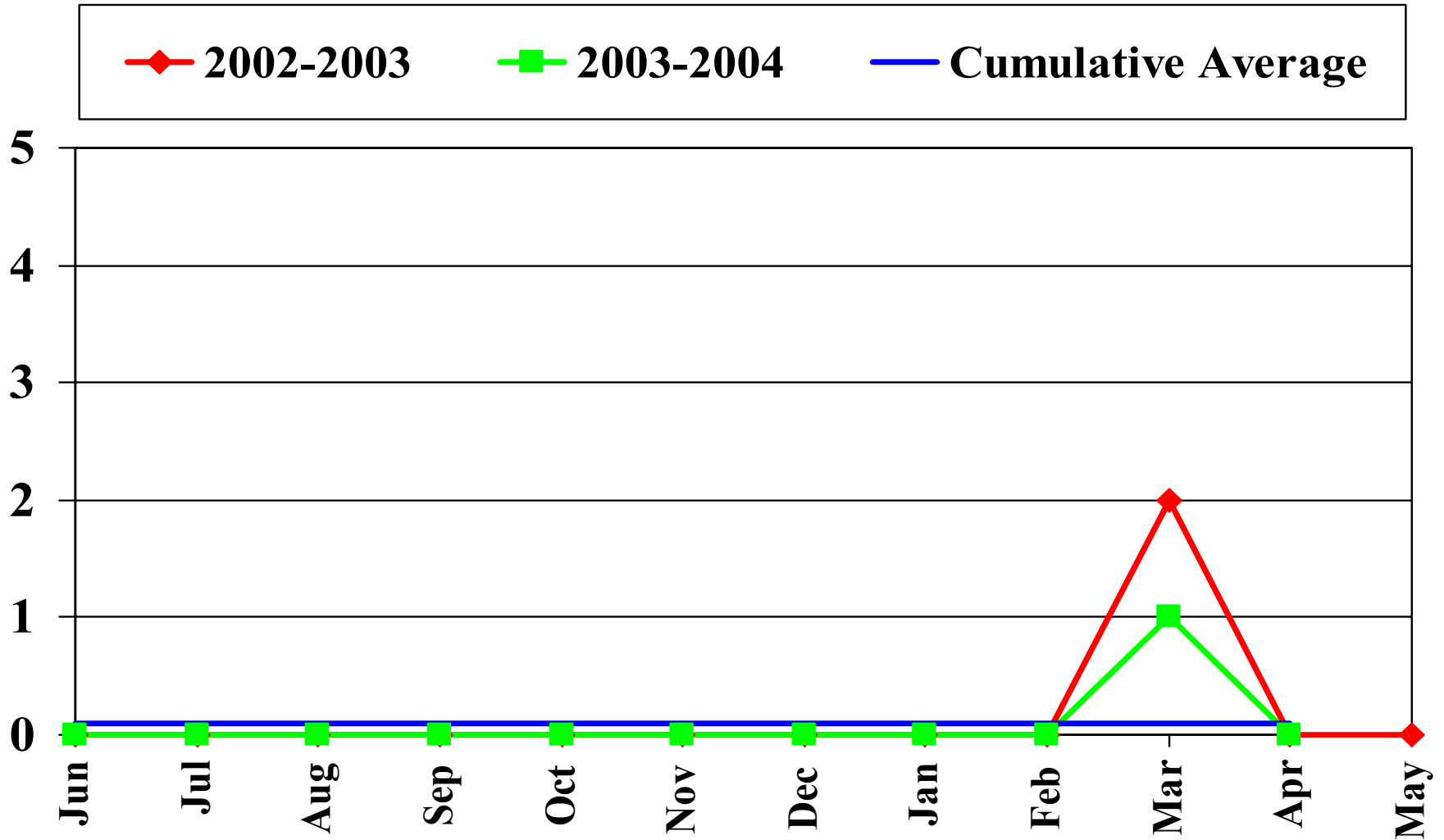

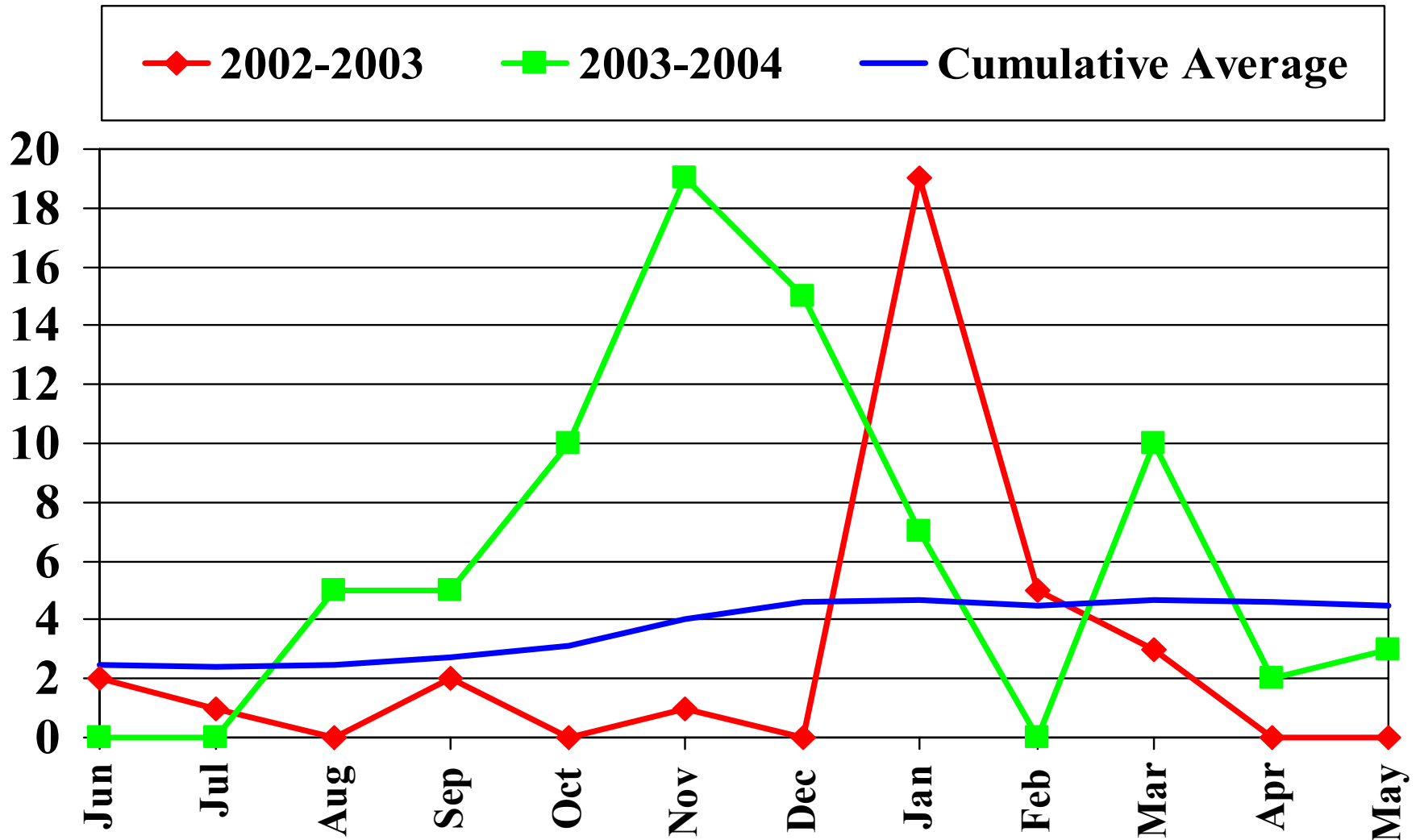

4(a) Total Restraining orders before the Court of Petty Sessions



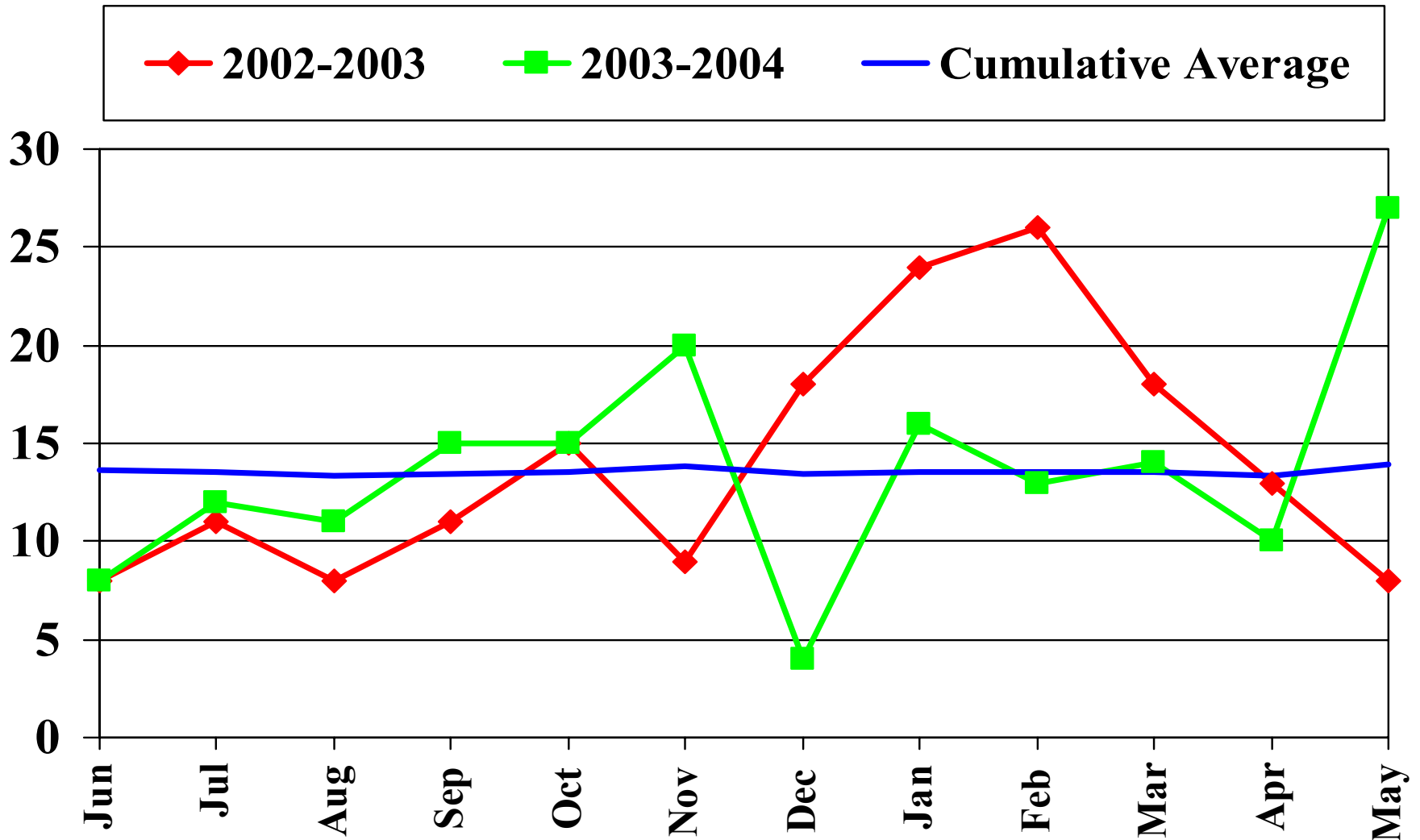

4(b) Total Restraining orders before the Children's Court



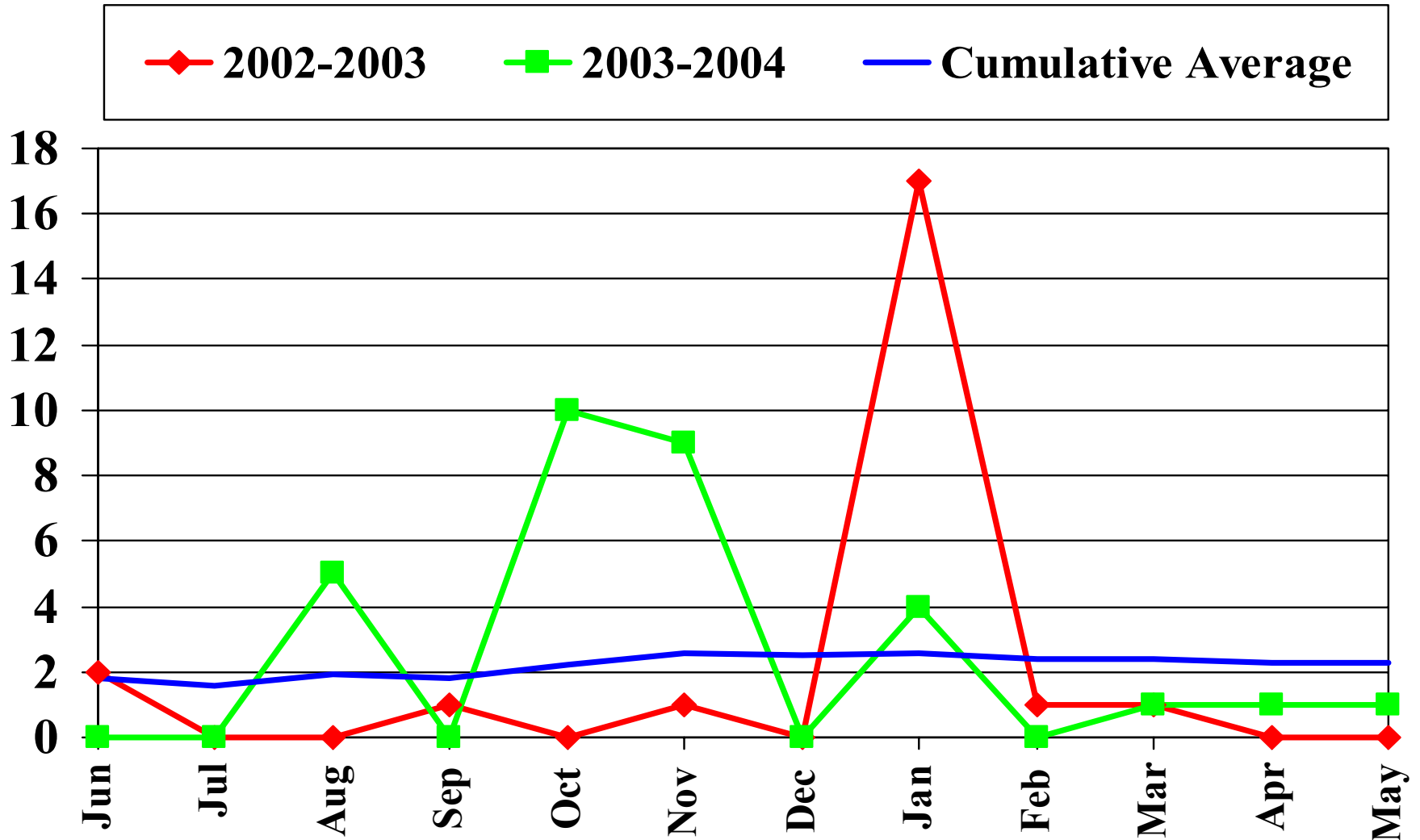

4(c) New restraining orders before the Court of Petty Sessions



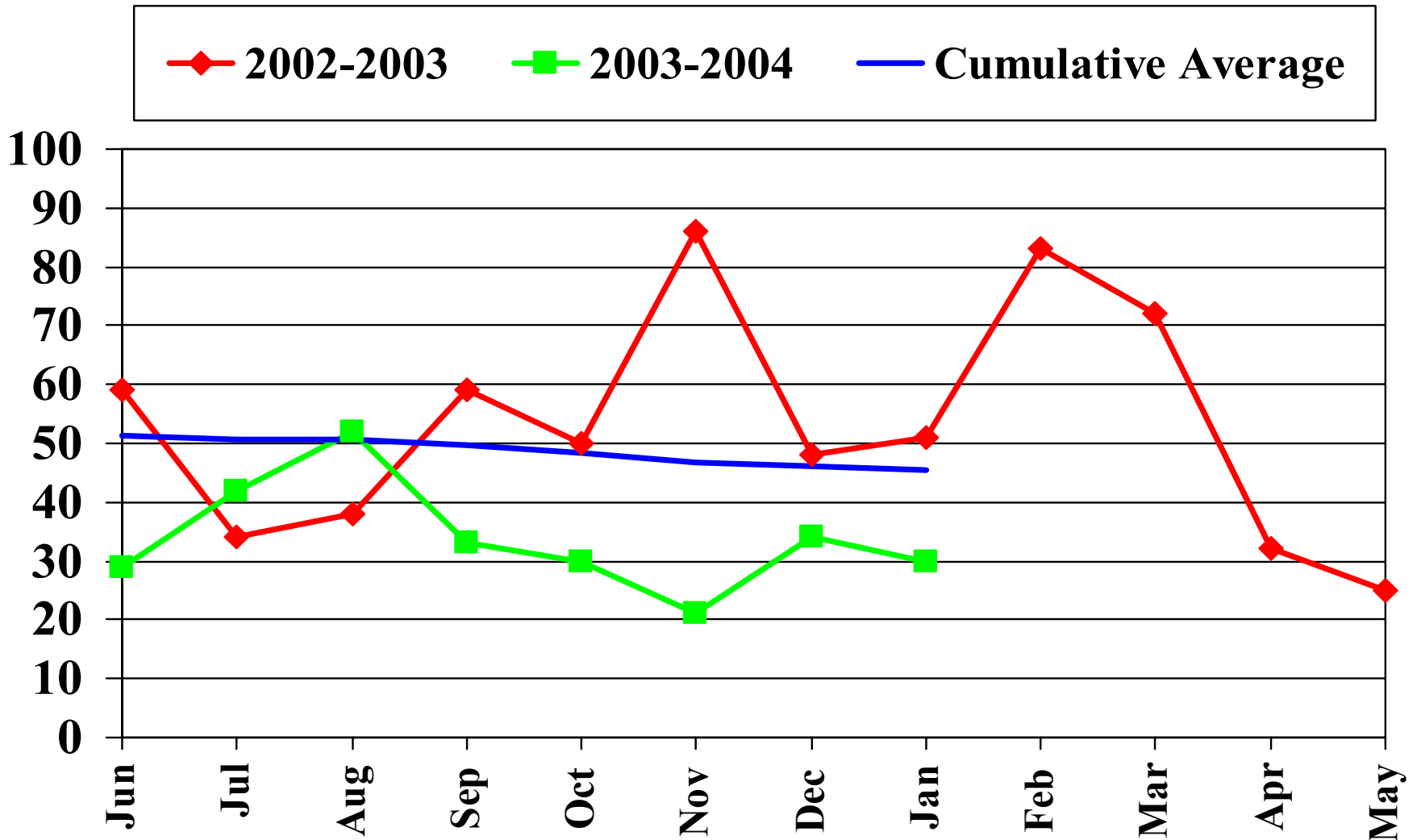

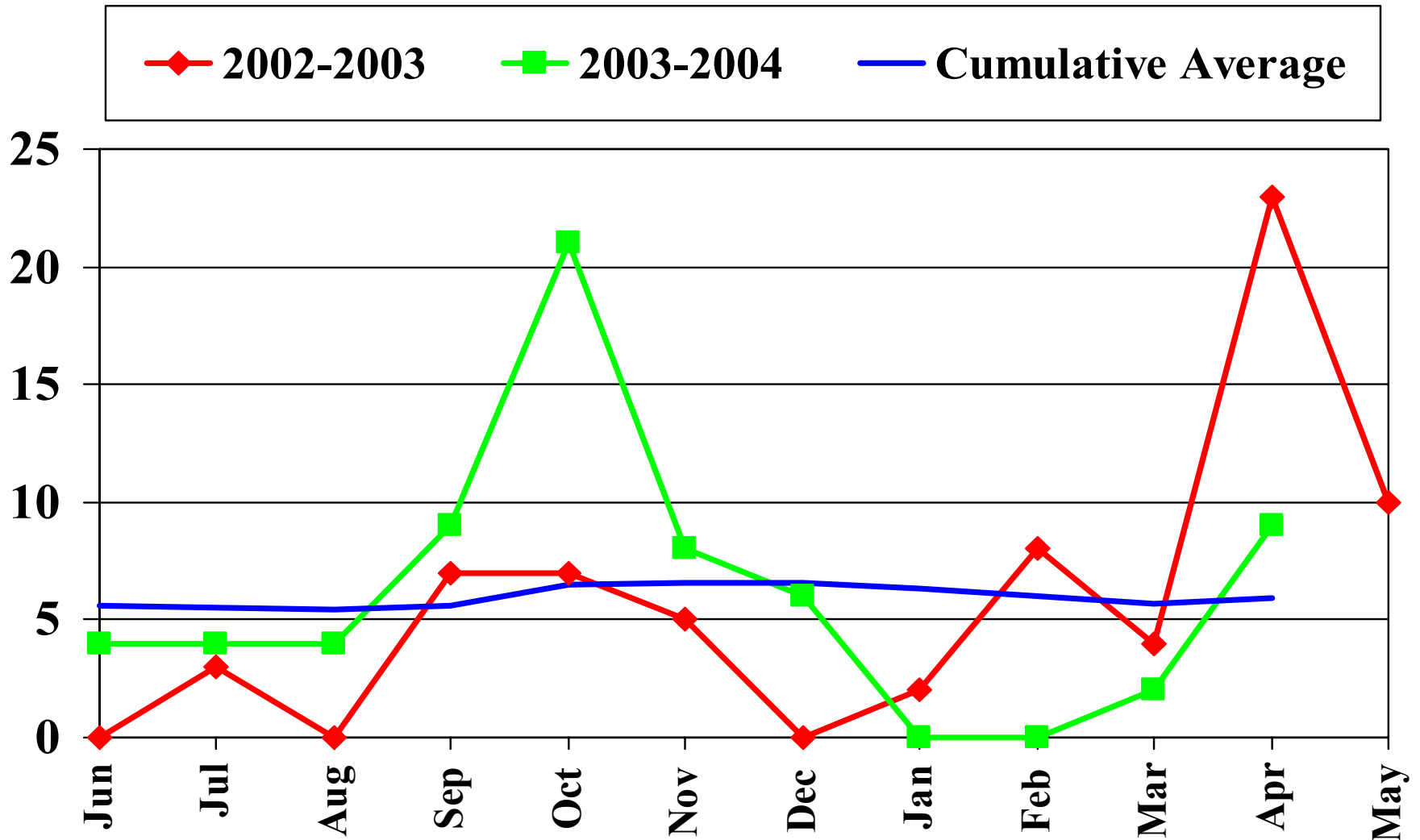

4(e) Persons presenting at DCD and SAAP services as a result of domestic or family violence.



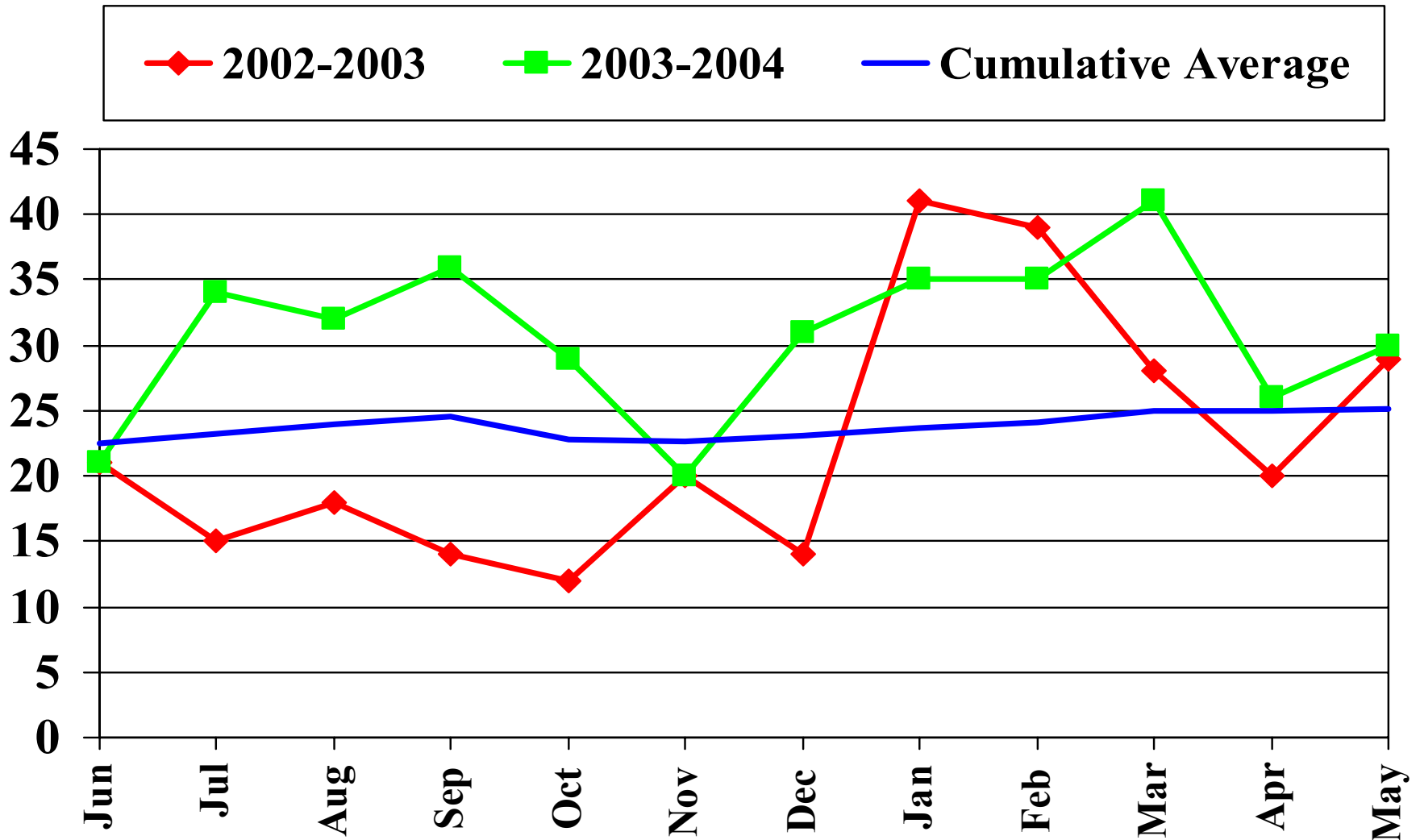

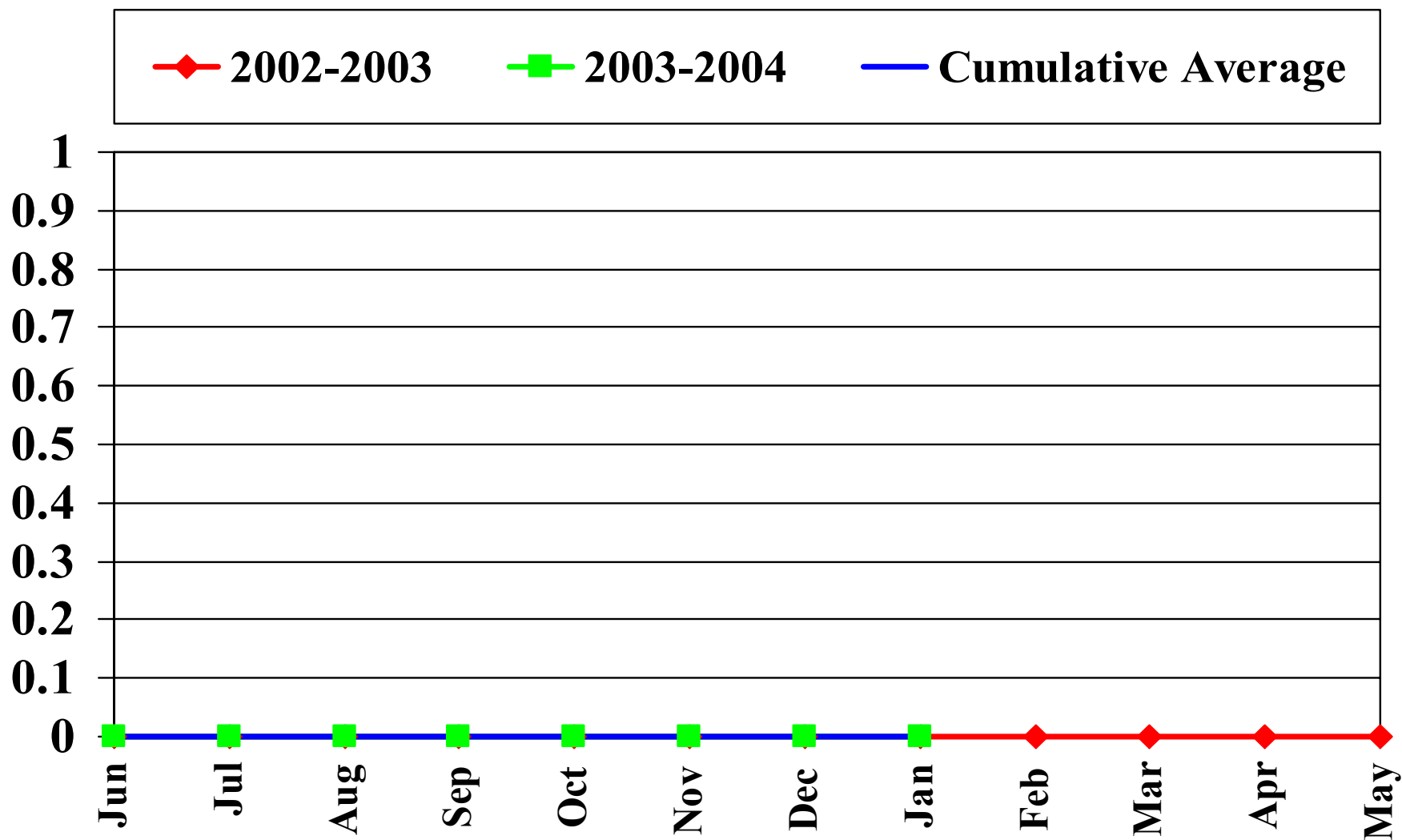

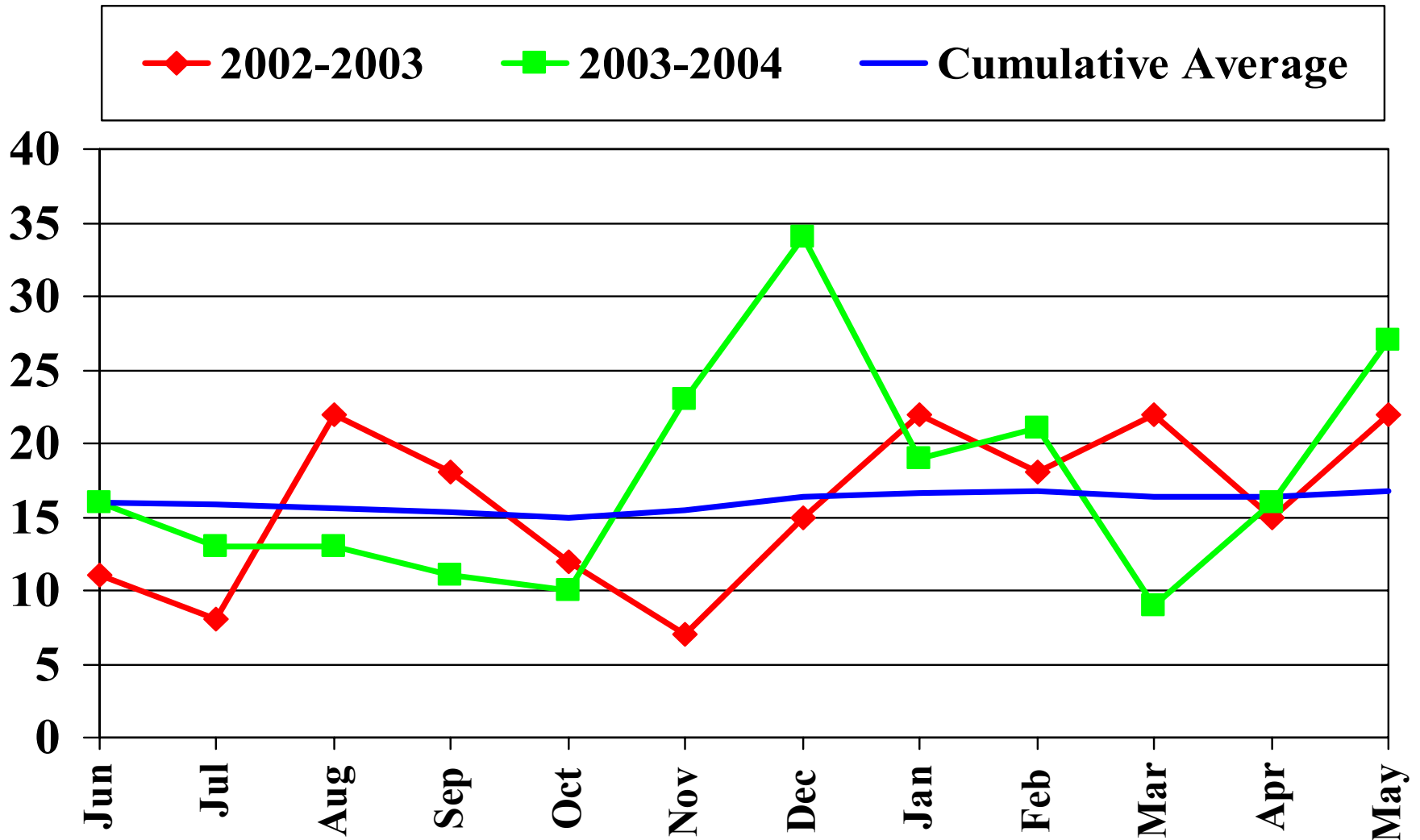

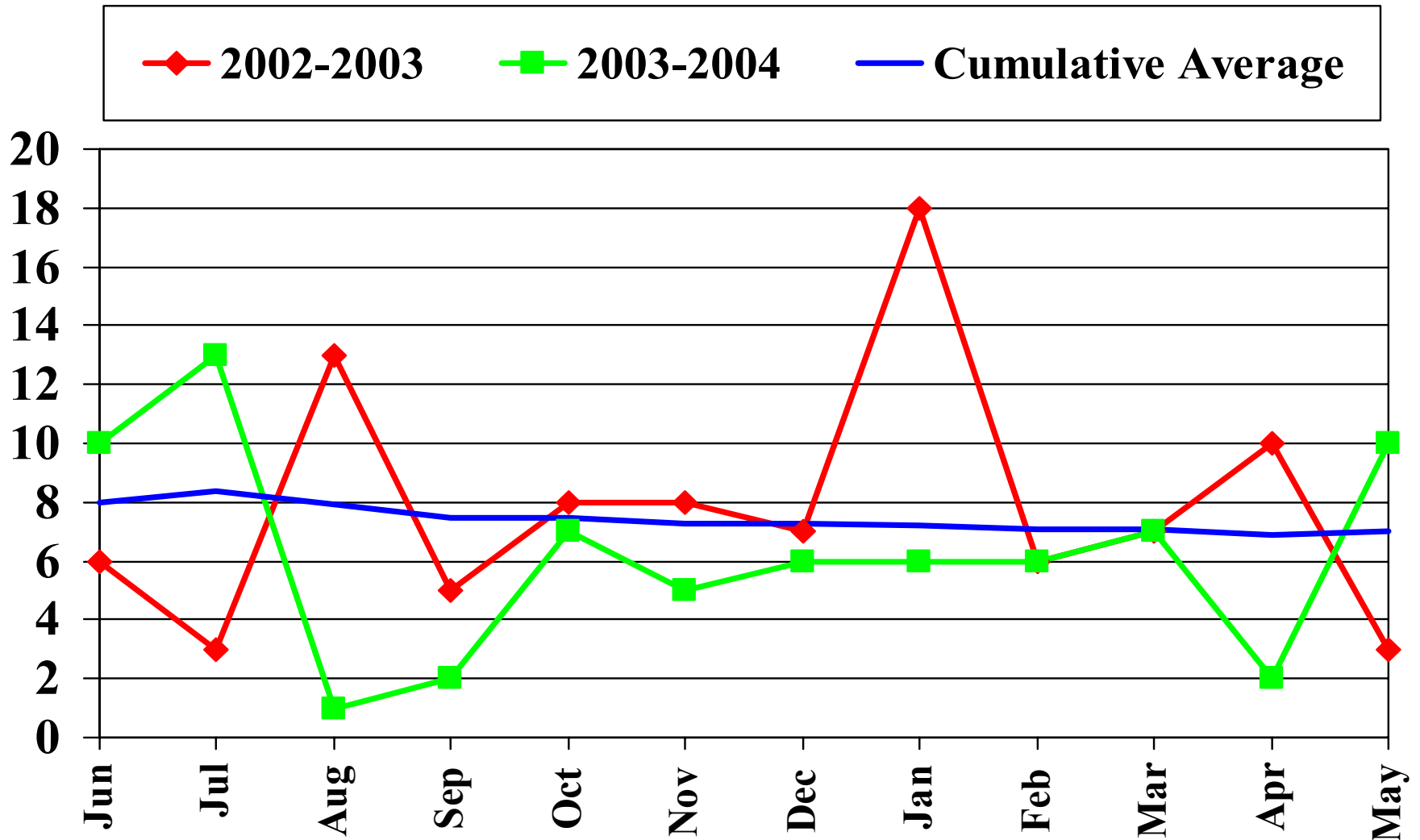

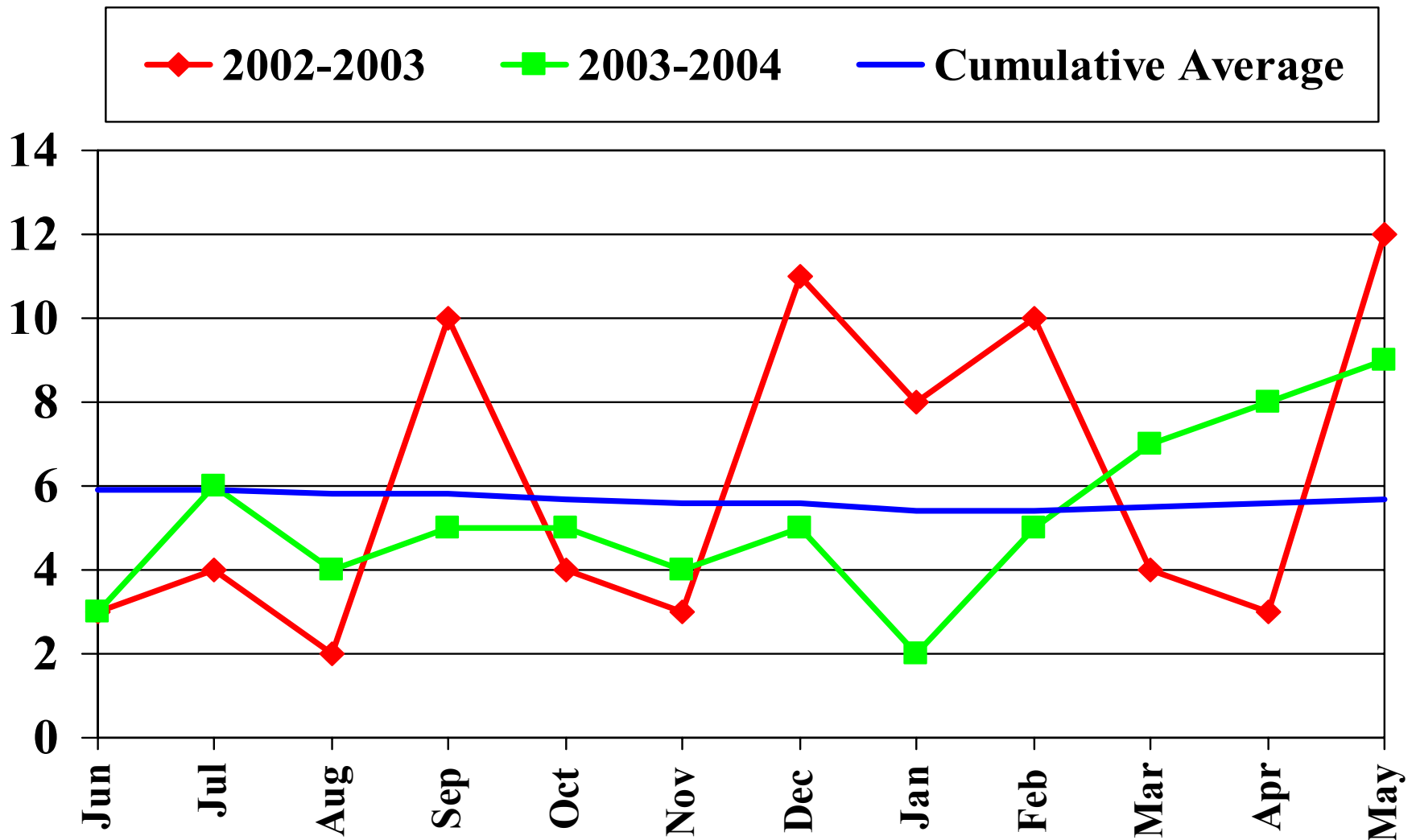

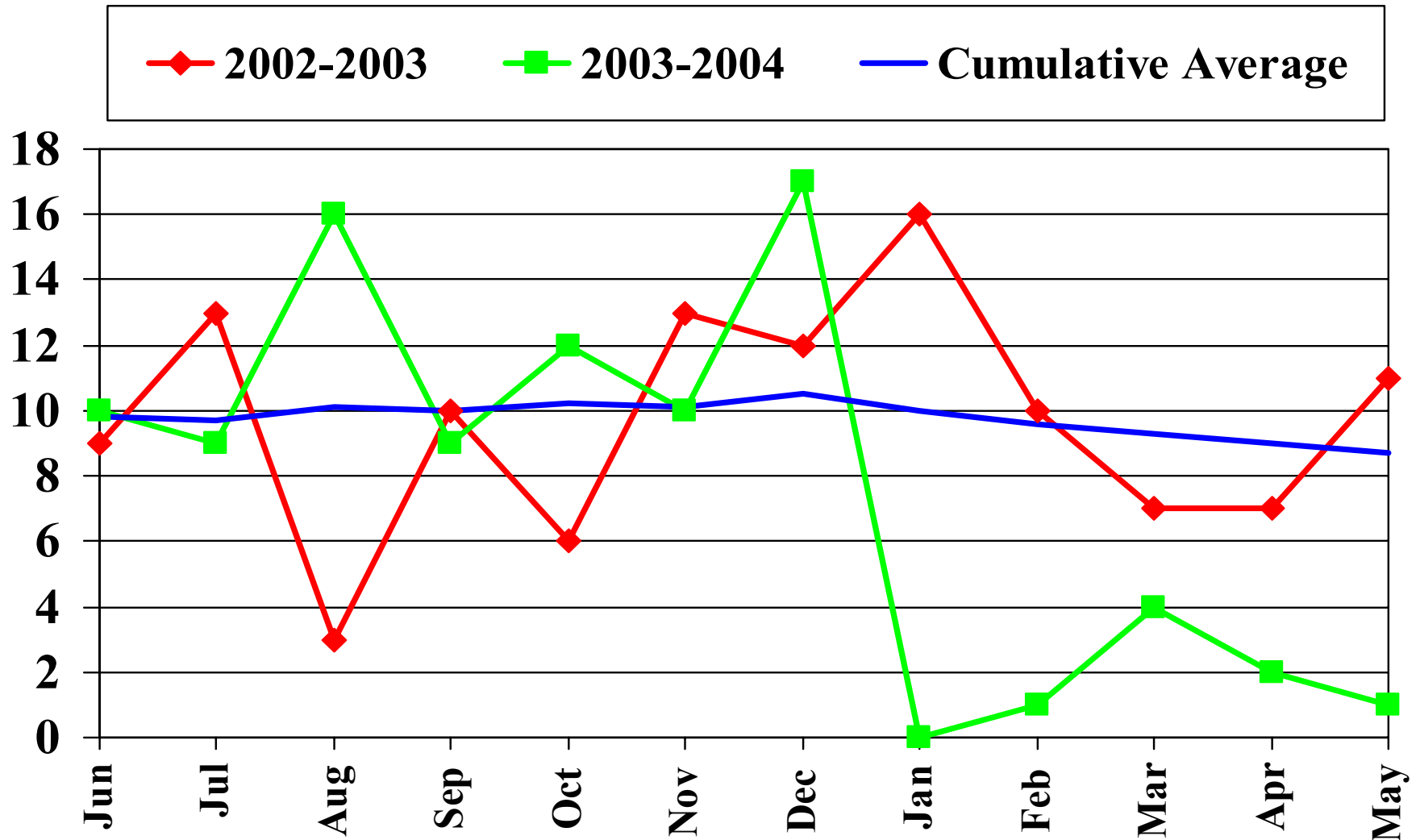

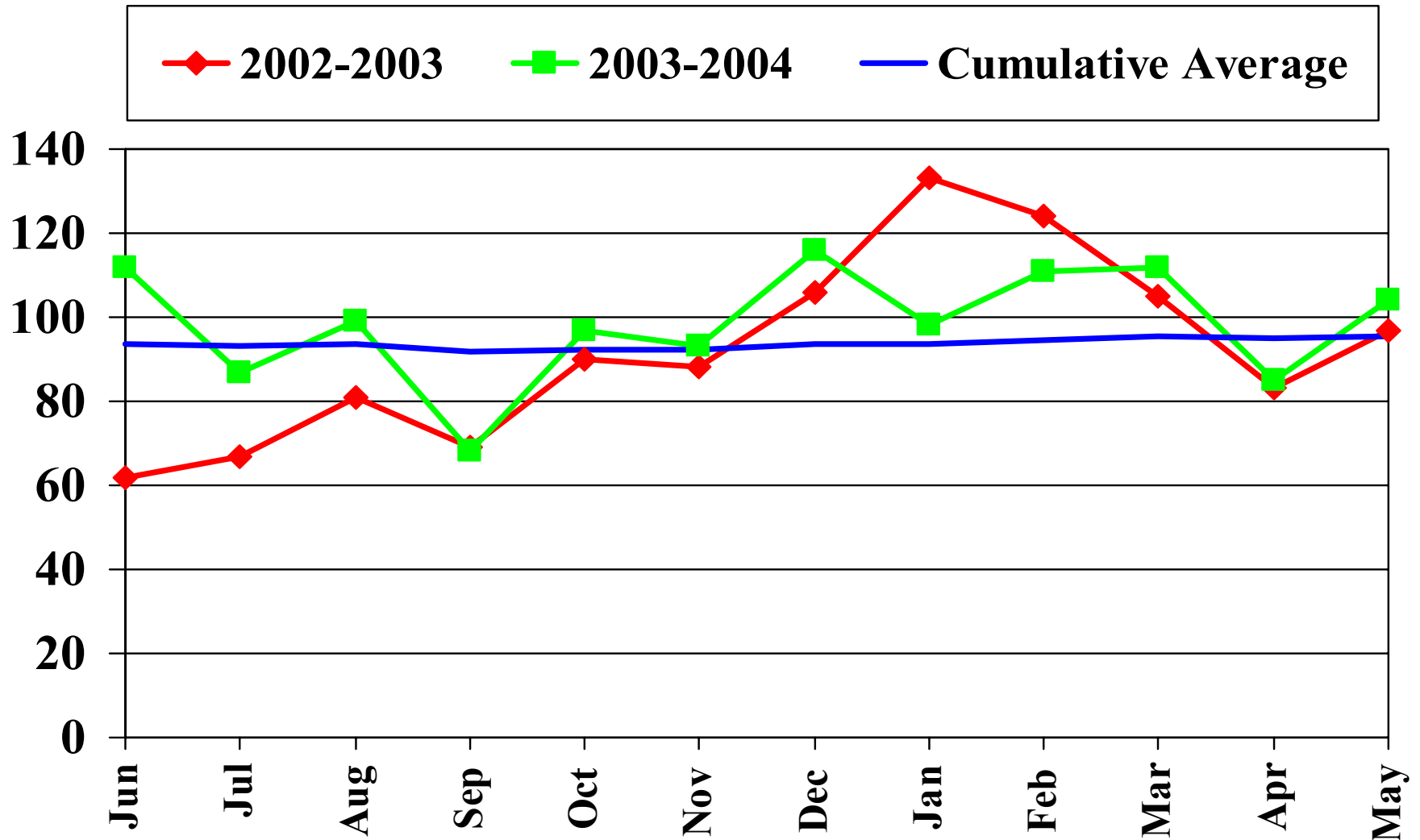

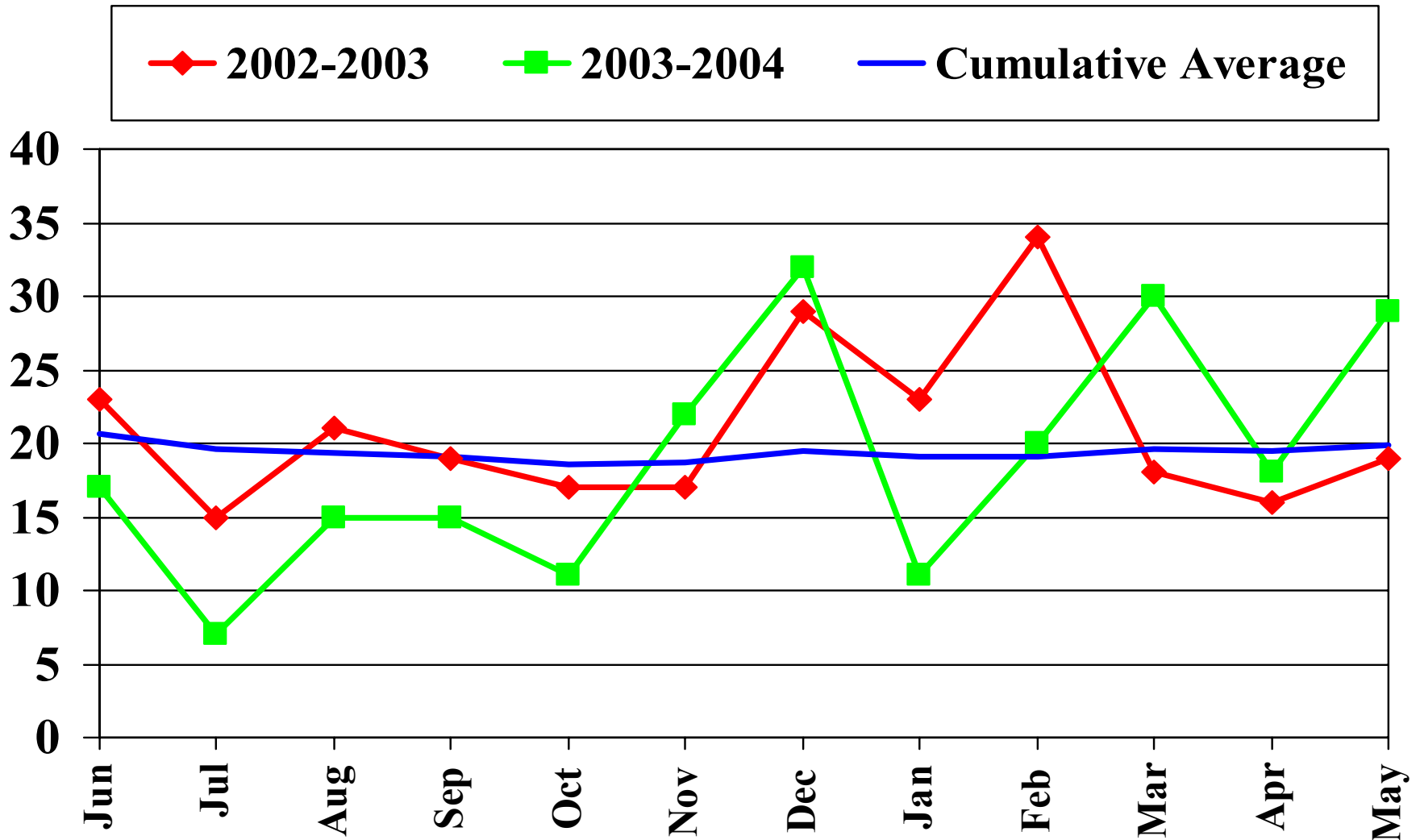

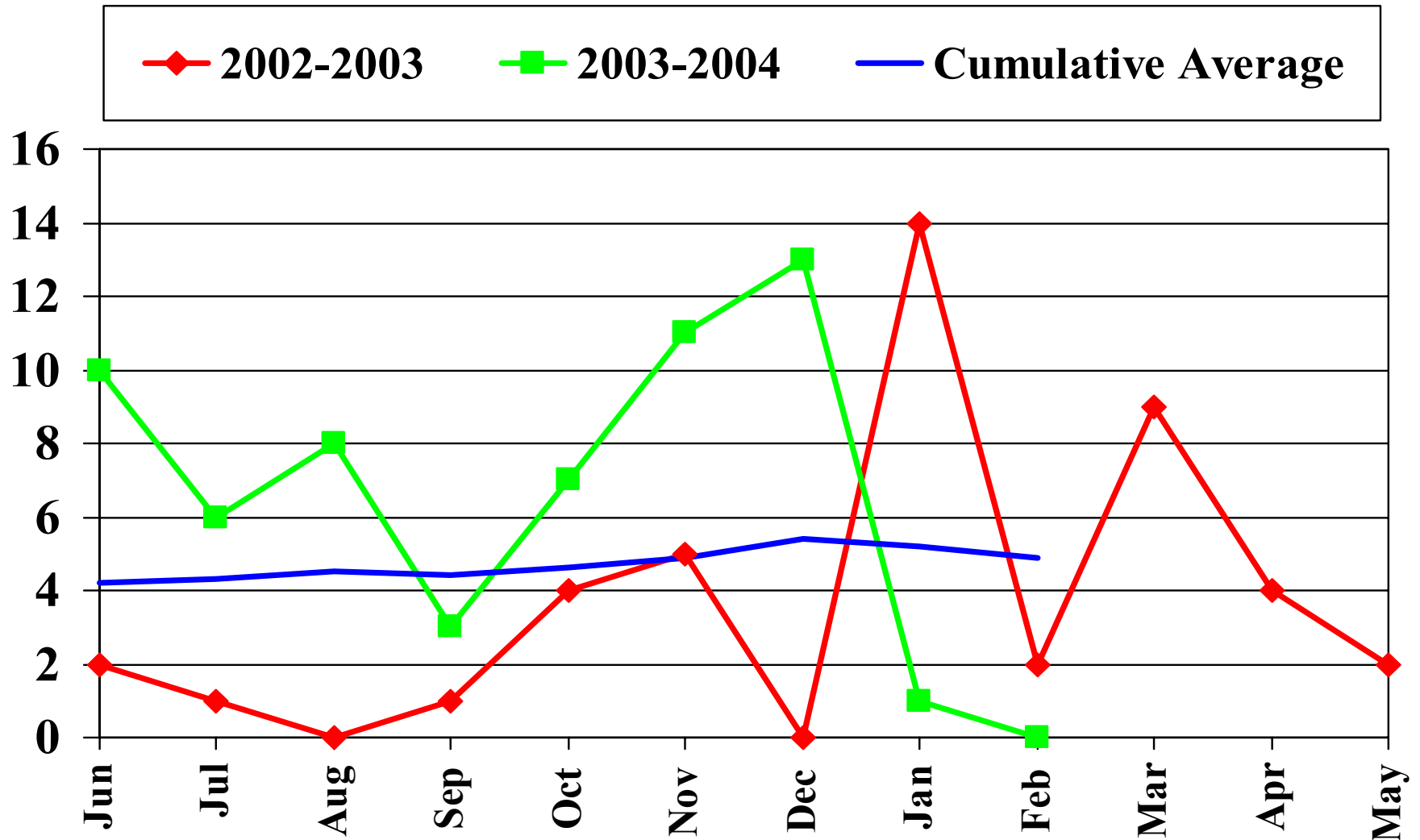

Women admitted to South Hedland lock-up.



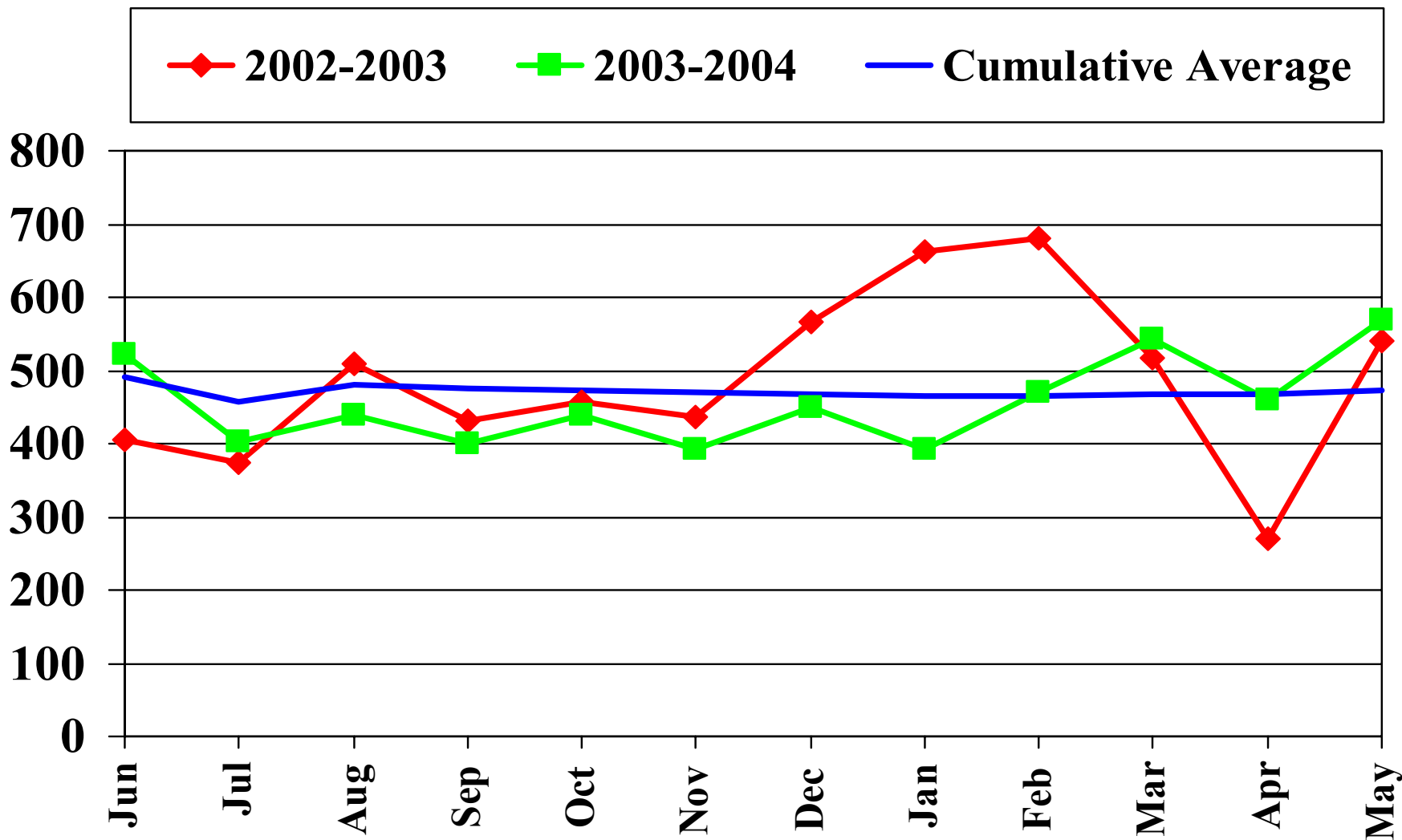

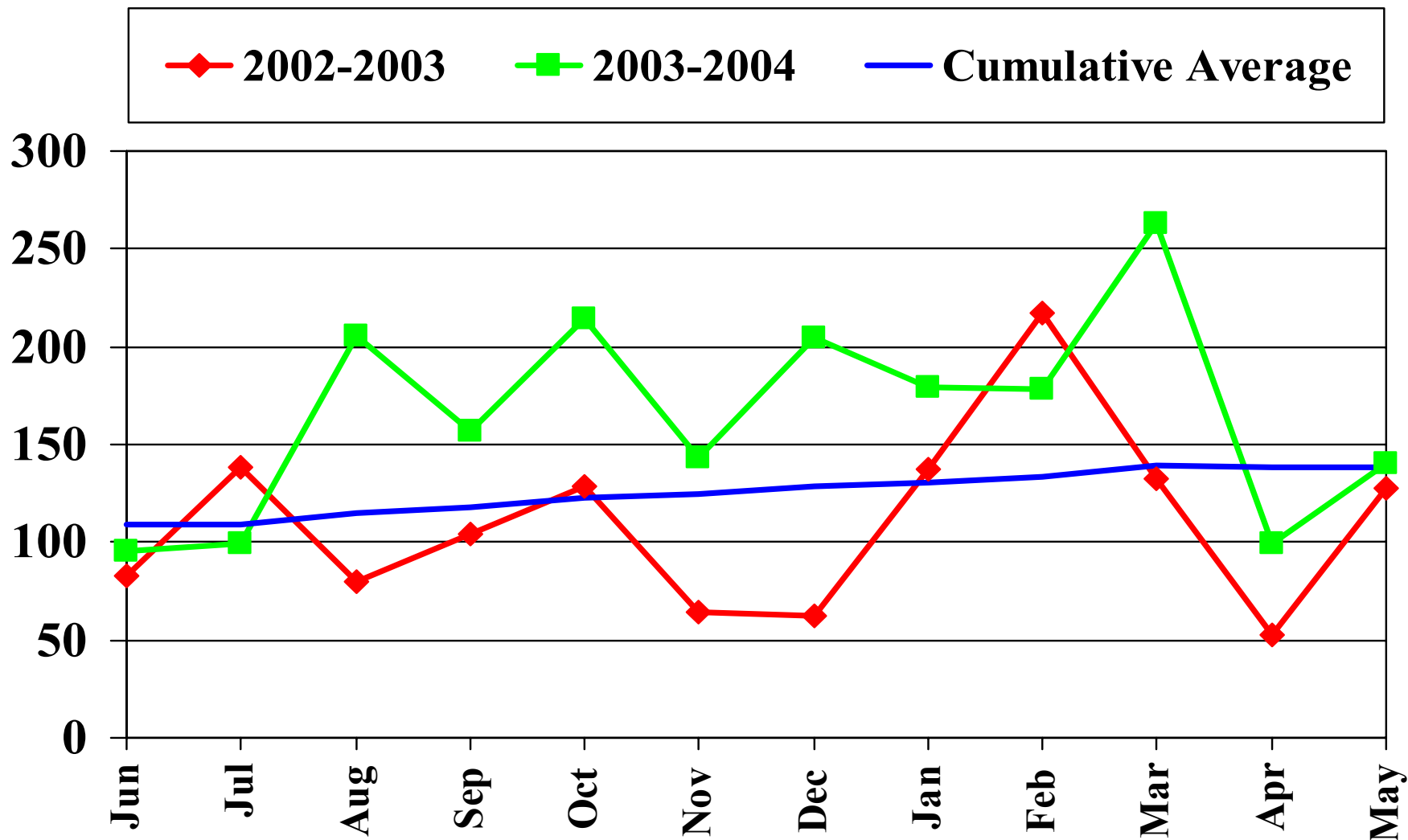

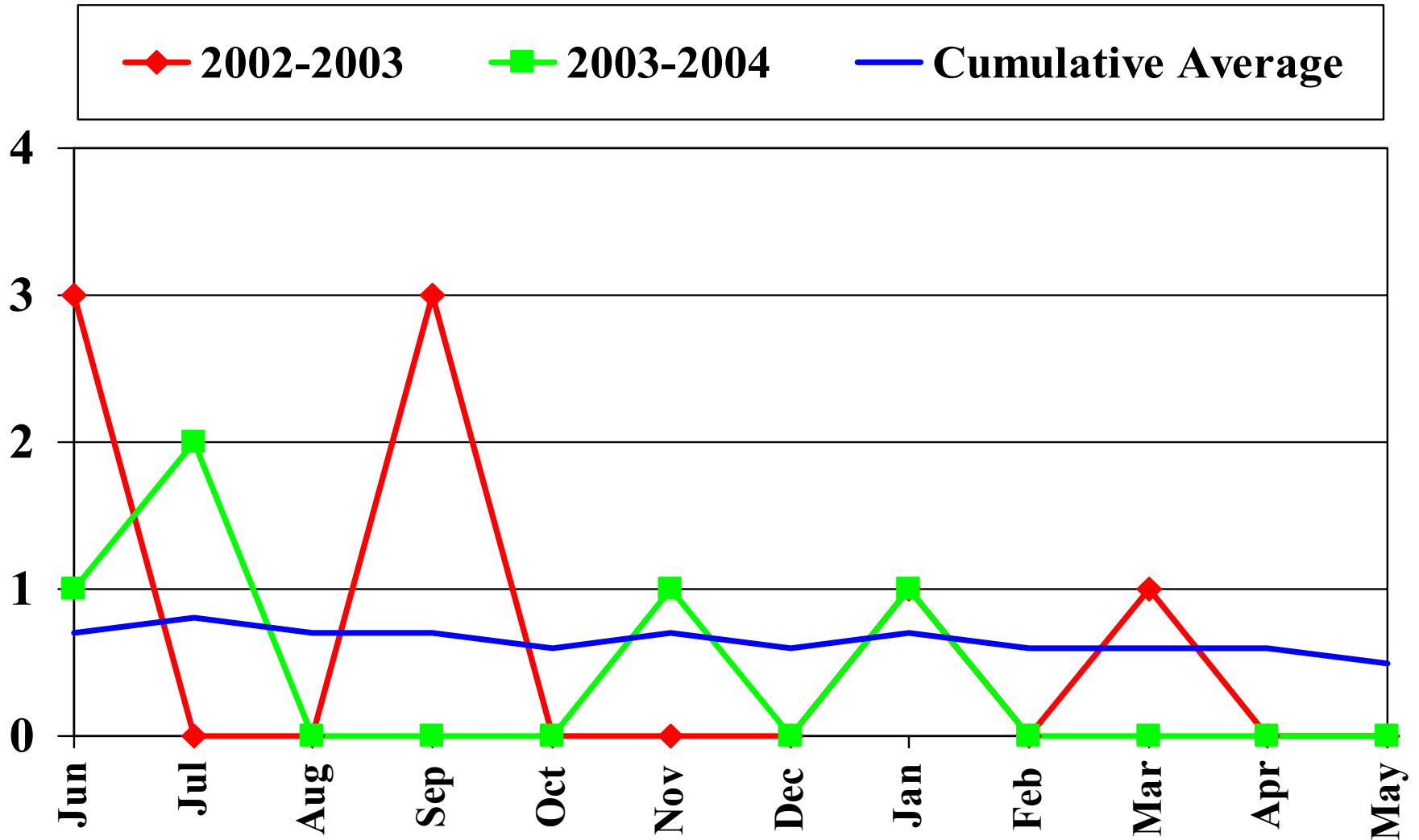

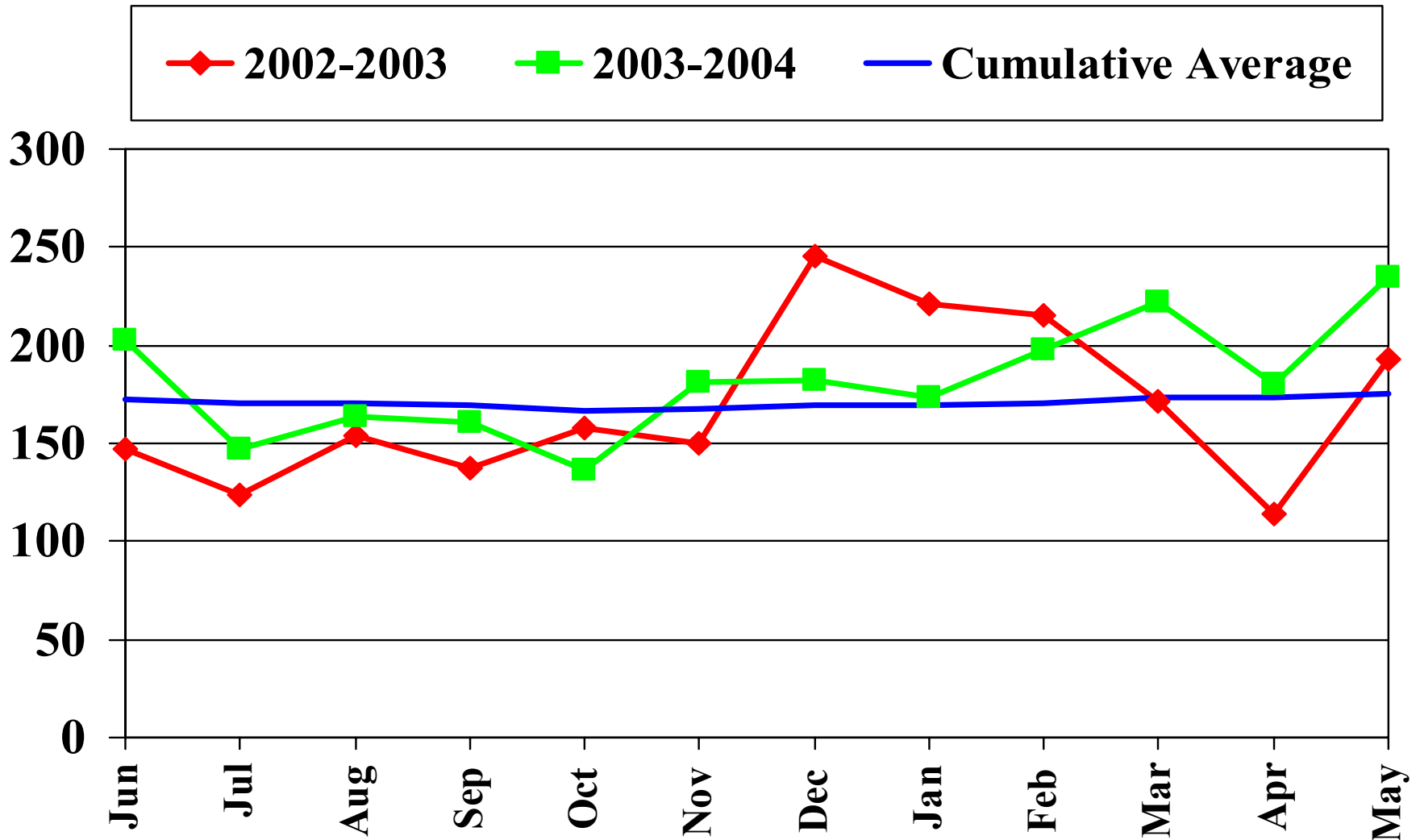

8(c) Total Applications for Care and Protection before the Children's Court



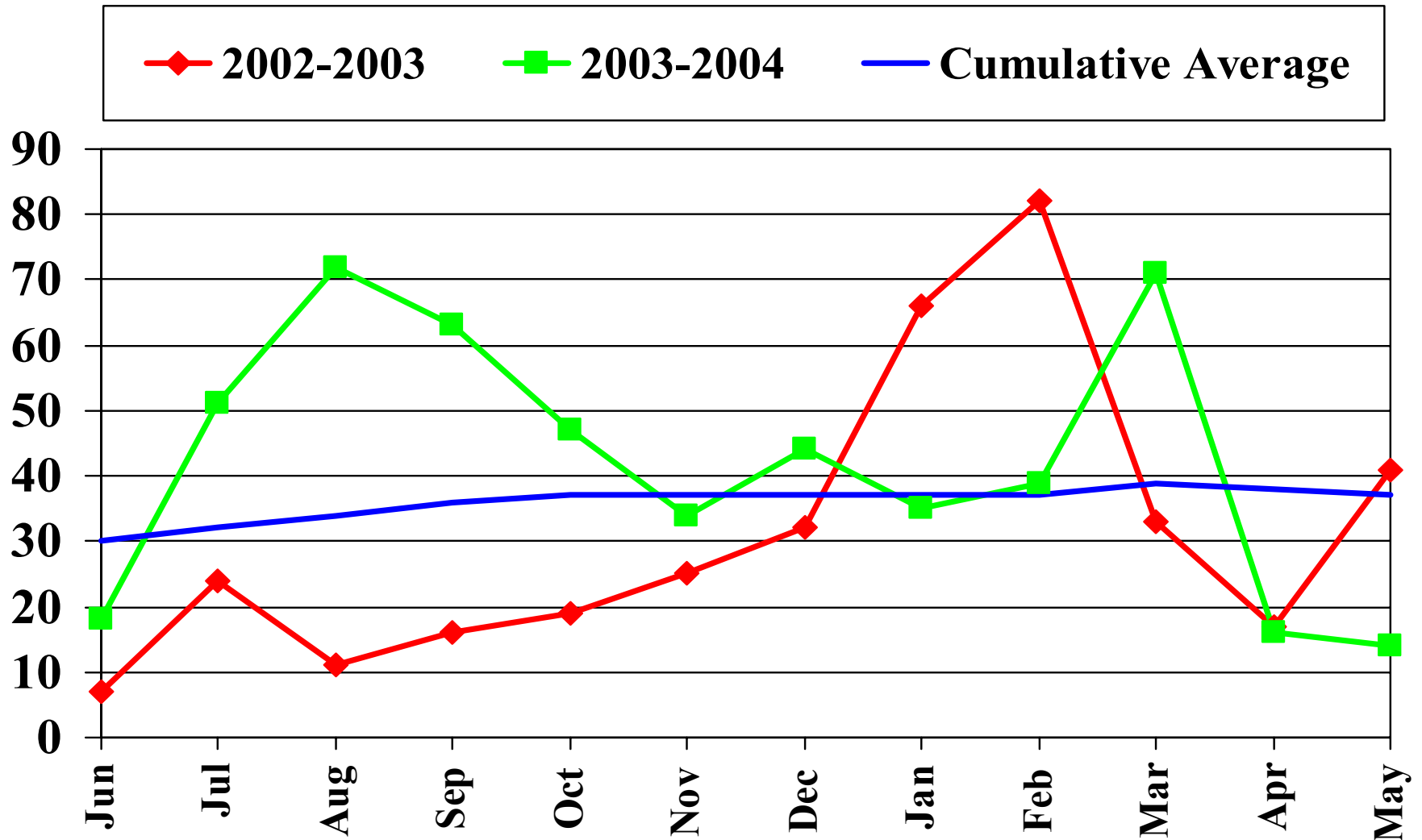

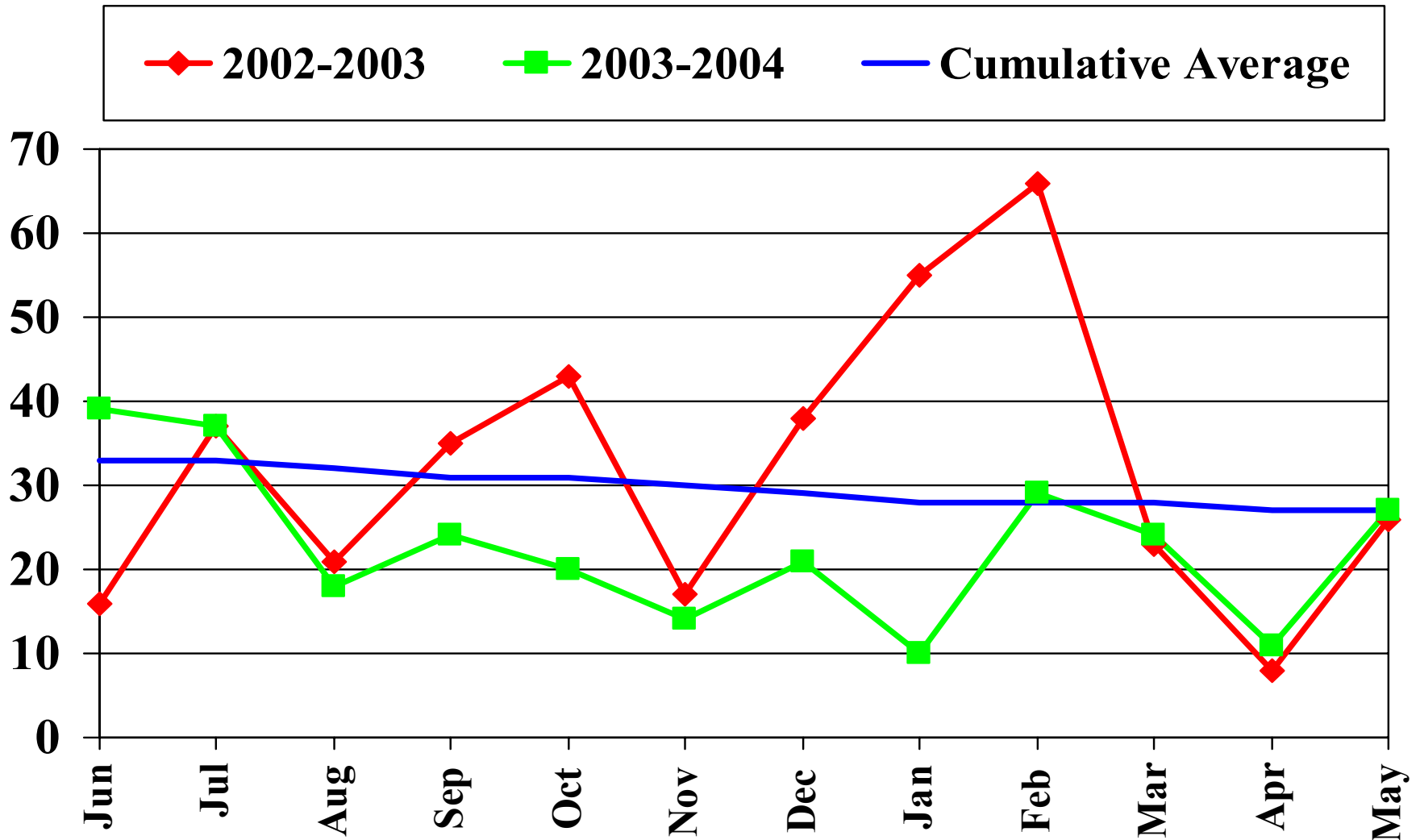

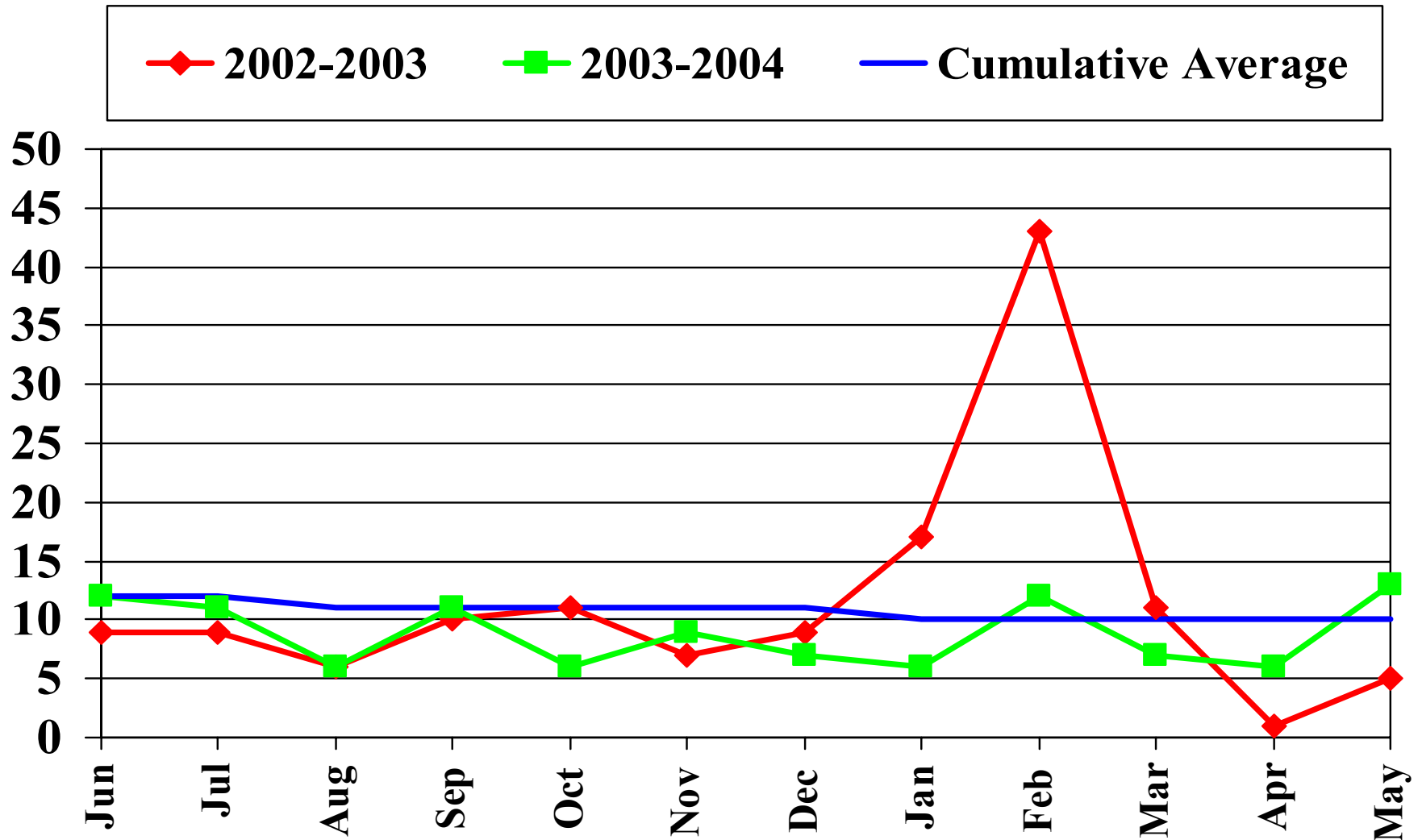

8f (i) Total custodial sentences handed down in the Court of Petty Sessions



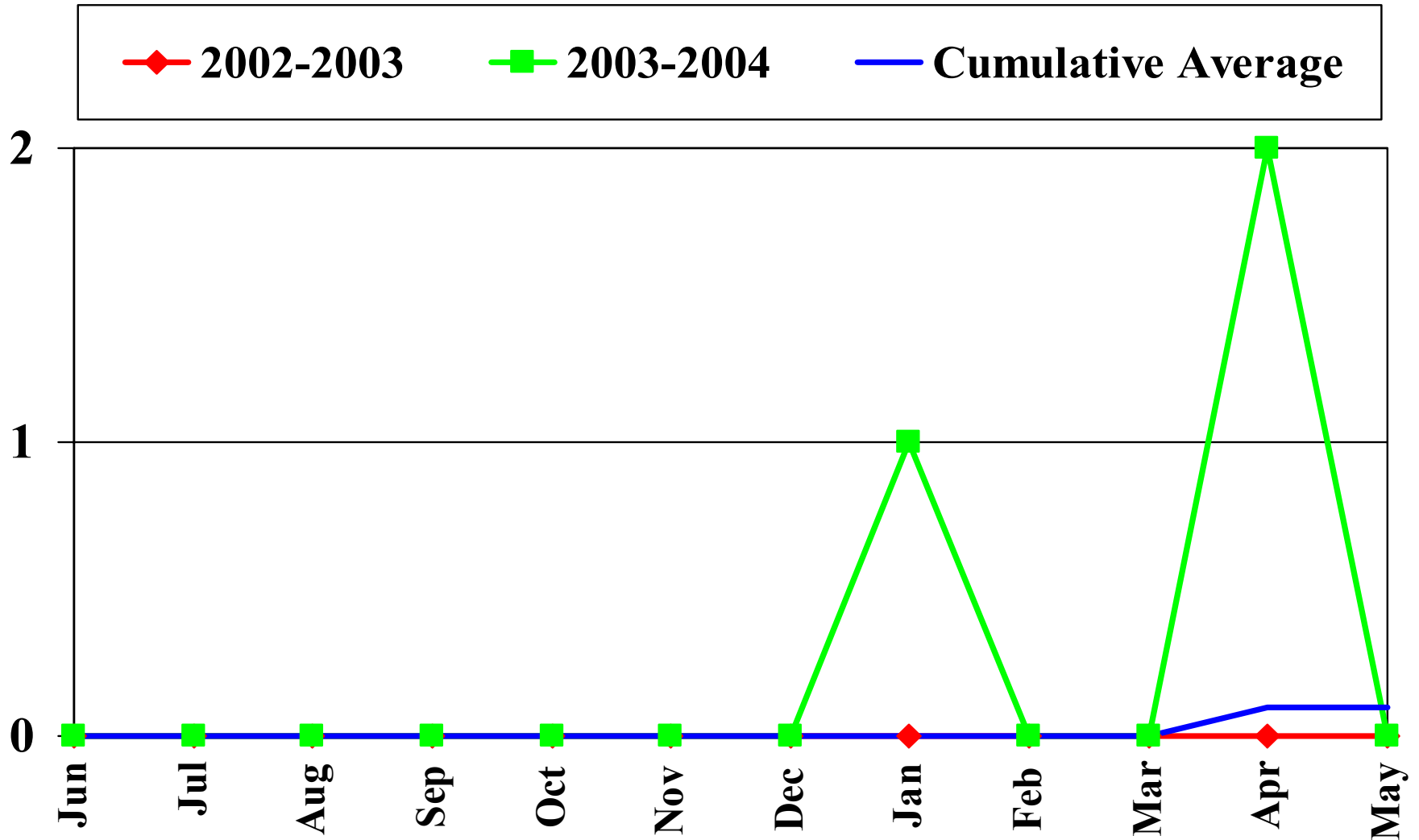

8f (ii) Number of defendants given custodial sentences in the Court of Petty Sessions



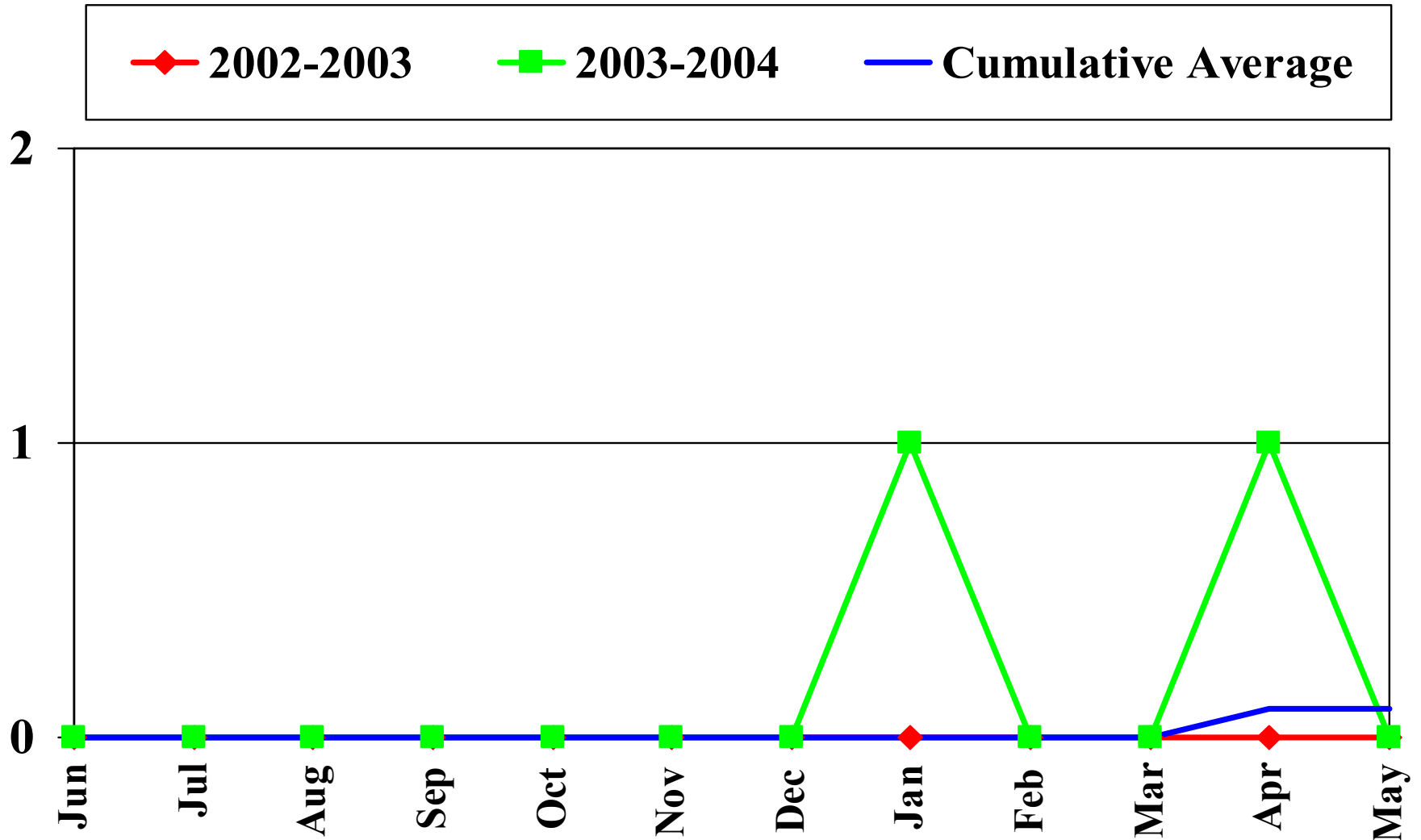

8g(i) Total custodial sentences handed down in the Children's Court



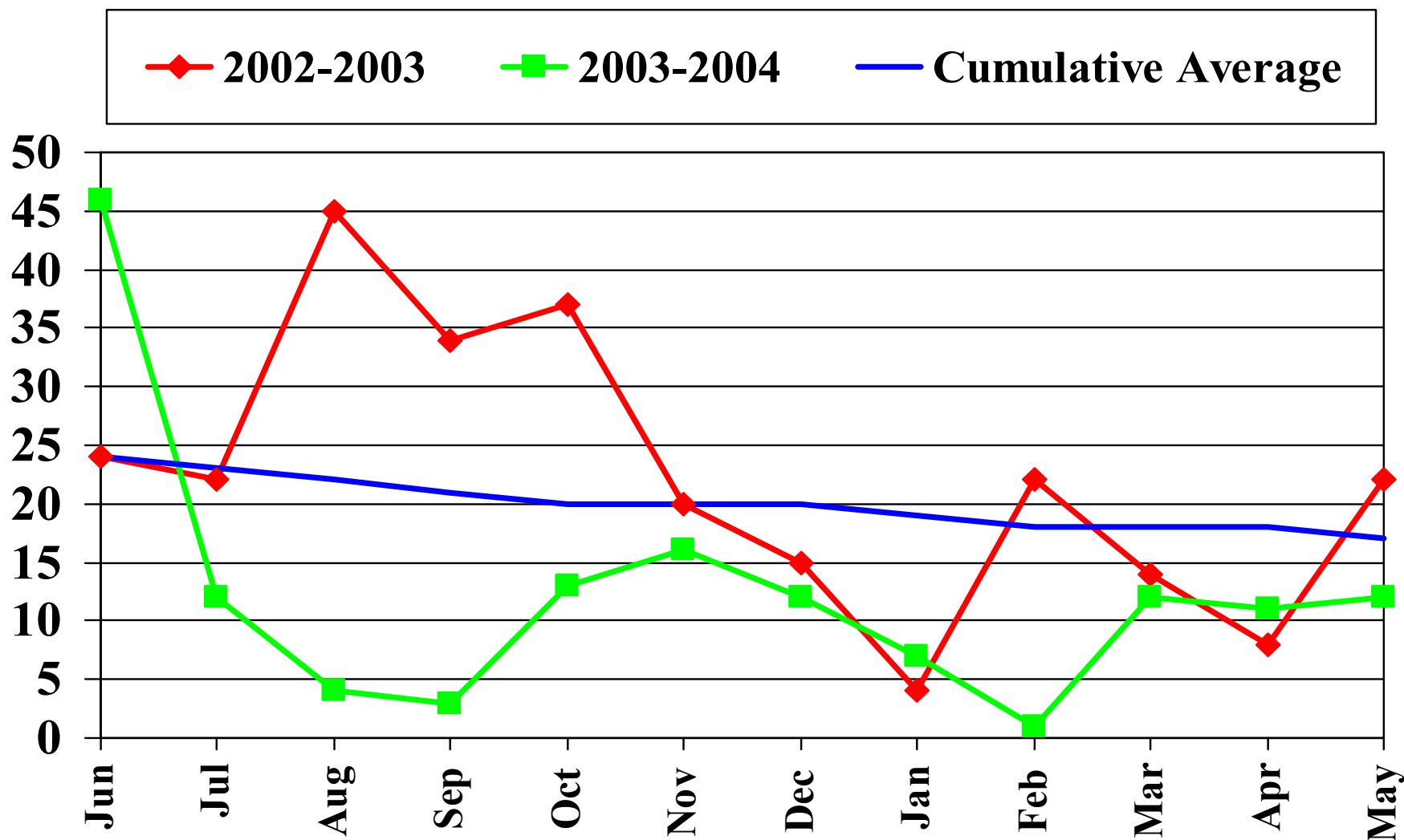

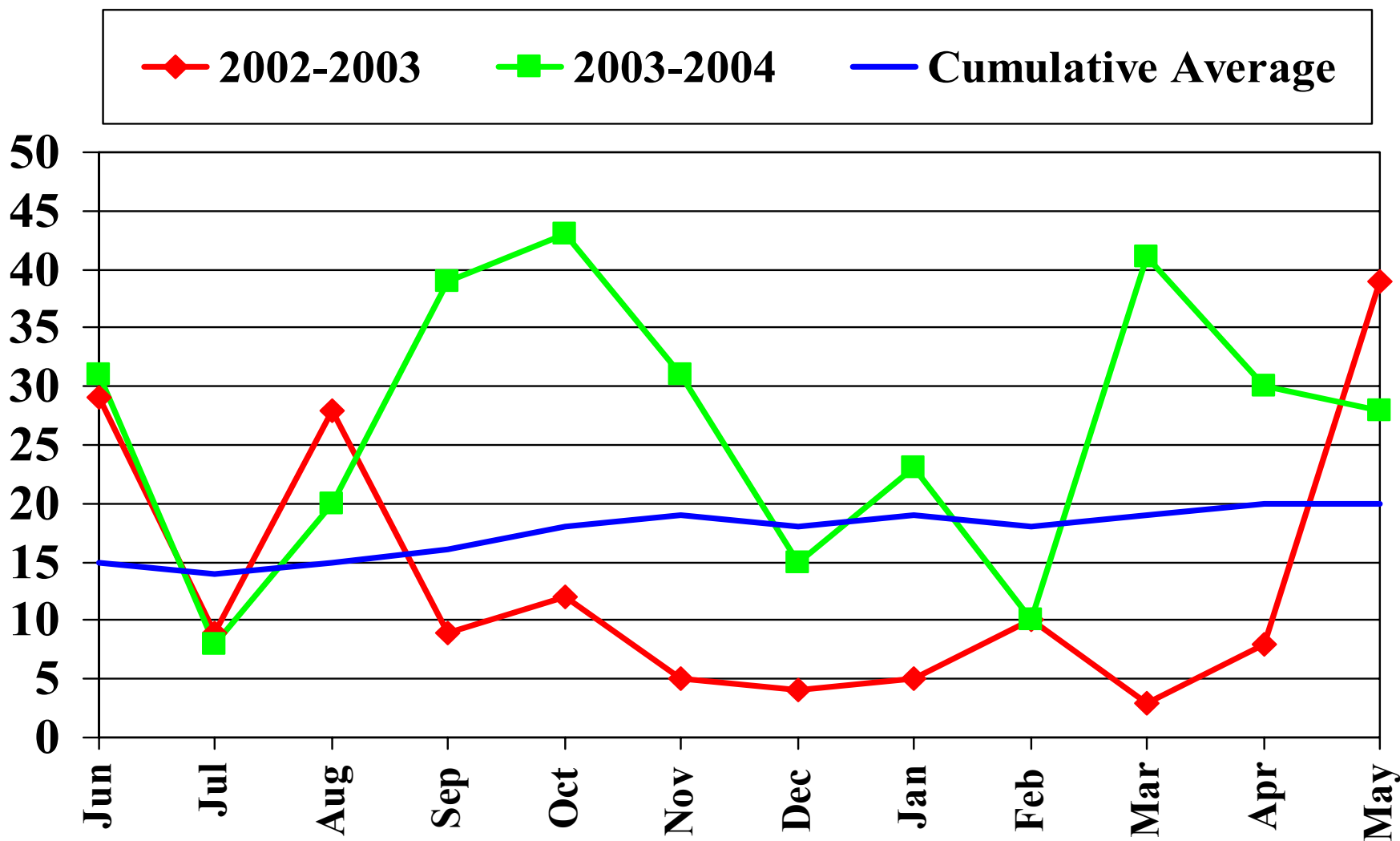

8(h) Court of Petty Sessions sentences requiring supervision by the Department of Justice.



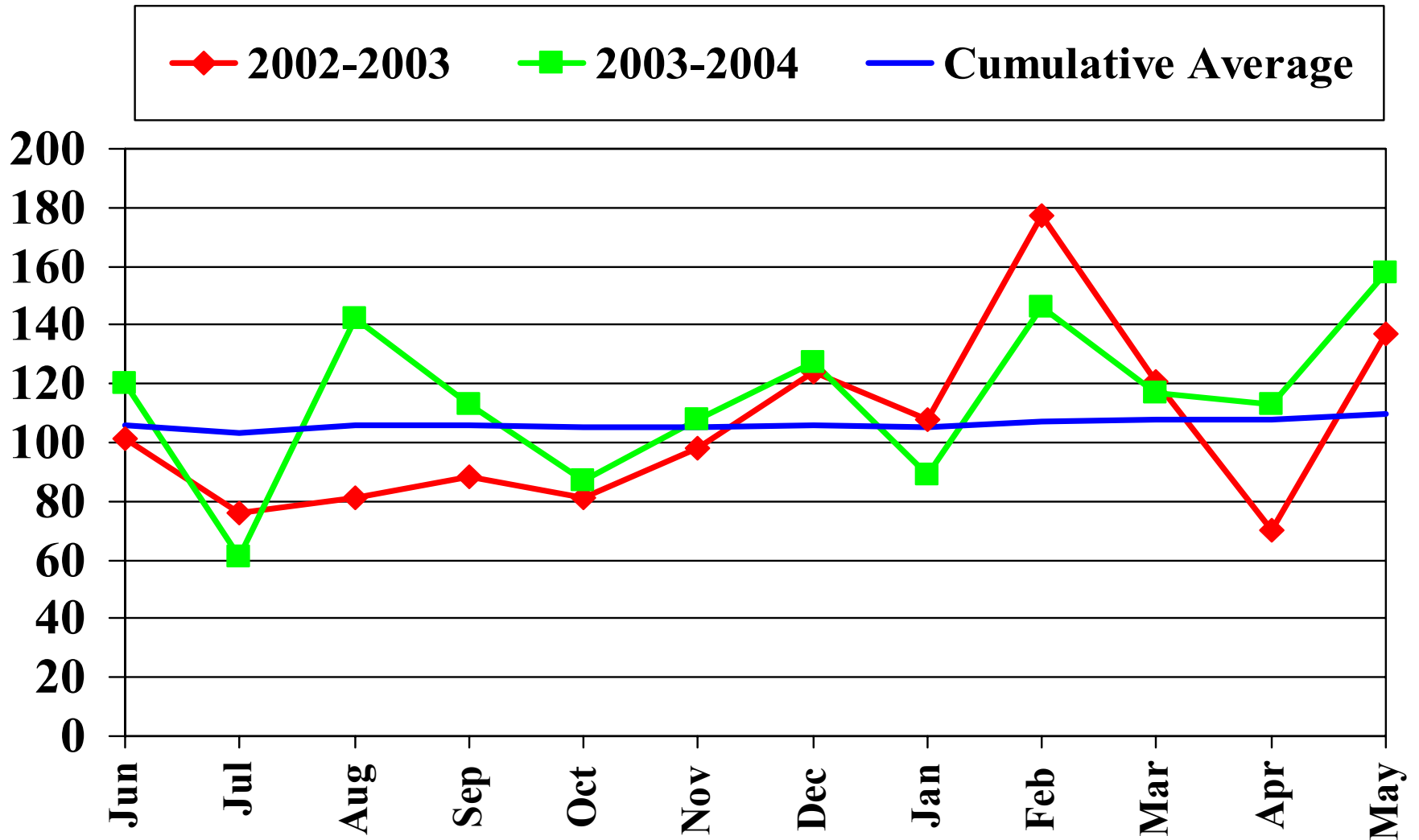

8(i) Children's Court sentences requiring supervision by the Department of Justice.



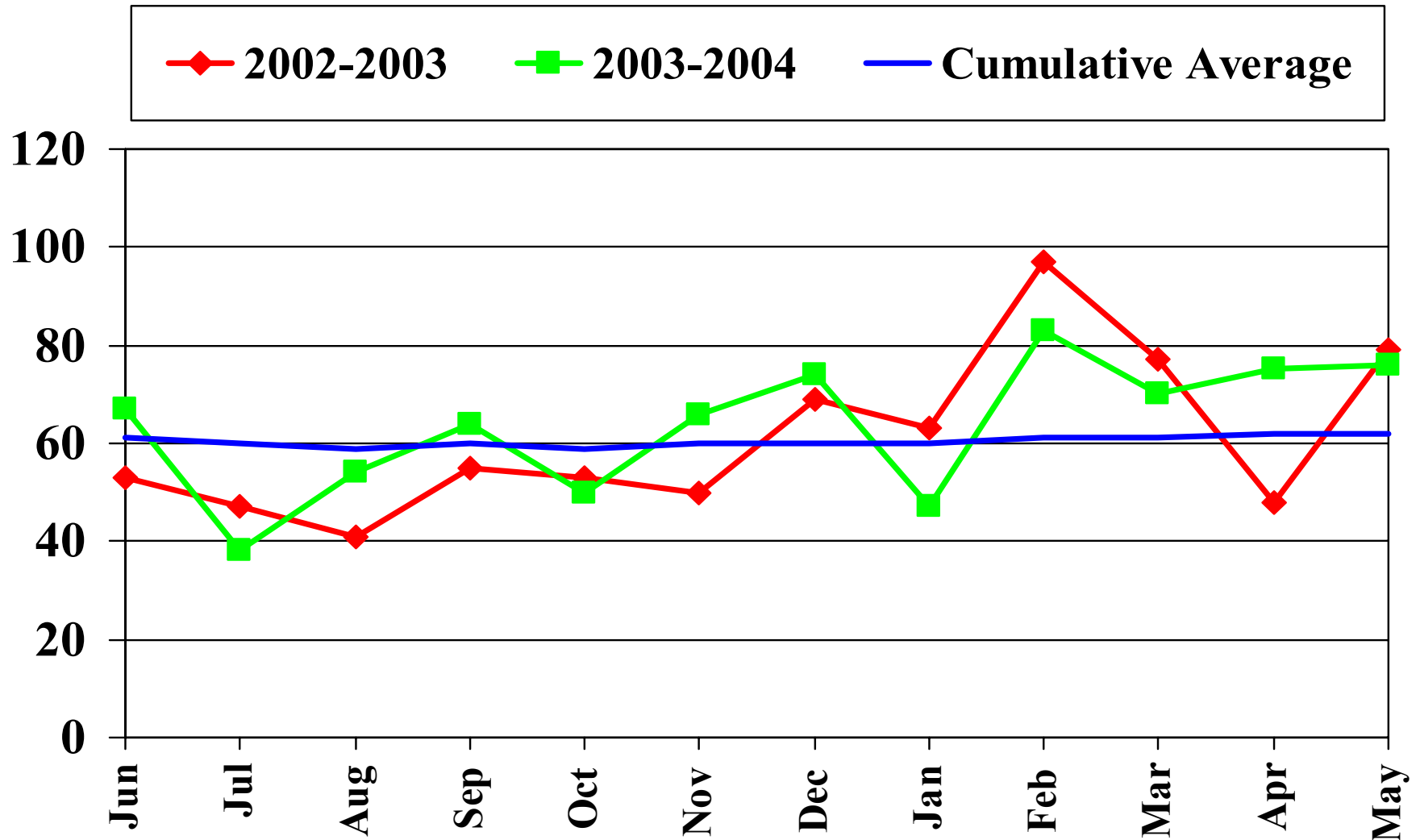

8j (i) Court of Petty Sessions total fines imposed



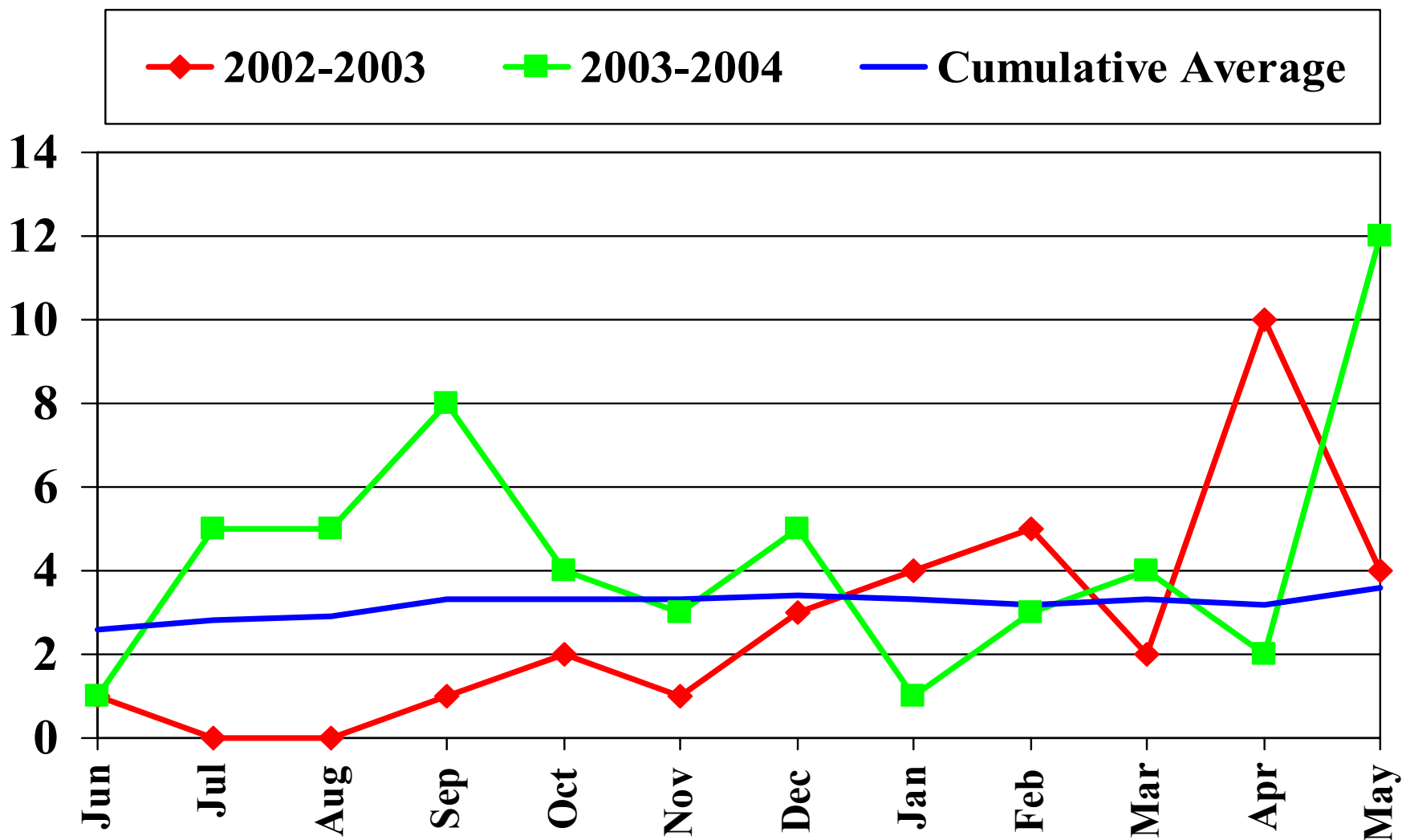

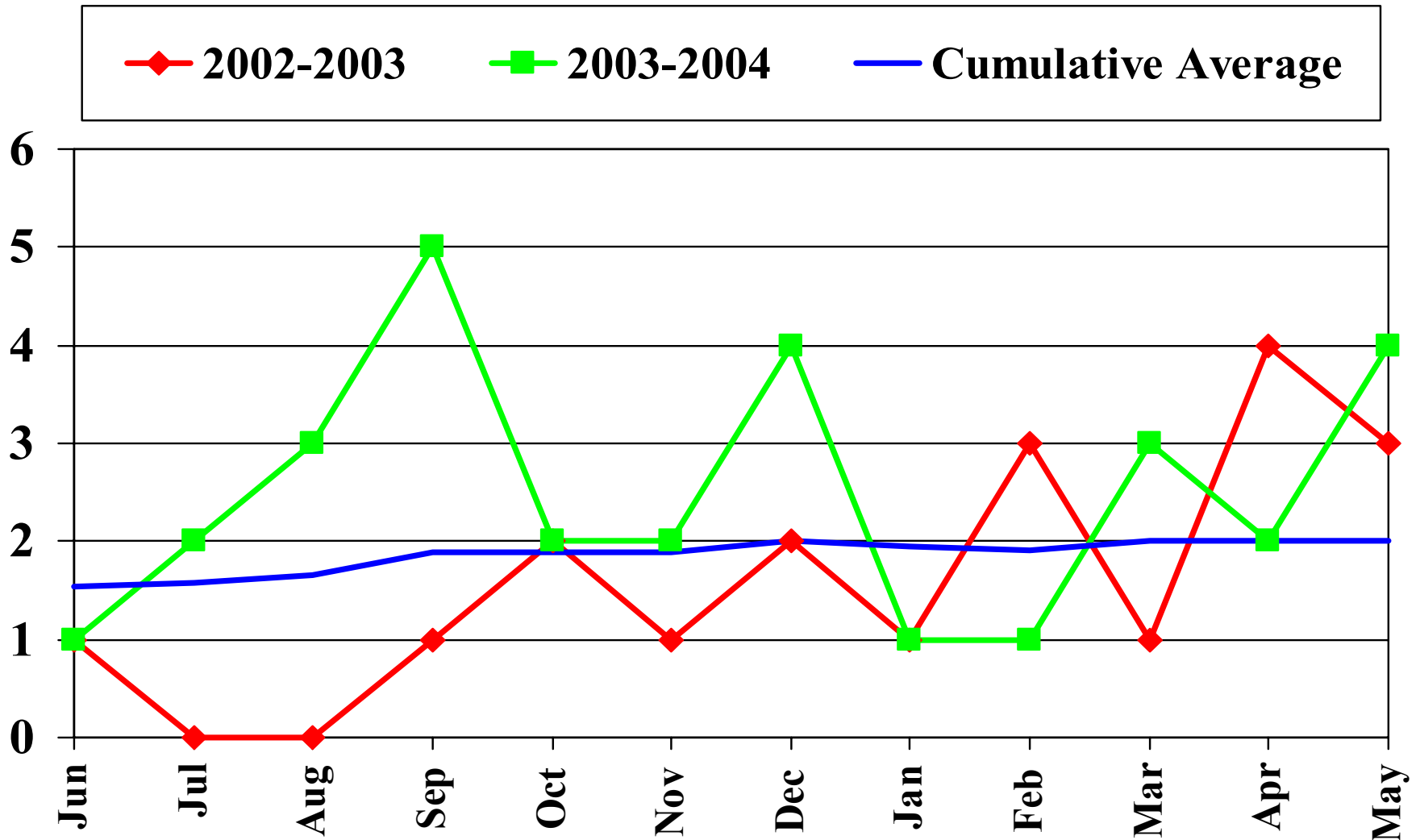

8k (i) Children's Court total fines imposed



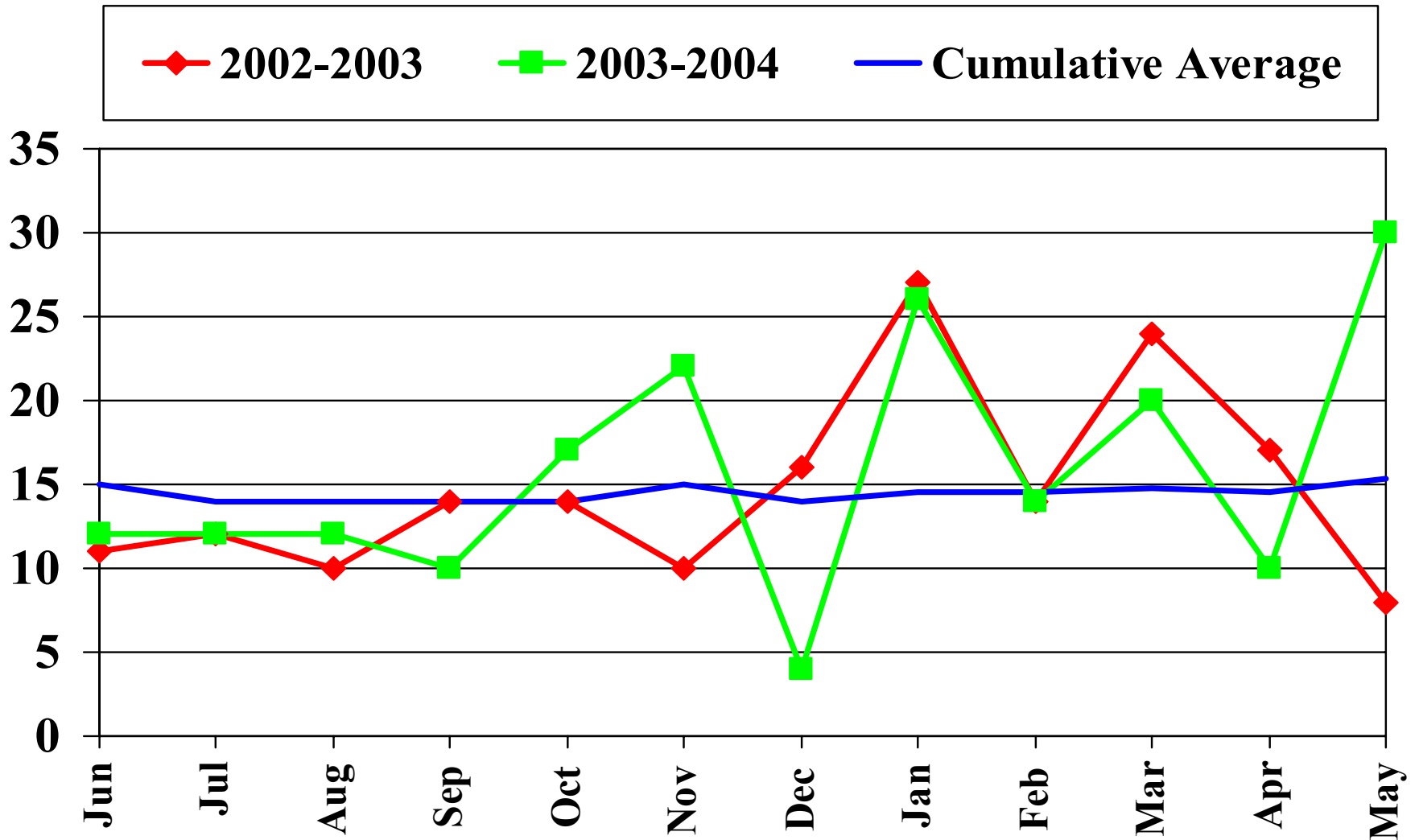

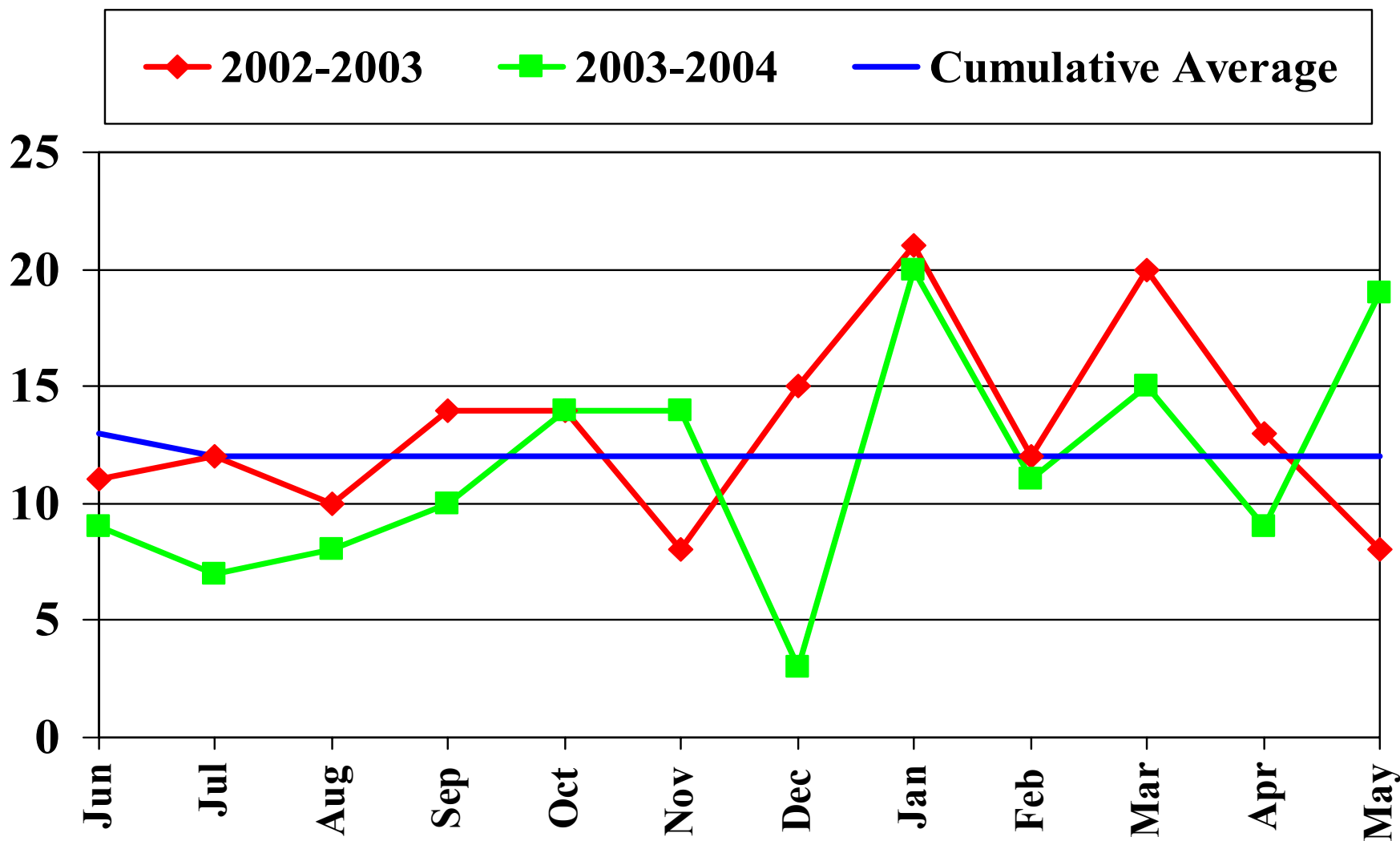

81 (i) Court of Petty Sessions total violence restraining orders.



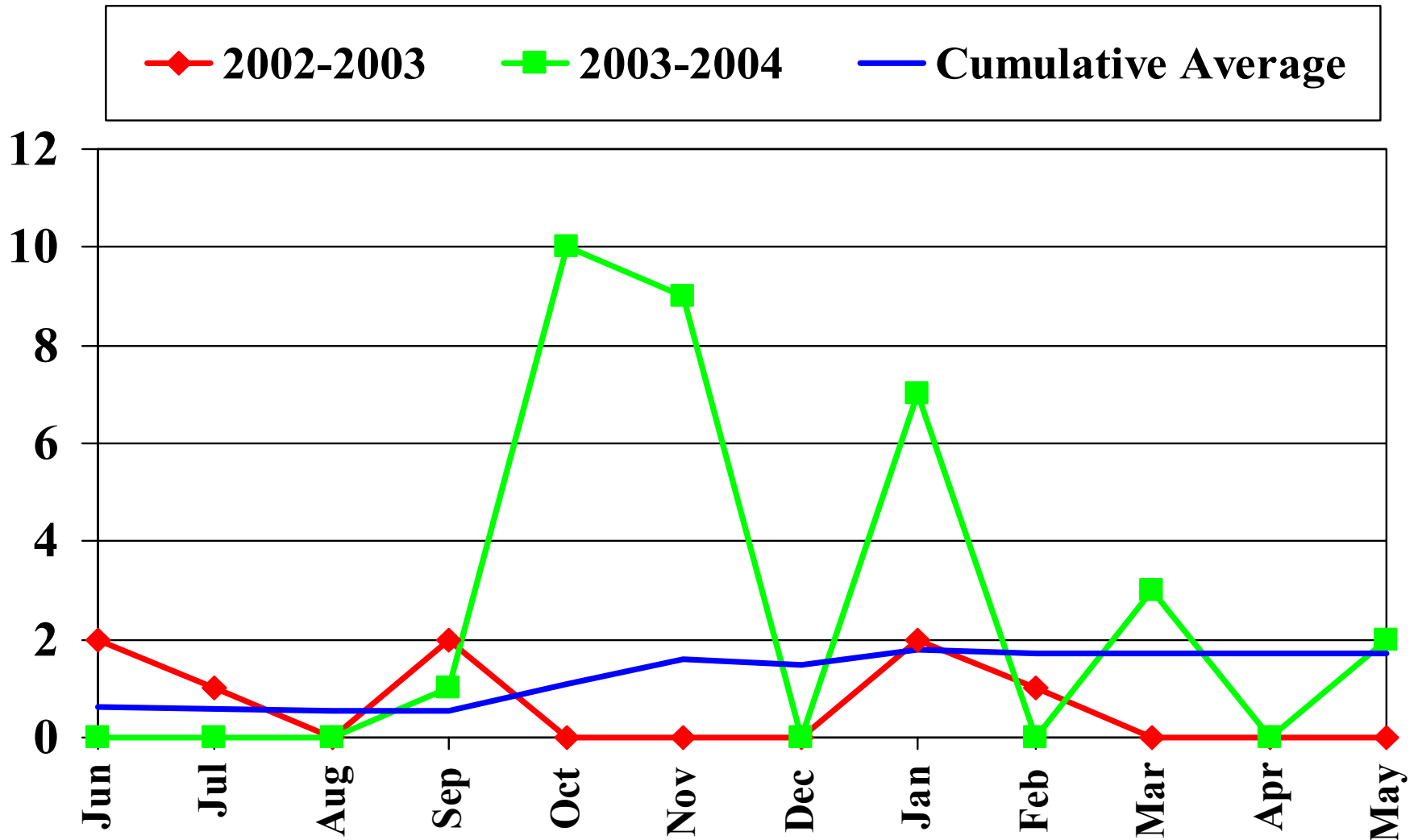

81 (ii) Defendants given violence restraining orders in the Court of Petty Sessions

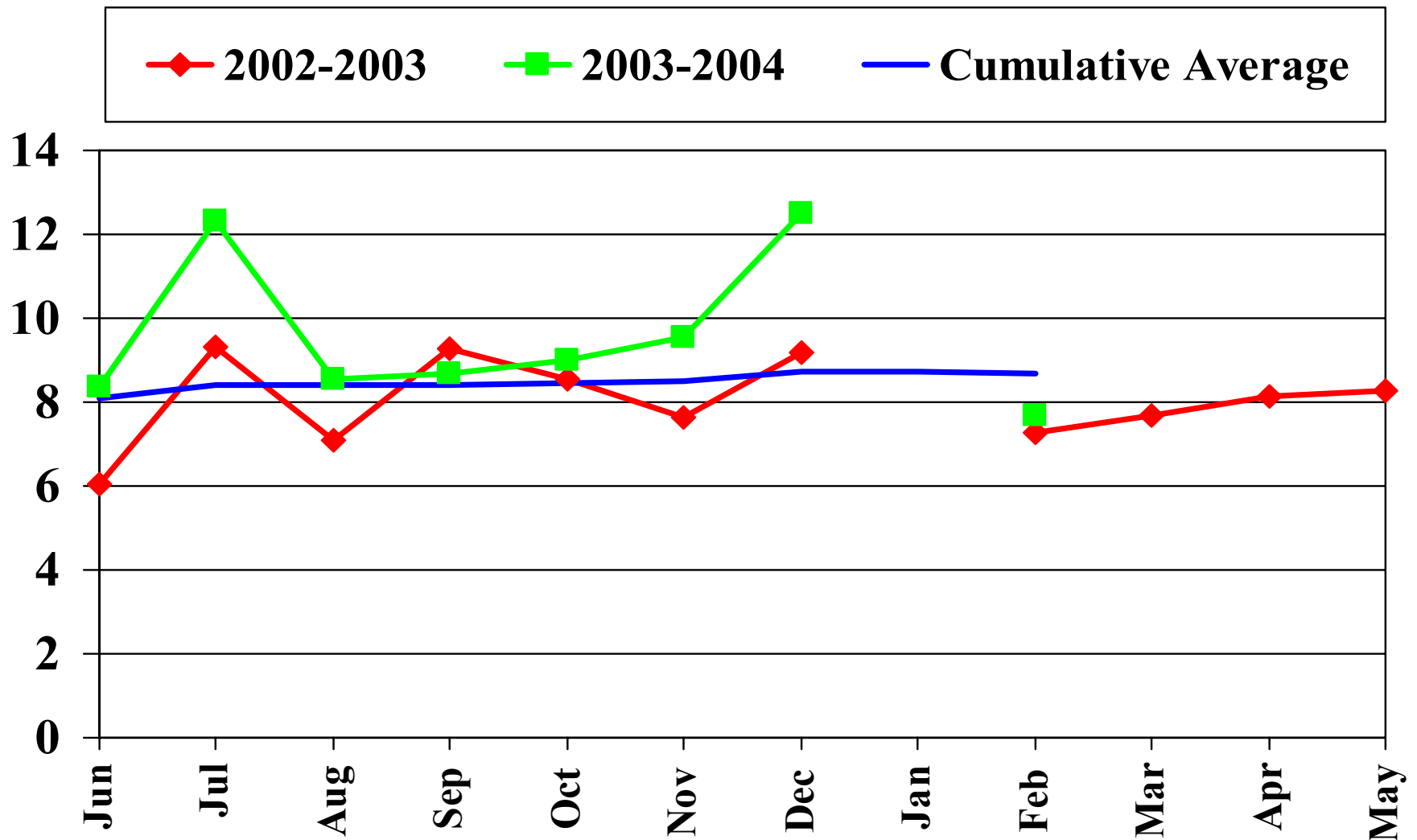

8(m) Children's Court total violence restraining orders.

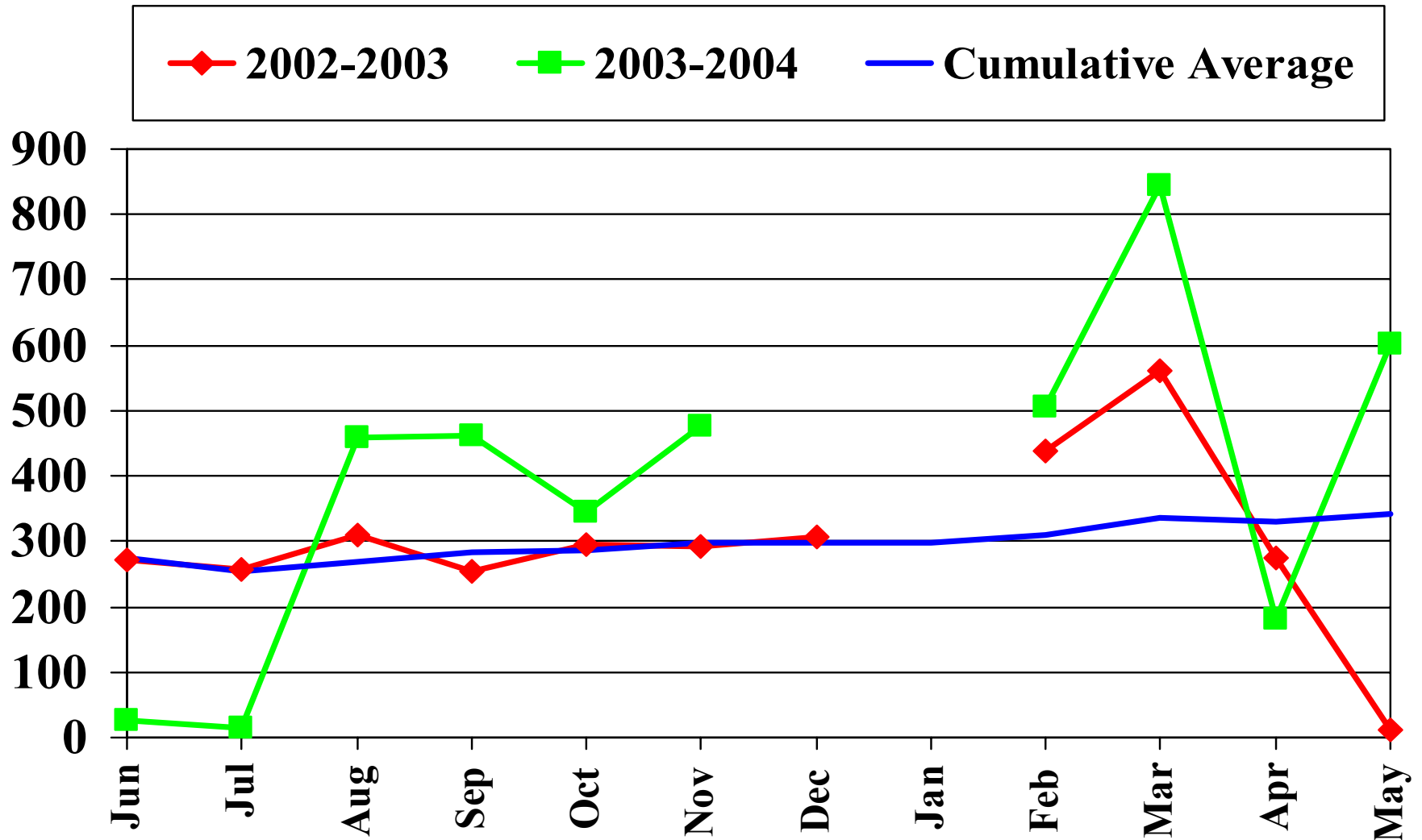


9. School Attendance 9(a) Unauthorised absences (as % of total half-days)

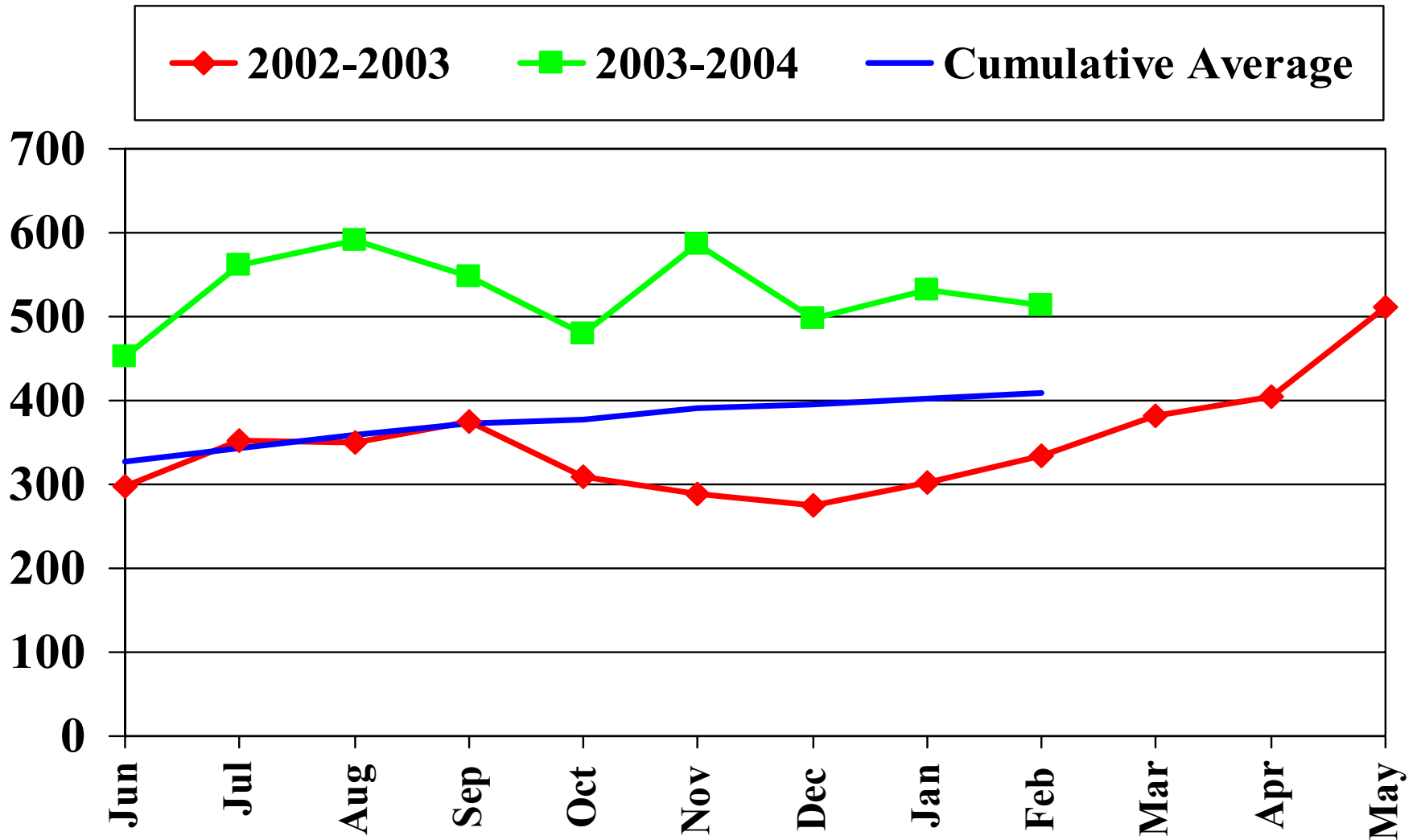

9(b) Youth picked up and returned to school

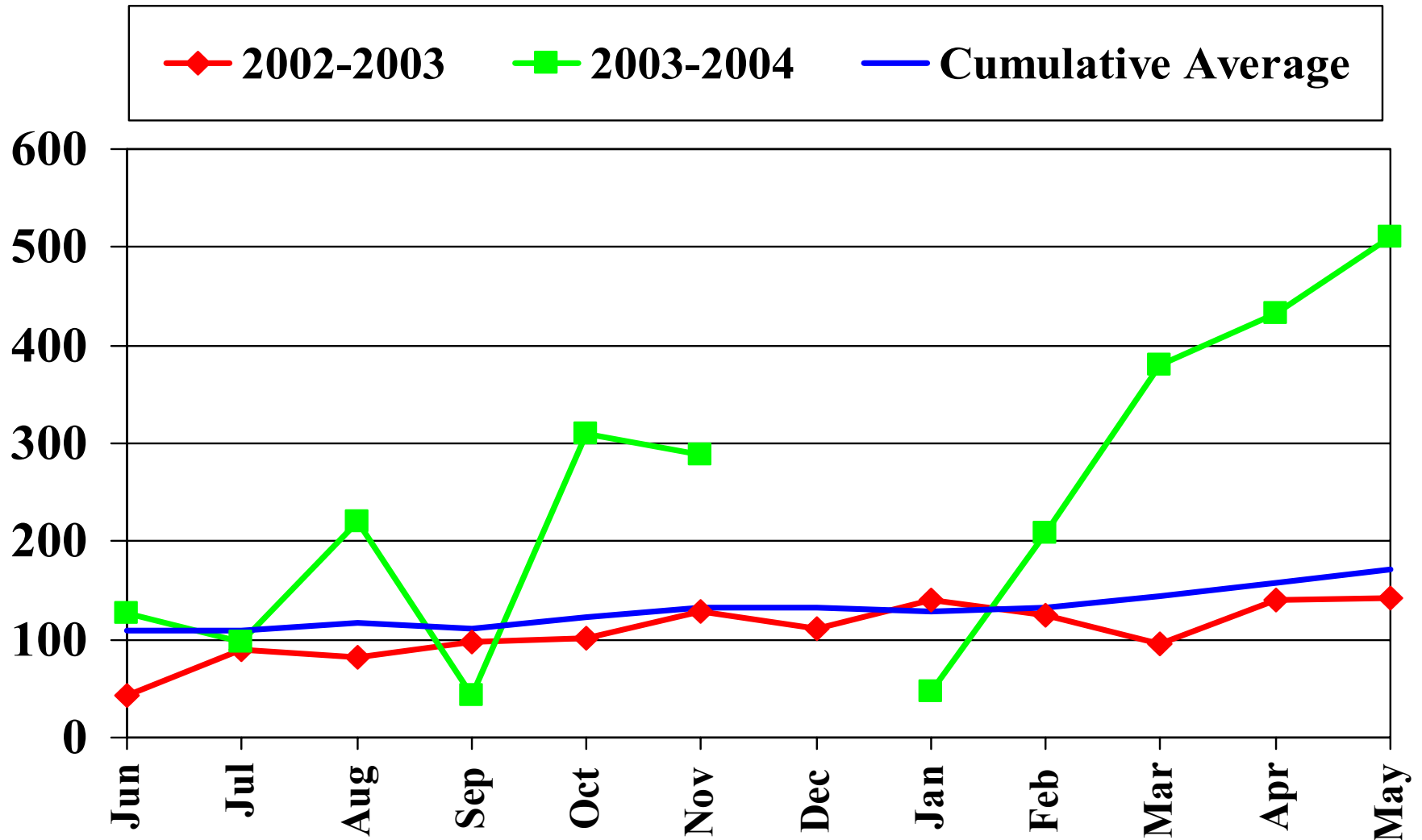

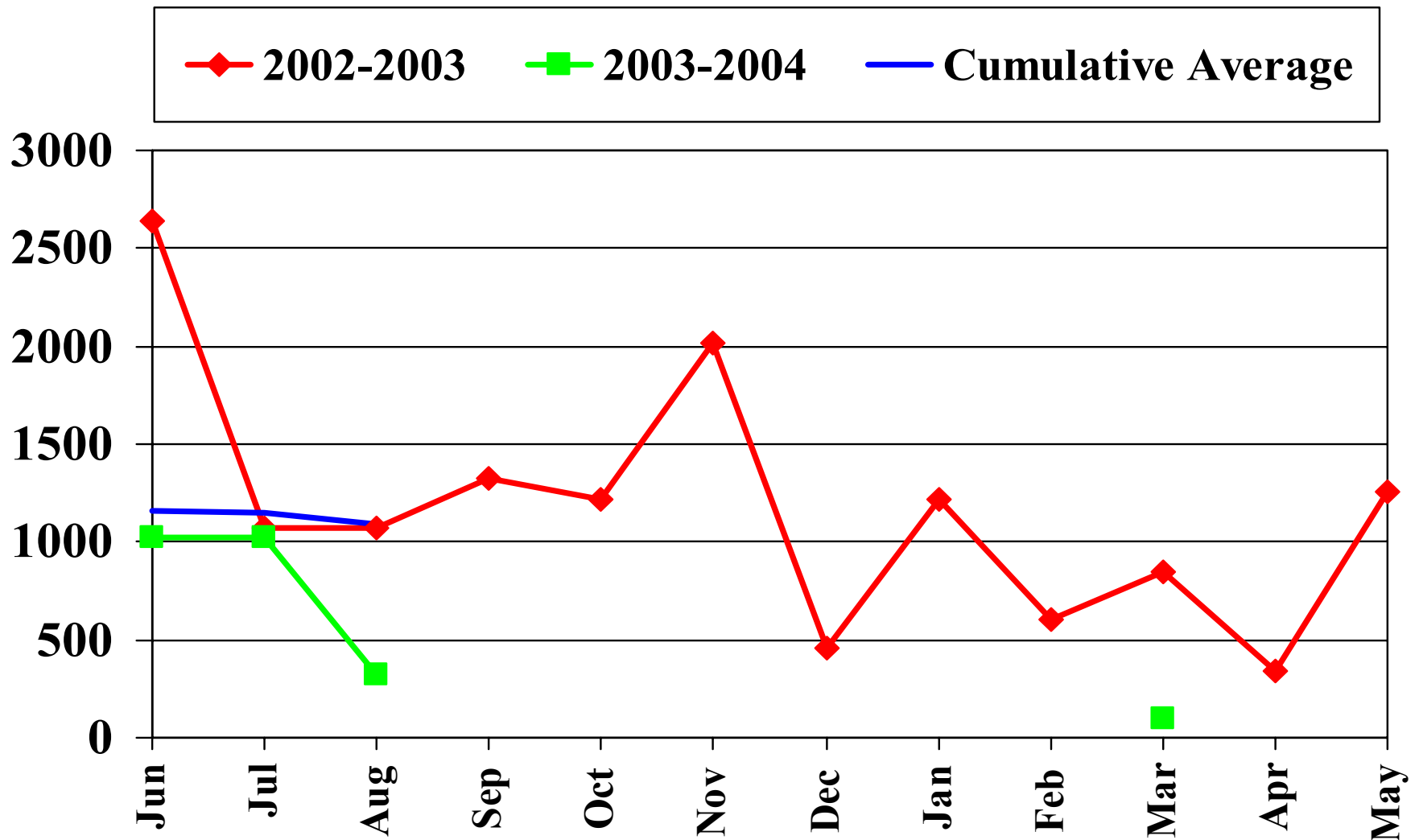

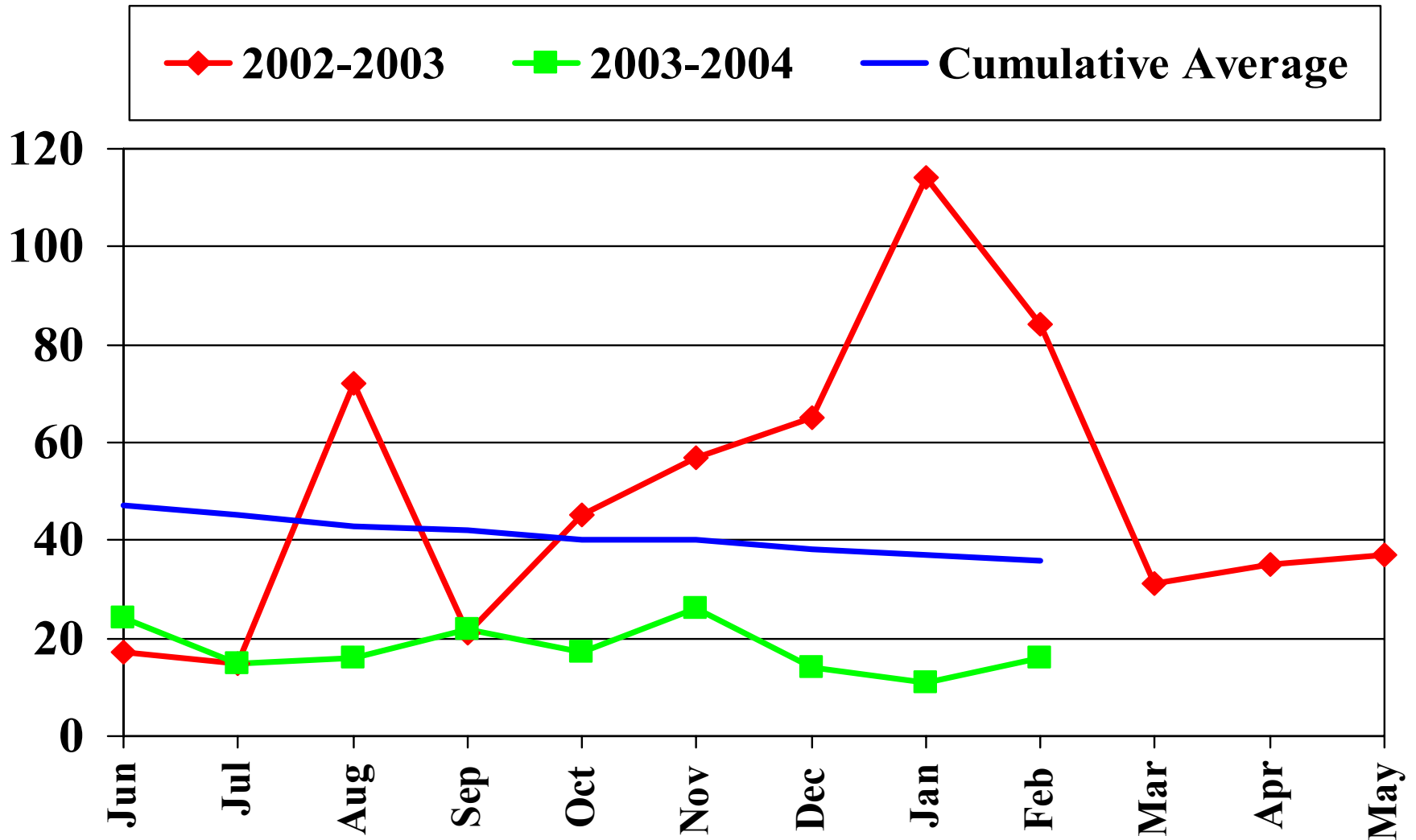

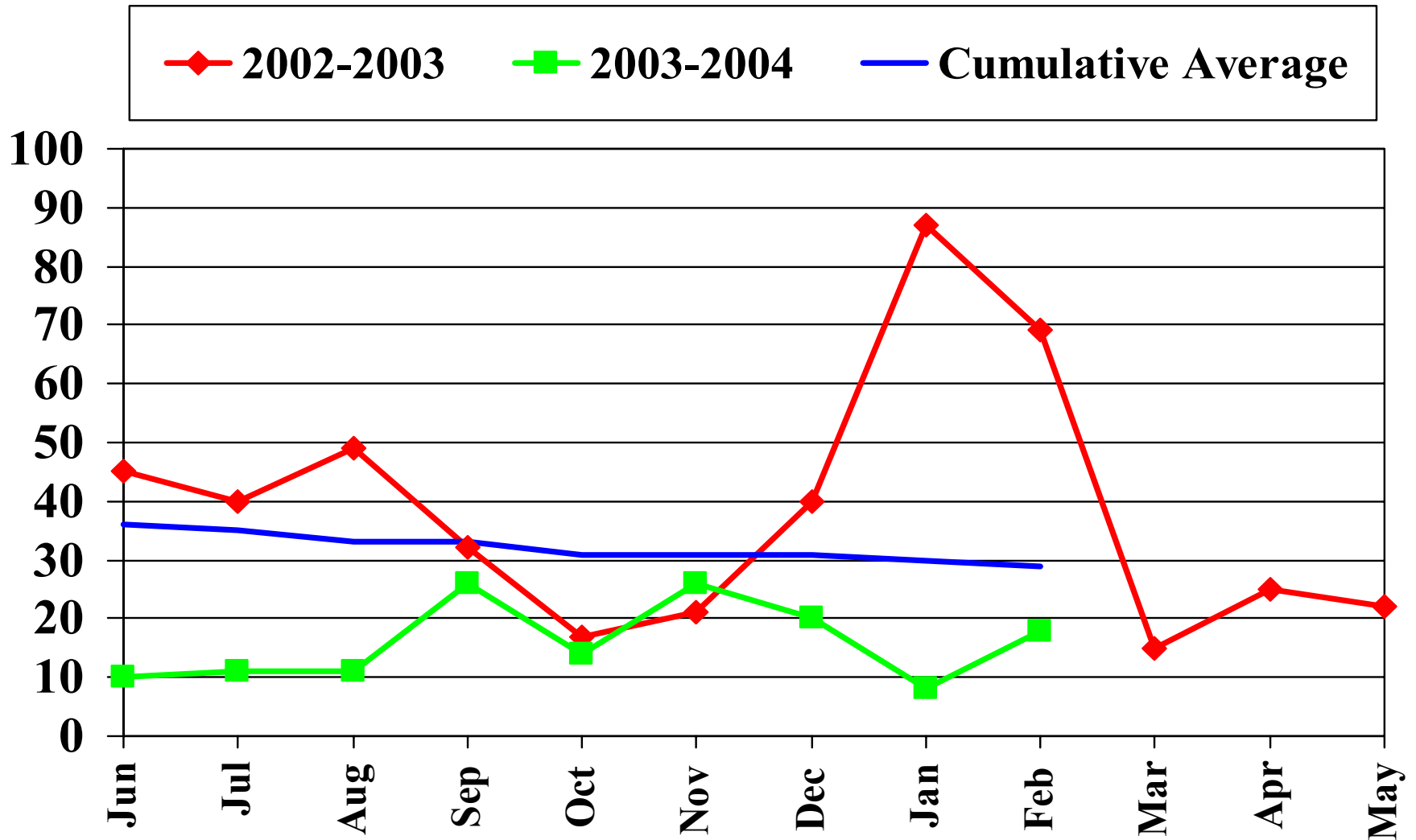
