Focus Groups - Purpose

- Eight key themes for discussion
- Small groups (10-15); open to general public by nomination
- Aimed at testing ideas and working concepts provides meaningful opportunity to influence thinking
- Not a decision-making group
- Focus is on growth solutions rather than validating the problems
- Participants likely to have alternative ideas about how to overcome implementation challenges – all input is welcome



Focus Groups - Format

- Presentation by consultant
 - Key issues: constraints and opportunities
 - Options or solutions considered
 - Key questions being tackled by Growth Plan
 - Key implementation challenges
- Structured discussion of three or four key questions / implementation challenges
- ToPH Executive Director acknowledgement of key themes
