9.1.1 Spoilbank Marina Concept Plans (residential and non-residential)

A teleconference was held with the following parties in attendance from Landcorp's office in Perth:

Matt Read guided the Committee through three options for the Spoilbank Marina Project. Option 1 was a non-residential proposal which Landcorp said may not be well-received by State Cabinet due to the lack of housing and its high cost. Option 2 included a residential component, however Landcorp advised that it could potentially face opposition from major industry concerned about dust levels. Option 3 was a futuristic hybrid of both options, showing what the Marina could look like in years to come if additional financial support was made available to fund an expansion.

NOTE: The Chairperson asked Matt Read if the residential apartments included in Option 2 would be similar to the high-density residential apartments seen in the Town's West End.

Matt Read said that the residential option Landcorp would like to build would be similar to the high-density apartments seen in the West End, but noted that while having a residential option would double the income received, it would not halve development costs.
