- Stall registrations close at 3.00pm, Monday 1 June 2020. No late registrations will be accepted.
- Stall registrations will only be confirmed for organisations operating in the Town of Port Hedland Local Government boundary.
- Organisation contact details provided in registrations will be made available to the public as a part of the Welcome to Hedland Digital Event 2020. If required, organisations are given the opportunity to provide two (2) sets of contact details:
  - One (1) set of contact details to be used by the Town of Port Hedland (the Town) only for registration purposes.
  - One (1) set of contact details to be made public on the Town's social media platforms, website and event web page, for digital event purposes.
- All costs associated in the production of any photo/s and or video ('Content') for registration purposes must be covered by the organisation themselves. The Town will not cover any costs incurred in the production of the Content.
- The Town will not be held liable for any loss, damage, accident, death or injury that may occur in the production of the submitted Content.
- Organisations agree that Content they submit will not be defamatory, obscene, derogatory, pornographic, sexually inappropriate, violent, abusive, harassing, threatening, objectionable with respect to race, religion, origin or gender, not suitable for children aged under 15, or otherwise inappropriate for publication. If deemed inappropriate, the Town has the right to dispose of Content without warning.
