

REGISTER OF ELECTORAL GIFTS

Local Government Act 1995

Local Government (Election) Regulations 1997

16 April 2021 to 19 October 2021

Part 5A of the *Local Government (Elections) Regulations 1997* requires both candidates and donors to disclose information about any electoral related gift with a value of \$200 or more that was given or promised during the disclosure period of 16 April 2021 to 19 October 2021. It is essential that candidates be aware of this legislative requirement and should advise donors of their reporting responsibilities.

The Chief Executive Officer is required to establish and maintain a public electoral gift register. Disclosures will be removed three days after Election Day for unsuccessful candidates and at the completion of the term of office for successful candidates.

How a disclosure is made

All disclosures are to be made on a LG09A Disclosure of Gifts form and delivered to the Town of Port Hedland Chief Executive Officer within three days of receiving the gift once your candidate nomination has been made to the Returning Officer.
