**KEY TERMS AND DESCRIPTIONS  
FOR THE PERIOD ENDED 31 OCTOBER 2022**

**REVENUE**

**RATES**

All rates levied under the *Local Government Act 1995*. Includes general, differential, specified area rates, minimum rates, interim rates, back rates, ex-gratia rates, less discounts and concessions offered. Excludes administration fees, interest on instalments, interest on arrears, service charges and sewerage rates.

**OPERATING GRANTS, SUBSIDIES AND CONTRIBUTIONS**

Refers to all amounts received as grants, subsidies and contributions that are not non-operating grants.

**NON-OPERATING GRANTS, SUBSIDIES AND CONTRIBUTIONS**

Amounts received specifically for the acquisition, construction of new or the upgrading of identifiable non financial assets paid to a local government, irrespective of whether these amounts are received as capital grants, subsidies, contributions or donations.

**REVENUE FROM CONTRACTS WITH CUSTOMERS**

Revenue from contracts with customers is recognised when the local government satisfies its performance obligations under the contract.

**FEES AND CHARGES**

Revenues (other than service charges) from the use of facilities and charges made for local government services, sewerage rates, rentals, hire charges, fee for service, photocopying charges, licences, sale of goods or information, fines, penalties and administration fees. Local governments may wish to disclose more detail such as rubbish collection fees, rental of property, fines and penalties, and other fees and charges.

**SERVICE CHARGES**

Service charges imposed under *Division 6 of Part 6 of the Local Government Act 1995*. *Regulation 54 of the Local Government (Financial Management) Regulations 1996* identifies these as television and radio broadcasting, underground electricity and neighbourhood surveillance services. Exclude rubbish removal charges.

**INTEREST EARNINGS**

Interest and other items of a similar nature received from bank and investment accounts, interest on rate instalments, interest on rate arrears and interest on debtors.

**OTHER REVENUE / INCOME**

Other revenue, which can not be classified under the above headings, includes dividends, discounts, rebates, reimbursements etc.

**PROFIT ON ASSET DISPOSAL**

Excess of assets received over the net book value for assets on their disposal.

**NATURE OR TYPE DESCRIPTIONS**

**EXPENSES**

**EMPLOYEE COSTS**

All costs associated with the employment of person such as salaries, wages, allowances, benefits such as vehicle and housing, superannuation, employment expenses, removal expenses, relocation expenses, worker's compensation insurance, training costs, conferences, safety expenses, medical examinations, fringe benefit tax, etc.

**MATERIALS AND CONTRACTS**

All expenditures on materials, supplies and contracts not classified under other headings. These include supply of goods and materials, legal expenses, maintenance agreements, communication expenses, advertising expenses, membership, periodicals, publications, hire expenses, rental, postage and freight etc. Local governments may wish to disclose more detail such as contract services, consultancy, information technology, rental or lease expenditures.

**UTILITIES (GAS, ELECTRICITY, WATER)**

Expenditures made to the respective agencies for the provision of power, gas or water. Exclude expenditures incurred for the reinstatement of roadwork on behalf of these agencies.

**INSURANCE**

All insurance other than worker's compensation and health benefit insurance included as a cost of employment.

**LOSS ON ASSET DISPOSAL**

Shortfall between the value of assets received over the net book value for assets on their disposal.

**DEPRECIATION ON NON-CURRENT ASSETS**

Depreciation expense raised on all classes of assets. Excluding Land.

**INTEREST EXPENSES**

Interest and other costs of finance paid, including costs of finance for loan debentures, overdraft accommodation and refinancing expenses.

**OTHER EXPENDITURE**

Statutory fees, taxes, allowance for impairment of assets, member's fees or State taxes. Donations and subsidies made to community groups.

**BASIS OF PREPARATION**

**BASIS OF PREPARATION**

The financial report has been prepared in accordance with Australian Accounting Standards (as they apply to local governments and not-for-profit entities) and interpretations of the Australian Accounting Standards Board, and the *Local Government Act 1995* and accompanying Regulations.

The *Local Government Act 1995* and accompanying Regulations take precedence over Australian Accounting Standards where they are inconsistent.

The *Local Government (Financial Management) Regulations 1996* specify that vested land is a right-of-use asset to be measured at cost, and is considered a zero cost concessionary lease. All right-of-use assets under zero cost concessionary leases are measured at zero cost rather than at fair value, except for vested improvements on concessionary land leases such as roads, buildings or other infrastructure which continue to be reported at fair value, as opposed to the vested land which is measured at zero cost. The measurement of vested improvements at fair value is a departure from AASB 16 which would have required the Town to measure any vested improvements at zero cost.

Accounting policies which have been adopted in the preparation of this financial report have been consistently applied unless stated otherwise. Except for cash flow and rate setting information, the financial report has been prepared on the accrual basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and liabilities.

**THE LOCAL GOVERNMENT REPORTING ENTITY**

All funds through which the Town controls resources to carry on its functions have been included in the financial statements forming part of this financial report.

All monies held in the Trust Fund are excluded from the financial statements. A separate statement of those monies appears at Note 14 to these financial statements.

**SIGNIFICANT ACCOUNTING POLICIES**

**CRITICAL ACCOUNTING ESTIMATES**

The preparation of a financial report in conformity with Australian Accounting Standards requires management to make judgements, estimates and assumptions that effect the application of policies and reported amounts of assets and liabilities, income and expenses.

The estimates and associated assumptions are based on historical experience and various other factors believed to be reasonable under the circumstances; the results of which form the basis of making the judgements about carrying values of assets and liabilities not readily apparent from other sources. Actual results may differ from these estimates.

The balances, transactions and disclosures impacted by accounting estimates are as follows:

- estimation of fair values of certain financial assets
- estimation of fair values of fixed assets shown at fair value
- impairment of financial assets

**GOODS AND SERVICES TAX**

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with receivables or payables in the statement of financial position. Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows.

**ROUNDING OFF FIGURES**

All figures shown in this statement are rounded to the nearest dollar.

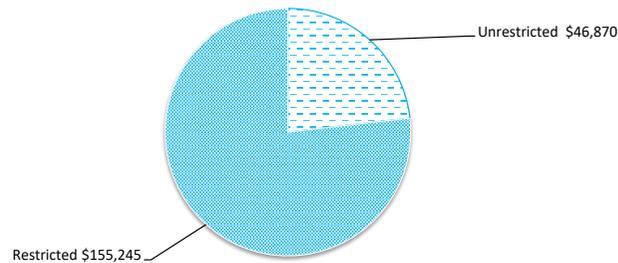
**KEY INFORMATION**

Cash and cash equivalents include cash on hand, cash at bank, deposits available on demand with banks and other short term highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value. Bank overdrafts are reported as short term borrowings in current liabilities in the statement of net current assets.

The local government classifies financial assets at amortised cost if both of the following criteria are met:

- the asset is held within a business model whose objective is to collect the contractual cashflows, and
- the contractual terms give rise to cash flows that are solely payments of principal and interest.

Financial assets at amortised cost held with registered financial institutions are listed in this note other financial assets at amortised cost are provided in Note 4 - Other assets.

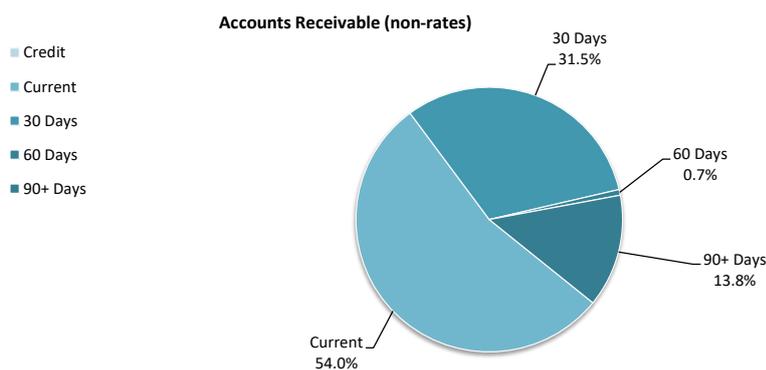
Trade and other receivables include amounts due from ratepayers for unpaid rates and service charges and other amounts due from third parties for goods sold and services performed in the ordinary course of business.

Trade receivables are recognised at original invoice amount less any allowances for uncollectable amounts (i.e. impairment). The carrying amount of net trade receivables is equivalent to fair value as it is due for settlement within 30 days.

**Classification and subsequent measurement**

Receivables which are generally due for settlement within 30 days except rates receivables which are expected to be collected within 12 months are classified as current assets. All other receivables such as, deferred pensioner rates receivable after the end of the reporting period are classified as non-current assets.

Trade and other receivables are held with the objective to collect the contractual cashflows and therefore the Town measures them subsequently at amortised cost using the effective interest rate method.

**Other financial assets at amortised cost**

The Town classifies financial assets at amortised cost if both of the following criteria are met:

- the asset is held within a business model whose objective is to collect the contractual cashflows, and
- the contractual terms give rise to cash flows that are solely payments of principal and interest.

**Inventory**

Inventories are measured at the lower of cost and net realisable value.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

**Land held for resale**

Land held for development and resale is valued at the lower of cost and net realisable value. Cost includes the cost of acquisition, development, borrowing costs and holding costs until completion of development.

Borrowing costs and holding charges incurred after development is completed are expensed.

Gains and losses are recognised in profit or loss at the time of signing an unconditional contract of sale if significant risks and rewards, and effective control over the land, are passed onto the buyer at this point.

Land held for resale is classified as current except where it is held as non-current based on the Council's intentions to release for sale.

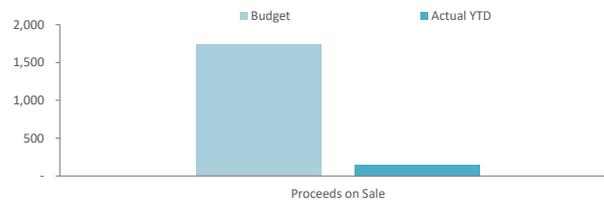

**SIGNIFICANT ACCOUNTING POLICIES**

Each class of fixed assets within either plant and equipment or infrastructure, is carried at cost or fair value as indicated less, where applicable, any accumulated depreciation and impairment losses.

Assets for which the fair value as at the date of acquisition is under \$5,000 are not recognised as an asset in accordance with *Financial Management Regulation 17A (5)*. These assets are expensed immediately.

Where multiple individual low value assets are purchased together as part of a larger asset or collectively forming a larger asset exceeding the threshold, the individual assets are recognised as one asset and capitalised.

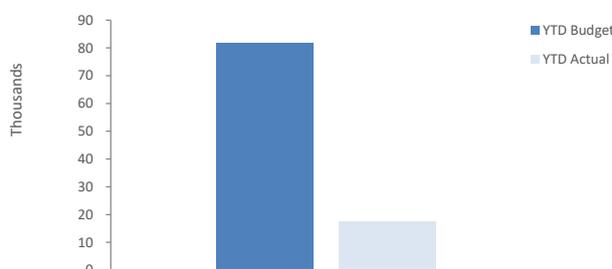
**Initial recognition and measurement for assets held at cost**

Plant and equipment including furniture and equipment is recognised at cost on acquisition in accordance with *Financial Management Regulation 17A*. Where acquired at no cost the asset is initially recognise at fair value. Assets held at cost are depreciated and assessed for impairment annually.

**Initial recognition and measurement between mandatory revaluation dates for assets held at fair value**

In relation to this initial measurement, cost is determined as the fair value of the assets given as consideration plus costs incidental to the acquisition. For assets acquired at zero cost or otherwise significantly less than fair value, cost is determined as fair value at the date of acquisition. The cost of non-current assets constructed by the Town includes the cost of all materials used in construction, direct labour on the project and an appropriate proportion of variable and fixed overheads.

Provisions

Provisions are recognised when the Town has a present legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured using the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Employee Related Provisions

Short-term employee benefits

Provision is made for the Town's obligations for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled. The Town's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as a part of current trade and other payables in the calculation of net current assets.

Other long-term employee benefits

The Town's obligations for employees' annual leave and long service leave entitlements are recognised as employee related provisions in the statement of financial position.

Long-term employee benefits are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Any remeasurements for changes in assumptions of obligations for other long-term employee benefits are recognised in profit or loss in the periods in which the changes occur. The Town's obligations for long-term employee benefits are presented as non-current provisions in its statement of financial position, except where the Town does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

Contract liabilities

An entity's obligation to transfer goods or services to a customer for which the entity has received consideration (or the amount is due) from the customer.

Capital grant/contribution liabilities

Grants to acquire or construct recognisable non-financial assets to identified specifications be constructed to be controlled by the Town are recognised as a liability until such time as the Town satisfies its obligations under the agreement.

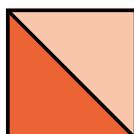

## THE JUNCTION CO. - AN OVERVIEW

In an ever-changing environment, The Junction Co. are agile to ensuring exhibitions, community programming and creative development reach those who need it most, our regional communities.

The Junction Co. program framework capacity-builds regional creatives and provides platforms for the broader community to engage with the creative industries. There are two distinct facilitated learning pathways for creatives to extend their knowledge and skill growth through formal and informal education points: Creative Enterprise and Artistic Excellence. In addition to this, a third stream, Connecting Communities, works to engage the community in culture, the arts and creativity, improving the liveability of the town. An overview of these areas is provided below, and the report detail is structured under these headings.

### **Creative Enterprise**

This program is a curated series of practical capacity-building workshops, enterprise development sessions, mentoring, and the facilitation and coordination of retail platforms designed to support creative entrepreneurs, building sustainable and dynamic enterprises.

### **Artistic Excellence**

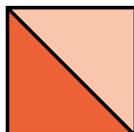
This program has been designed to impart the skills, knowledge and creative independence required to develop Pilbara-based artists. Using a combination of mentoring, workshops, studio learning, participants receive individual guidance and group activities. The artists are supported in their exploration of art making, confidence development and exhibiting their work.

### **Connecting Communities**

Through a program of place activation activities we seek to actively improve community membership and engagement, encourage a balance of work and play, and assist in strengthening a Pilbara identity. In addition to the program framework, The Junction Co. is well positioned to be the hub for community, the arts and creativity through the following.

### **Place Activation Project**

Together with our neighbours in Hedland’s West End, The Junction Co. continues to coordinate programming to activate and revitalise the precinct around the



Courthouse Gallery+Studio. In partnership with an energetic town team of businesses, community organisations and residents, we are developing a common, positive narrative for the area of the West End bounded by The Esplanade, McKay Street, Richardson Street and Anderson Street, to:

- Create a positive, recognisable identity for the area, and improve community perceptions
- Encourage longer visitation to the area from a broader segment of the community
- Build a sense of community among our neighbours, and broader community

In July 2020, the town team officially became the 49<sup>th</sup> Town Team in Australia and New Zealand and have been energised in activating Portside. Minutes for each Town Team meeting are available upon request, and provided to team members, including the Town of Port Hedland.

**Regional Arts Network**

The Junction Co. is one of eight diverse organisations leading Regional Arts Network initiative coordinated by Regional Arts WA, striving to re-imagine how arts services are delivered to local communities across regional and remote Western Australia and engage in critical dialogue on subjects relevant to WA’s regional arts sector. The Network acts as an information and resource sharing forum between the Network and Regional Arts WA, sharing relevant information and resources between the Network and other groups, identifying areas where regional arts advocacy is required and working together to spread awareness and driving identified state-wide initiatives.

The Regional Hub Coordinator works closely with the Courthouse Gallery+Studio, broader The Junction Co team and regional agencies to ensure the ongoing development of the program offerings, enabling greater visibility on opportunities for Hedland and Pilbara creatives to share their creative endeavours more broadly, and vice versa.

The Regional Arts Network have recently updated the TOR, and honed on their purpose and mission:

***The Regional Arts Network is a sustainable and thriving ecosystem of connected creative regional communities that engage with their local community, local governments, and key stakeholders to drive state-wide collaborative projects and conversations.***

***The purpose of the Regional Arts Network is to connect, collaborate and share information across the state to strengthen the regional arts sector.***

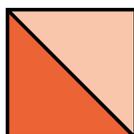
An exciting project the Courthouse Gallery+Studio team have been working on this past quarter, with the RAN is the development of a Creative Youth Directory, a platform for youth to showcase their work, creative disability and inclusion program and development of the relevant recourses for arts workers and carers, as well as regional exhibition programs like Act Belong commit Ebb+Flow.

*Act Belong Commit Ebb+Flow* brings together ten artists from each region of Western Australia and their exploration of constant changes within regional communities within Western Australia.

Throughout 2021 and early 2022, community members in the North Midlands joined the artists to explore how changes in our regional communities are often temporary. *Act Belong Commit Ebb+Flow* worked with the creative and collaborative nature of the arts to explore the past and look to the future of regional communities.

Exploring the temporary periods of decline and growth, drought and rain, hardship and prosperity, the ten residencies resulted in an exciting co-designed exhibition.

The exhibition featured artists Lynda Howitt, Martine Perret, Sarah-Jane Eeles, Mikaela Castledine, Siobhan Kelley, Crystal Stacey, Diedre Robb, Sue Helmut, Nyree Taylor and Marianthe Loucataris.

These ten artists explored how these factors outside of our control ebb and flow within our unique regional areas, reflected by the various mediums of visual, written, sculptures and digital works.

As a former Port Hedland resident, artist Siobhan Kelley was invited to share additional works with the Hedland community as part of the exhibition. In addition to that, Siobahn engaged with various community groups in Port Hedland through workshops, *Mark Making* to share her knowledge and practice. The results of these workshops was contribute to her future works.

Prior to the official opening, Siobahn Kelley (artist) and curators Andrew Bowan-Bright and David Bowman-Bright talked to the public about the experience and provided a brief overview of each artwork exhibited. The talk was live-streamed and the public was able to ask questions and gain insight into the exhibition. Livestream was attended by many regional communities.

The opening night exhibition was held in a warm, friendly and inclusive atmosphere. The SAFE Hedland was also invited to provide a sausage sizzle for a donation.

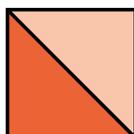

Act Belong Commit – Mark Making was a free workshop held by the Courthouse Gallery+Studio and The Junction Co. in partnership with North Midlands Project. It was our pleasure to invite Act Belong Commit Ebb+Flow artist Siobhan Kelley to share her knowledge and practice through these workshops with various Hedland community groups.



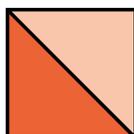
In the workshops, participants were encouraged to respond to the environment with a sense of 'feeling' the landscape, rather than making an accurate representation of it. Using pencils and graphite, participants experimented with a variety of marks that 'feel out' an object, rather than accurately represent it.

The workshop began with a few quick drawing exercises to loosen the hand and the mind. Artist Siobhan Kelley kept these drawings that became part of a collaborative artwork, contributing to Siobhan's future works.

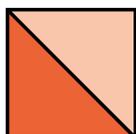

*Every Wednesday from 9 am to 10 am.*

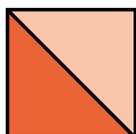
Art Antics is a children's art class for children five years and under, except for families passing through town who pop in or sometimes home school children. It is held on Wednesday 9-10 am at The Courthouse Gallery + Studio.

Art Antics is for any children who love crafts and love the freedom to explore and play while refining their fine motor skills, knowledge of colours, and learning in a group environment. It is a free class that enables anyone from the community to come along and join in. Amy, the facilitator, offers a demo and explanation of the planned activity and then helps them to create their work. It is a very relaxed and intimate atmosphere that allows the mothers and fathers to talk and share with other parents facing similar life experiences.

Throughout the last term, we made an air-dry clay trinket dish then painted it, and a card for Father's Day/ someone special in their life. We learnt how to draw a self portrait look at the basic elements of a face. Then using collage techniques we surrounded our face with things that we love such as strawberries, cars and flowers.

We cut up recycled coffee cups holders and turned them into bangles. Decorated with feathers and other amazing jewels, so they looked as fabulous as possible!

The Art Antics program has provided a regularly opportunity for creative chaos, community connection and skill development. # 1. Introduction

This report has been prepared by **element**, on behalf of Gravity Crane Services Pty Ltd, to request the initiation of an amendment to the Town of Port Hedland Local Planning Scheme No. 7 (LPS 7). The proposal will formalise the zoning of the land to reflect the current and intended future light industrial land use under the planning framework.

The amendment proposes to rezone Lot 6270 (No. 5) Miller Street, Wedgefield (the 'subject site') from 'Environmental Conservation' reservation to 'Light Industrial' zone generally in line with that envisaged under the strategic framework for the area.

LPS 7 identifies the following objectives for the Light Industry zone:

- *To provide for a range of industrial uses and services industries generally compatible with urban areas, that cannot be located in commercial zones;*
- *To ensure that where any development adjoins zoned or developed residential properties, the development is suitably set back, screened or otherwise treated so as not to detract from the residential amenity.*

This report sets out the context of the proposed amendment in the planning framework, along with suitability and capability for rezoning. This report includes a description of the following matters:

- Site details and locational information;
- Background consultations in the formulation of the amendment request;
- Description of the existing land uses and site attributes;
- Consideration of relevant planning framework;
- Detailed explanation of the proposed amendment; and
- Justification for the proposed amendment.

## 1.1 Scope and Nature of Amendment

This local scheme amendment request seeks to amend the scheme map to reclassify the subject site from its existing 'Environmental Conservation' reserve to 'Light Industry' zone.

The amendment is deemed to be a 'Standard' amendment under the provisions of the *Planning and Development (Local Planning Schemes) Regulations 2015* for the following reasons:

- It is an amendment that is generally consistent with the objectives of the relevant zone;
- It is generally consistent with the Town of Port Hedland Local Planning Strategy;
- It will have minimal impact on land in the Scheme not subject to this amendment; and
- It does not result in any significant environmental, social, economic or governance impacts on land in the Scheme area.

## 2. Background

### 2.1 Location and Context

The amendment area comprises one (1) landholding of approximately 0.729 hectares at Lot 6270 (No. 5) Miller Street, Wedgefield (the 'subject site').

The subject site is located in Wedgefield, the industrial precinct within the municipality of the Town of Port Hedland and is bound by Miller Street to the east, Environmental Conservation reserved land to the north and west, and light industrial zoned land to the south.

### 2.3 Existing Land Use

The subject site is currently occupied by Mammoet Australia (heavy lifting and transport) for use as a lay-down area and by J & S Trucks & Machinery (a commercial vehicle mechanic) for storage under a crown lease over the land. The businesses exist as part of a number of tenancies operating over the subject site, Lot 5834 (No. 40) Moorambine Street, Lot 5913 (No. 44) Moorambine Street and Lot 601 Miller Street within the Wedgefield light industrial precinct.

The existing operations have not been granted development approval under LPS, however we confirm that a development approval will be sought from the Town of Port Hedland.

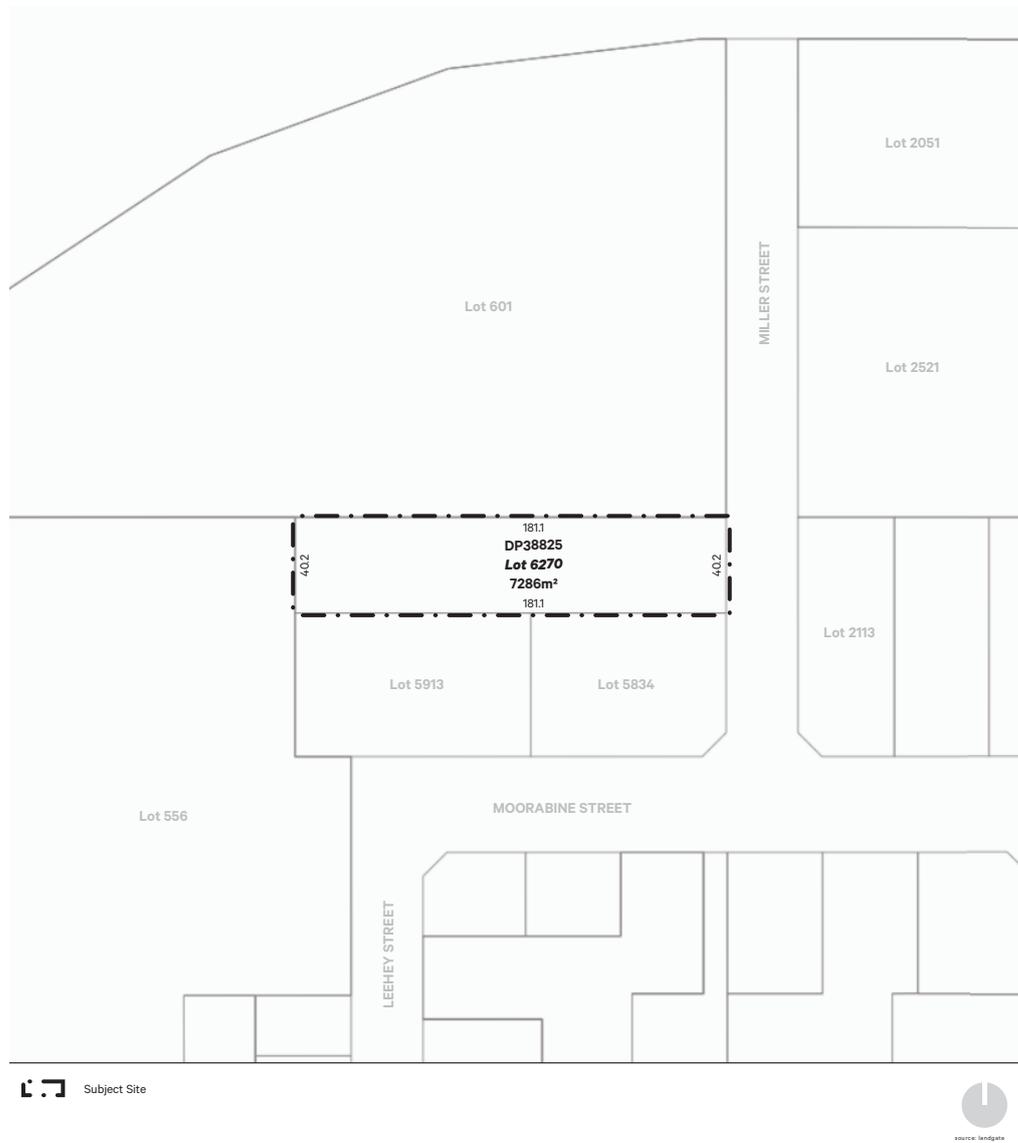


Figure 3. Site Plan

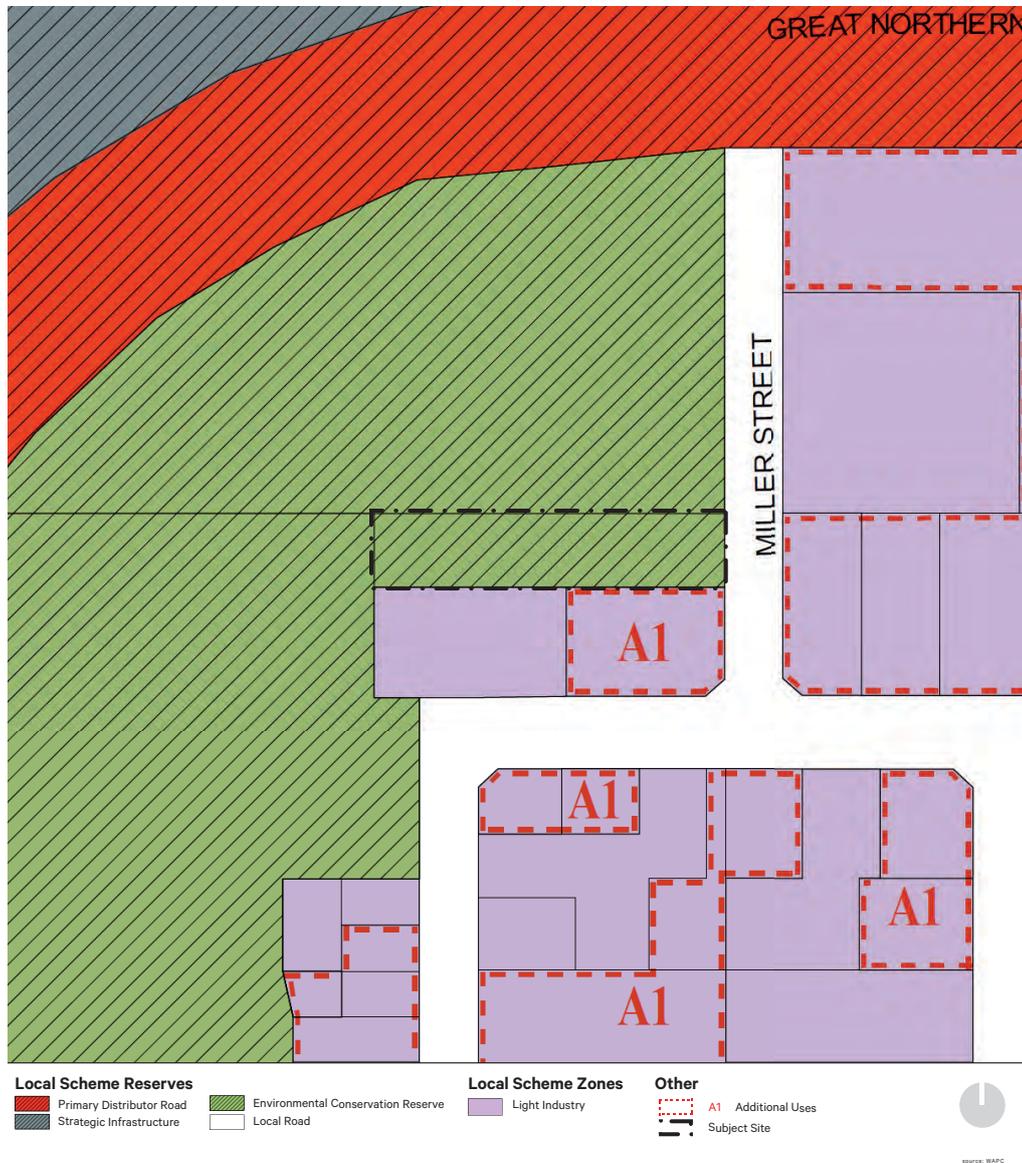


Figure 4. Town of Port Hedland LPS 7

## 3. Site Analysis

The following section is a general description of the site characteristics of the subject land area. The section demonstrates that there are no significant constraints to facilitating rezoning of the land.

### 3.1 Bushfire Considerations

A desktop search of the Department of Fire and Emergency Services (‘DFES’) Map of Bushfire Prone Areas indicates that the subject site is located within a bushfire prone area. Although the subject site is constrained by bushfire, these considerations can be addressed at the development application stage.

*Refer to Appendix A – Bushfire Attack Level Assessment.*

### 3.2 Acid Sulphate Soils

A desktop search of the Department of Water and Environmental Regulation (‘DWER’) Acid Sulphate Soil Risk Map, indicates that the subject land does not contain any known risk of encountering acid sulphate soils.

### 3.3 Heritage Considerations

A desktop search of the Department of Planning, Lands and Heritage (‘DPLH’) Aboriginal Heritage Inquiry System and the Heritage Council’s State Heritage Register indicate that there are no listings of State or national heritage significance impacting the subject land.

### 3.4 Contaminated Sites

A desktop search of the DWER Contaminated Sites Database indicates that the subject land is not classified as a contaminated site.

### 3.5 Site Access

The site is currently accessed via Miller Street on the eastern boundary. Internal access between the subject site and Lot 5913 to the south also provides a point of access and egress onto Moorambine Street for existing tenants.

### 3.6 Servicing

Water services are located in the adjoining road reserve along Moorambine Street to the south and Miller Street to the east. Underground power services are available to the subject site. Sewer is not available in this area.

## 4. Proposed Scheme Amendment

This part describes the rationale for the scheme amendment request and approach proposed.

### 4.1 Overview of Amendment

This scheme amendment seeks to amend LPS 7 by rezoning the subject site from 'Environmental Conservation' reserve to 'Light Industry' zone. The proposed scheme amendment does not propose any alterations to the LPS 7 text.

The subject site has been used for light industrial purposes by Mammoet Australia and J & S Trucks & Machinery under a crown lease since 2004. Gravity Crane Services has sought to purchase the land from the State government and the scheme amendment to rezone the land to light industry zoning will reflect the current and future industrial use of the land.

*Refer Attachment 1 – Proposed Zoning.*

### 4.2 Background Consultations

In formulating this local planning scheme amendment, preliminary consultation was undertaken with the Town's planning officers and refined the scope of the requested amendment accordingly.

As detailed in correspondence with the Town of Port Hedland in February 2021, officers acknowledged that the proponent entered into a lease commencing 22 January 2004 for the use of "Light Industry" and has been operating as such. It was advised that a scheme amendment would be required to rezone the property from 'Environmental Conservation' reserve to the 'Light Industry' zone. DPLH officers confirmed that the scheme amendment would rationalise the existing use of the land and enable the land to be purchased by the current operator.

### 4.3 Planning Rationale

The proposed amendment is considered to be consistent with the principles of orderly and proper planning and is largely aligned with the general principles and broader vision set under the strategic framework for the area. Specifically, the rezoning to Light Industry will facilitate consistency between LPS 7 and the Town's Local Planning Strategy, which contemplates light industrial land use and development over the subject site.

The land has been used for light industrial purposes since 2004 (operating under a crown lease) and therefore the proposed scheme amendment will reflect the site's current and future light industrial use and is consistent with the objectives of the Light Industry zone.

The subject site is predominately cleared and does not contain any areas of biodiversity or conservation significance. In this regard, the existing designation within the Environmental Conservation reserve is not appropriate as it does not reflect the actual use of the land. As such, the proposed rezoning will not result in any adverse environmental, planning or amenity outcomes.

## 5. Planning Context

### 5.1 Planning and Development (Local Planning Schemes) Regulations 2015

The Planning and Development (Local Planning Scheme) Regulations 2015 (the Regulations) made under the Planning and Development Act 2005 (the Act), govern the way in which local planning strategies and local planning schemes are prepared, consolidated and amended. Section 75 of the Act provides local governments with the ability to amend a local planning scheme and the Regulations divide scheme amendments into either a basic, standard or complex classification.

The proposed amendment is considered to be a 'standard' amendment for the following reasons:

- The proposed Light Industry zoning is consistent with the land use contemplated under the Town of Port Hedland Local Planning Strategy;
- The proposed amendment will have minimal impact on surrounding land within the scheme area;
- The proposed amendment will not result in any significant environmental, social, economic or governance impacts;
- The proposal is not a complex or basic amendment.

### 5.2 Town of Port Hedland Local Planning Strategy

The Town of Port Hedland Local Planning Strategy (the 'Strategy') was published in May 2021 and is the primary planning document for the municipality, providing the rationale for the zones and other provisions of LPS 7, with a timescale of 10-15 years.

Pursuant to the Strategy, the subject site is identified for 'Light Industry' land use. The Strategy contemplates the following objectives for light industry land use within the Wedgefield Precinct:

- *Resolve land use conflicts between industrial and sensitive land uses.*
- *Provide a safe and efficient road network to support transport logistics.*
- *Provide sufficient industrial land to meet long-term requirements for industry.*
- *Protect open swale drainage networks from encroaching development.*
- *Improve the general amenity of industrial areas over time.*

The proposed local planning scheme amendment is consistent with the above objectives and will reflect the light industrial land use contemplated for the land under the Strategy.

### 5.3 Town of Port Hedland Local Planning Scheme No. 7

The Town of Port Hedland LPS 7 is the primary statutory document guiding land use and development within the municipality. Pursuant to LPS 7, the subject site is zoned 'Environmental Conservation'. The Environmental Conservation reserve seeks to:

- *Identify areas with biodiversity and conservation value, and to protect those areas from development and subdivision;*
- *Identify and protect areas of biodiversity conservation significance within National Parks and State and other conservation reserves.*

The objectives of the 'Light Industry' zone, as contemplated under LPS 7 are outlined below:

- *To provide for a range of industrial uses and services industries generally compatible with urban areas, that cannot be located in commercial zones;*
- *To ensure that where any development adjoins zoned or developed residential properties, the development is suitably set back, screened or otherwise treated so as not to detract from the residential amenity.*

As demonstrated above, it is clear that the subject site is not consistent with the objectives for the Environmental Conservation reserve given that the land is cleared and of no biodiversity or conservation significance. The subject site has been used for light industrial purposes under a crown lease since 2004 and rezoning to Light Industry will be consistent with the objectives of the zone. The proposed scheme amendment will formalise the zoning of the land to light industry and will reflect the current and intended future use already contemplated under the Strategy.

## 6. Conclusion

This report has been prepared by **element**, on behalf of Gravity Crane Services Pty Ltd, to request the initiation of an amendment to the Shire of Port Hedland Local Planning Scheme No. 7 to facilitate a rezoning from 'Environmental Conservation' to 'Light Industry' zone at Lot 6270 (No. 5) Miller Street, Wedgefield.

This report has demonstrated that the proposed local planning scheme amendment is consistent with the principles of orderly and proper planning and is largely aligned with the general principles and broader vision set under the strategic framework for the area. In particular, it is noted that:

- The proposed Light Industry zoning is aligned with the Town's and WAPC-endorsed Local Planning Strategy;
- The existing designation of the land within the Environmental Conservation reserve does not reflect the actual use of the land, which is predominately cleared and is of no biodiversity or conservation significance;
- The proposed rezoning will reflect the current and intended future use of the land and consistent with the objectives of the light industry zone;

For these reasons, the amendment is in balance justified under the planning framework and will reflect the current and intended future use of the land.

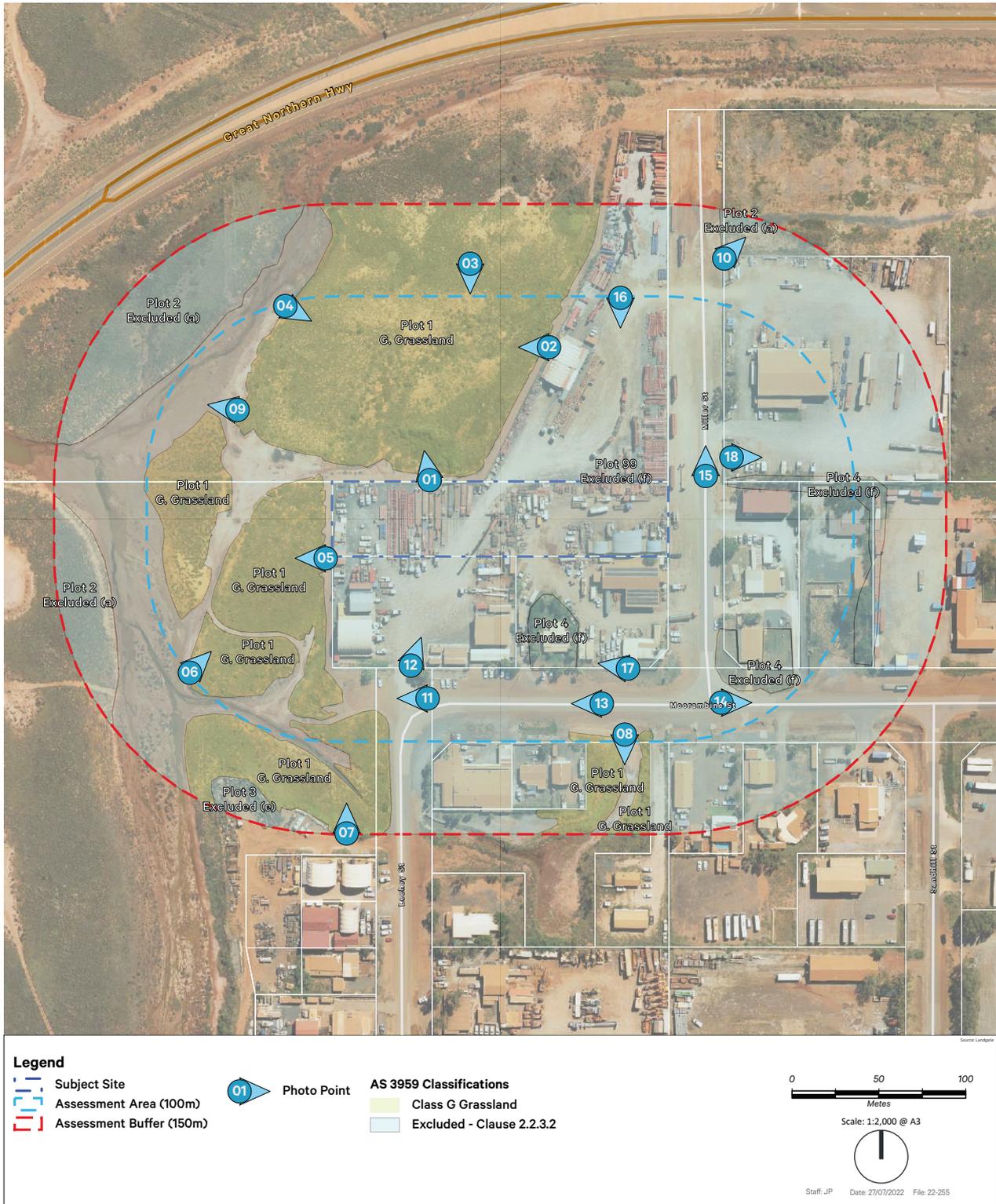
Vegetation Classification and Slope Analysis

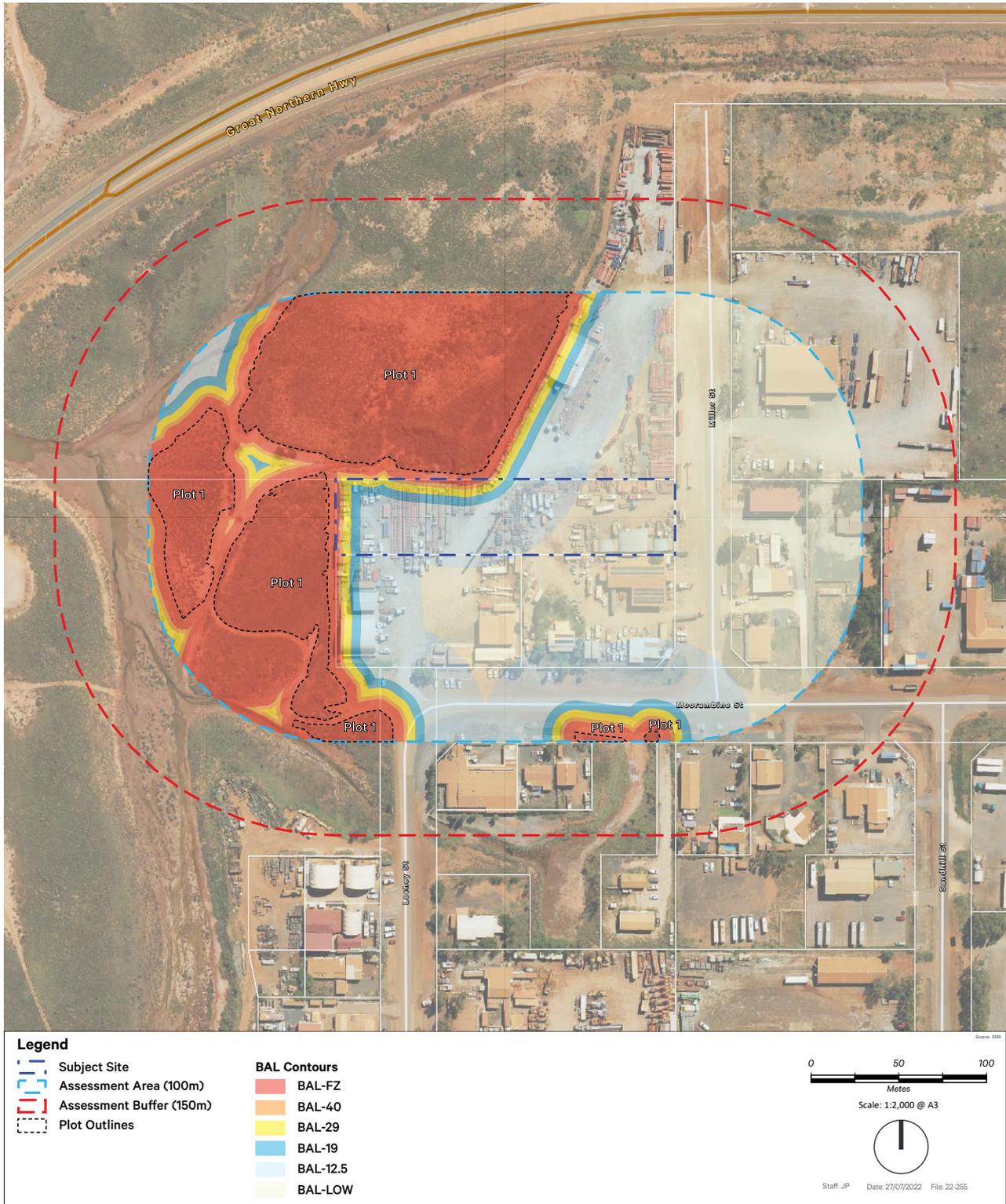
The assessment inputs in Table 1 have been relied upon to prepare the BAL Contour Map in Figure 2 which determines the radiant heat impact on the subject site based on existing conditions. The BAL Contour Map has been prepared in accordance with *State Planning Policy 3.7 Planning in Bushfire Prone Areas* (SPP3.7), the *Guidelines for Planning in Bushfire Prone Areas* (the Guidelines) and *AS 3959-2018*.

The BAL Contour Map indicates that the western and northern boundaries at the vegetation interface are subject to BAL-FZ and BAL-40, with the remainder of the site subject to BAL-29 or below. Given the subject site is primarily used for storage, the bushfire impact on the subject site is considered acceptable, in accordance with SPP 3.7 and the Guidelines.

### Additional Considerations

This assessment has been prepared to accompany the scheme amendment only and demonstrates that the radiant heat exposure on the subject site is acceptable to enable the scheme amendment to be initiated by the Town of Port Hedland.

Any future development of the subject site will require a Bushfire Management Plan to be prepared at development application stage to demonstrate compliance with SPP 3.7 and the Guidelines, including adequate separation from the identified bushfire hazards.

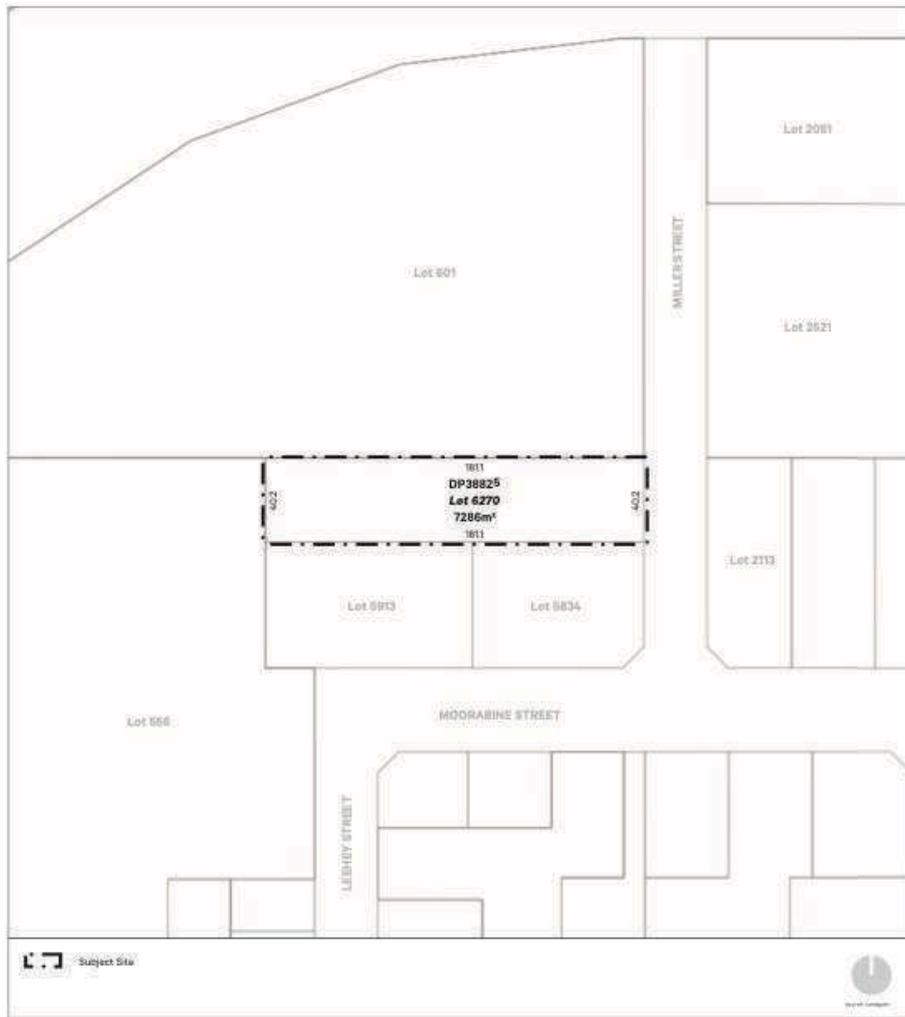

### Appendix 1: Bushfire Attack Level (BAL) Explained

A Bushfire Attack Level (BAL) Assessment is a means of measuring the severity of a building's potential exposure to ember attack, radiant heat and direct flame contact, using increments of radiant heat expressed in kilowatts per metre squared, and the basis for establishing the requirements for construction to improve protection of building elements from attack by bushfire.

The methodology used to determine the Bushfire Attack Level and the subsequent building construction standards are sourced from *AS3959-2018 Construction of buildings in bushfire prone areas*. The Bushfire Attack Level is determined through the following steps:

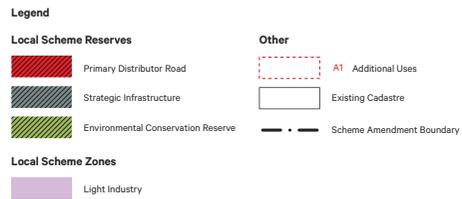
1. Determine the relevant Fire Danger Index (FDI) rating. FDI 80 is assigned within WA;
2. Determine the classified vegetation within 100 metres of the subject building;
3. Determine the separation distance between the building and the classified vegetation source/s;
4. Determine the slope of the land under the classified vegetation; and
5. Determine the BAL from the appropriate table of AS3959-2018.

AS 3959-2018 has six levels of BAL ratings based on the radiant heat flux exposure to buildings as outlined below. AS 3959 details the building construction standards relevant to each BAL; the relevant sections of AS 3959 are provided below.

**July to December 2021**

July to September 2021 saw an unprecedented rise in foot traffic through the door of the Visitor Centre. Our popular tours were booked out daily and Pilbara Tours put on extra tours to accommodate the huge numbers that were requesting to do their tours.



There were scheduled Eastern states tour companies that cancelled when COVID closed borders and the tours became untenable. Tours that cancelled were Martins Albury Coaches and Southern Cross Coaches. Fortunately, they have rescheduled for 2022.

**Hosted Keep Australia Beautiful Tidy Towns judges**

On 15 September, the Visitor Centre hosted the Keep Australia Beautiful Tidy Towns judges who got to speak to delegates from the Men's' Shed (Sam Arif), Port Hedland Historical Society (Nina Pangahas), Visitor Centre (Julie Arif), Care for Hedland Environmental Group (Kelly Howlett), citizen scientist and Senior Citizen of the Year 2021 Doris Tuefel, and Pilbara Tours (Sam Smeeton). All the guests spoke passionately about Port Hedland and the bit they do to promote a great community.

**Power outage**

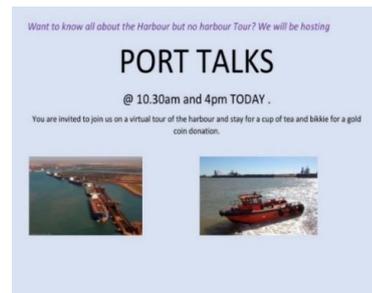


We were contacted by the Town of Port Hedland regarding an urgent electrical matter that required the power to be disconnected for 2 days. This was to happen in the peak of the tourist season. After two false starts the power was disconnected and we moved the tourist service outdoors for 2 days to still assist with information services and brochures/ maps etc. The visitors were happy with our adaptability and would have been very

discontented if we had shut the doors for 2 days. Visitor services went al fresco for 2 days.

**Port Talks**

With the closure of the jetty due to maintenance, the prestigious Harbour Tour was not available and the demand for facts and information about the port prompted the Port Talks session which was very popular. Seventeen sessions (17) were delivered at the Visitor Centre by the staff and 364 people attended.



**Promotion**

The WA Caravan and Camping show came to Port Hedland and filmed a segment about Port Hedland including the Visitor Centre “Free things to do in Port Hedland” as well as other aspects of tourism in Port Hedland. This segment was aired on Channel 7 on 28 August.

ABC KIMBERLEY did an outside broadcast in front of the Visitor Centre on 4 August and had many guest speakers talking about many tourism aspects of Port Hedland.

**Finalist Business of the Year Awards**

The Port Hedland Visitor Centre were a finalist in the 2021 Port Hedland Chamber of Commerce and industry Business of the Year awards in the categories of Tourism and Hospitality, and Business 5 – 10 employees.

**Exhibition**

The Visitor Centre got into the Olympic spirit during the 2020 Tokyo summer Olympics with a small exhibition of Olympic memorabilia.



**Yarning with a local**

This event was held Friday morning at 11:30 am where guests were invited to talk to visitors about some aspect of living in Port Hedland. Speakers for this quarter were Arnold Carter, Ben Rose, Doris Tuefel, and Julie Arif. These speakers came back for several Fridays and spoke to visitors ranging from 5 - 10 in number speaking on topics of Rocks of the Pilbara, Port Hedland Fringing Reef, Establishing the first iron ore mine in the Pilbara, Rescuing and raising kangaroos and Port Hedland’s History.

**125 years of Port Hedland – Port Hedland Heritage Festival held on 16-22 October**

A week-long celebration led by the Port Hedland Historical Society was held from 16-22 October 2021.

On 17 October, a larger than usual Wedge Street Footpath Market was held to celebrate the 125<sup>th</sup> birthday of Port Hedland. The Visitor Centre organised 4 events over a period of 10 days with the assistance of a community grant of \$2,500 from FMG and financial assistance from the Port Hedland Historical Society. Attendance over the 4 events at the Visitor Centre was approximately 1,500.

The market included parade of nations, cake cutting, and various kids entertainment. It created a fantastic community birthday party feel with balloons, cake, music, and party games for families to enjoy. In kind support came from Deputy Mayor Renae Coles who assisted in donating gifts for the prizes and in supplying character costumes and volunteers to wear them to create a fun party atmosphere. Children participated in a treasure hunt and visited all the stalls and businesses in the area and had their treasure card stamped to get a prize. Stallholders, businesses, parents, and children all enjoyed getting around to stalls and businesses that they might have overlooked without the treasure hunt. A huge birthday cake for Port Hedland was cut after the children all sang “Happy Birthday Port Hedland” and was distributed to the community attending the markets.

Also, during the week of the Festival, the Hedland Maritime Initiative and Pilbara Ports Authority held kids in-colouring competition and all entries were on public display at the Hedland Maritime Initiative office on the same day as the market. The Hedland

Maritime Initiative office is located next to the Visitor Centre. The entries and the maritime displays contributed to the festivities and attracted community interests.



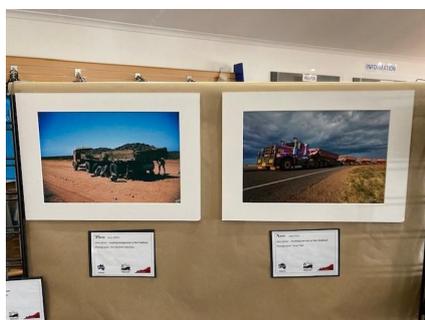
#### **Parade of Nations**

As part of the Wedge Street Footpath Market, the Visitor Centre organised the Parade of Nations to parade up Wedge Street from Dalgety House Museum to showcase the broad ethnic population of Port Hedland. The event was colourful with majority of the 25 participants waving the flags of their birth country. Countries represented included Turkey, Australia, USA, Ireland, Wales, Czechoslovakia, Poland, Sri Lanka, Philippines, Thailand, Yugoslavia, South Africa, and Italy.



**Port Hedland Then and Now exhibition**

The Visitor Centre, in collaboration with Hedland Camera Club, also put together a Now and Then Photographic exhibition; the opening night was held on 19 October followed by another night event on 20 October where Julie Arif shared her knowledge of the history of the town. Fifteen guests attended the opening night. Many thanks to Stuart Bell for coordinating the 2021 photos of Port Hedland. Thanks to the FMG grant which covered the cost of printing, mounting, and freighting the photos to Port Hedland. The exhibition was on show for 10 days and had a great response from all that viewed it and it generated a great deal of discussion about Port Hedland’s past. It also had good exposure on Facebook.



**A Brief History of Port Hedland**

On Tuesday, 19 October, a visual and oral presentation was delivered to an audience of 25 people. The 1.5hr presentation showcased a timeline of Port Hedland's history from the original people – the Karriyarra people to this date in time 22 October 2021. Photos on the big screen were shared with the story of significant events that have shaped the town.

**Port side Christmas Festival**

The Junction and Courthouse Gallery + Studio led this event.

The November Wedge Street Footpath market was held in collaboration with The Junction and Courthouse Gallery +Studio to create the portside Christmas Festival that saw the West end come alive with the Christmas spirit. The Visitor Centre organised non “makers” market stalls along Wedge Street, music by Jan Gillingham and her music students, a roaming Santa, and the Find Santa Treasure Hunt for children. Estimated attendance was 1,500- 2,000 across the whole precinct with the door count at the Visitor Centre getting to 881 on that night.





#### **Funky Christmas tree comp**

For the third consecutive year, the Visitor Centre has organised the Funky Christmas Tree promotion to encourage businesses in Port Hedland to create a tree of interest that reflects the nature of their business. This year, 11 entries were received across the town with some very creative trees submitted. Voting attracted 286 votes for the favourite tree which was Pilbara Tools and Fasteners tree built out of the boxes with their products in them.

#### **NWT Pick up Point**

The Visitor Centre have agreed to be the pickup point for the weekly newspaper, the Northwest Telegraph as they currently do not have anyone to distribute the paper.

#### **Santa's Mailbox**

A Santa letterbox at the Visitor Centre was promoted to increase local visitation to the Visitor Centre. A total of 30 letters were received with personal replies sent to the letter writers.

#### **KTA Tourism workshop held on 8 November**

Julie Arif attended the workshop with WA Tourism to have some input with the strategic planning for tourism in WA, in particular tourism in the Pilbara.

**Portside meeting/activities led by the The Junction**

Julie Arif attended meeting on 26 October. John Hague also attended meeting/event.

**Turtle daytime nesting tour and Reef walk**

At this time of the year tours and tourists are very sparse. There are limited tours available which have been the free Care for Hedland Turtle Tours/ Daytime Nesting tours and hatchling tours. Free guided reef walks with Doris Teufel continued until the weather got too hot. The Visitor Centre have been facilitating these activities for the last 3 years by promoting the events and taking bookings for the nesting tours.

**Thank you function**

The Visitor Centre and Pilbara Tours hosted a Thank you function for the supporters, sponsors, and stakeholders which was held at the Dalgety House Museum Gardens on 6 October.

**Organisational change**

John Hague has resigned from the Seafarers Centre effective 18 December 2021. John has remained connected with the Pilbara in his new role.

**Book exchange**

Remains available for those who wish to either exchange or buy second-hand books.

The Visitor Centre was closed from 23 December 2021 to 23 January 2022.

**January to June 2022**

Prior to opening after the holiday break, the centre had been prepared for the new regulations required for COVID. People directional grids in place to ensure that entrance and exiting visitors did not interact.

A common statement we hear is that tourists cannot find the Visitor Centre as it is set back from the road with no large signage to indicate where it is. To overcome this, we have purchased bright yellow new flags with the “i” sign to catch their eye as they drive down Wedge Street.

We have also enhanced the tabletops with informational map stickers to encourage visitors to sit and enjoy our Visitor Centre air conditioning and atmosphere as they plan their forward journey.



#### **Welcome Packs**

The Welcome packs that were started in 2021 continue to be well received with the High School requesting 25 packs, plus a welcome to Port Hedland presentation for their new staff to assist them settle into Port Hedland.

The Hedland Health Campus also requested 30 packs for their new staff. New residents to Port Hedland frequently make the Visitor Centre their first stop and we give out 2-3 Welcome Packs a week. This information was picked up by the media and an interview was done with ABC Kimberley about the Welcome Pack, how they are received and what they contain.

**Perth Airport WA Tourism Conference on 21-22 June 2022**

Nina Pangahas attended the Perth Airport WA Tourism Conference on 21-22 June 2022 which was held at the Perth Exhibition and Convention Centre. The afternoon before the conference, she also attended the exclusive Visitor Centre WA meeting where delegates were briefed on an upcoming People Counter project. The meeting was followed by a dinner with Visitor Centre WA representatives and officers.

Below is an extract of from her report including photographs:

"The speakers were impressive and inspirational. There was so much positivity, and I found the Visitor Centre WA meeting and the conference very valuable. During each session, delegates were invited to provide feedback on priorities as they listen to the presentation and panel discussions. The following top five priorities have been identified and these will be communicated to the public via social media:

1. Reactivate Perth as a world-class event destination by expanding Perth Convention and Exhibition Centre and building the city's reputation as Australia's top winter destination for major sporting and cultural events.
2. Build back international aviation capacity from Europe, the UK, and key Asian markets such as Japan and India.
3. "Sprinkle" Aboriginal culture and authentic experience throughout every visitor's journey in WA.
4. Speed up visa processing and market WA as Australia's best destination for working holiday makers, student, and skilled staff; and
5. Establish WA as the ultimate electric vehicle caravanning and road trip state."

The event was jointly presented by Tourism Council WA, Visitor Centres WA, Caravan Industry Association WA, FACET, WAITOC and Destination Perth and is supported by Tourism WA.

The 2023 Perth Airport WA Regional Tourism Conference will take place in Kalgoorlie-Boulder on **29 - 31 May 2023**. The conference will be the fourth held in regional location. Previous events were held in Albany in 2017, Karratha in 2019, and Geraldton in 2021.

In 2021, the Seafarers Harbour Tour started in April. However, it was cancelled for 6 weeks from 2 June because of the Port Authority’s maintenance work on the community jetty. This impacted the tourists as this is a very popular tour and has many good reviews. Visitors were anticipating this tour and were disappointed when it was not available for 6 weeks.

Pilbara Tours resumed their Twilight Industry Tours and Eco Salt Tours in April and May, respectively. The Town Discovery Tour resumed in May.

In 2022, the Seafarers Tours and Pilbara Tours commenced its tours in March and May, respectively.

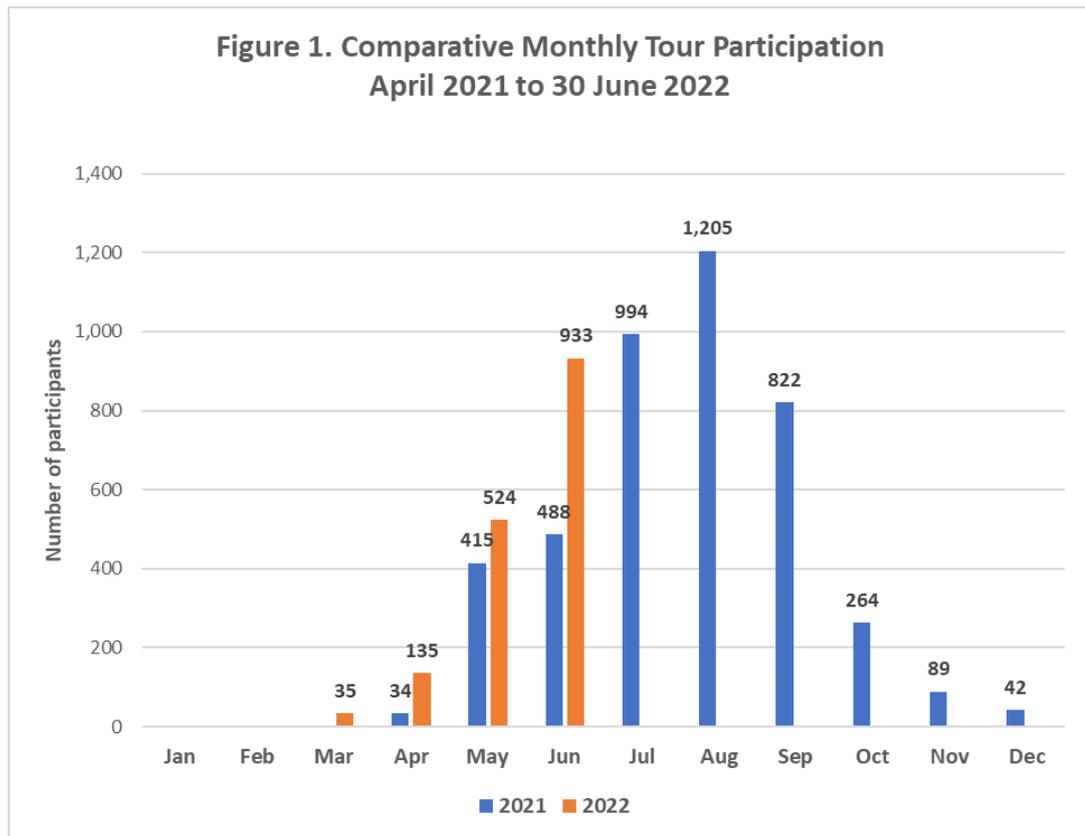
From April 2021 to 30 June 2022, the Visitor Centre and Seafarers Centre have facilitated a total of 480 tours with a total of 5,980 participants, consisting of 1,697 adults (28%), 3,947 seniors (66%) and 336 children (6%).

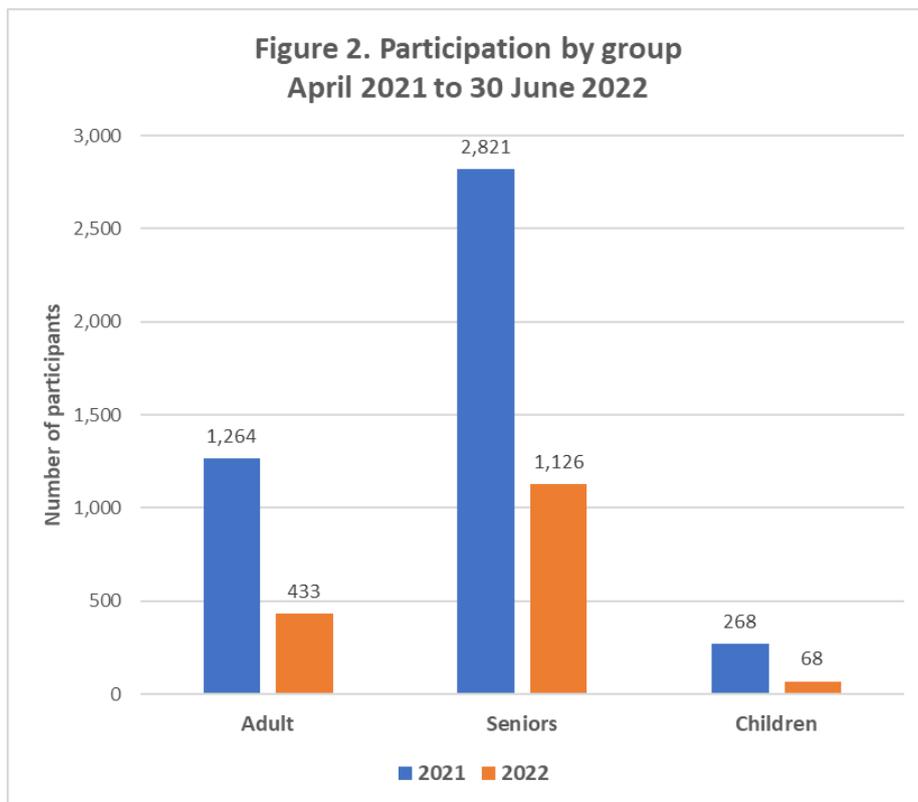
The Seafarers Fortescue Tour remains suspended because of COVID19.

The tours started in April 2021, hence the inclusion of April tour data in this annual reporting.

Also, it should be noted that the 2021 figures cover the full tourism period, whereas the 2022 figures only cover the start of the tourism period from April to June. This explains the low group participation in 2022 as shown in Figure 2.





8.2. Visitor Numbers

The number of walk-in visitors is captured by the Visitor Centre’s electronic people counter system. It should be noted that in the first quarter until 12 April 2021, the system did not work because of flat batteries in the sender/receiver units. However, the Visitor Centre had put in place since the beginning of 2021 a manual recording of walk-in visitors. The system was used to report walk-in visitors during the period when the counter system was not operational.

In 2021, the Visitor Centre delivered port talk in June until middle of July when the harbour tours were cancelled because of scheduled port maintenance. The port talk was held twice daily. It contributed to walk-in numbers in June and July as visitors returned to the Visitor Centre for the scheduled talks. The walk in-traffic from the electronic people counter system is shown under section 8.3.

The Visitor Centre was closed from 28-29 June 2022 for stocktake.

\*This figure was understated. The people counter system did not function from 23 July to September in 2021 due to battery failure. The numbers for this period were taken from the manual count of walk-in visitors during the period when the reception desk was not busy.

In the last quarter of 2020, the Visitor Centre have introduced a manual recording of walk-in visitors to capture a snapshot of the age profile and what visitors do when they enter the Centre. The Visitor Centre also tried to capture the nature of queries made in person or by phone. It should be noted that when the reception was busy and during periods of high traffic, not all queries were recorded.

Comparing the second quarter of 2021 and 2022, the walk-in visitors were mainly those belonging to the older cohorts above 60 years old. The numbers, however, were lower in 2022 compared to the same period in 2021.

9. Prevailing Marketing Conditions

The Visitor Centre receives regular newsletter updates from the Tourism Council WA (TCWA).

Following strong advocacy from TCWA, the State government lifted the total removal of the G2G pass from 29 April 2022 which meant that WA is now in alignment with other states with restriction-free international and interstate travels. The G2G pass had been creating uncertainty for international visitors and events, and the triple vaccination requirement had prevented 30% of Australians from visiting WA.

In its latest survey, the TCWA found that 65% of tourism businesses identified the G2G pass as the restriction most negatively impacting their business. The government also lifted the removal of 2 sqm rule and capacity limits on events. Together with the removal of the G2G pass this is a substantial step forward for WA tourism and events creating a favourable environment in the lead up to the tourism season.
