 - b) A Strategic Approach to Economic Development in WA
 - c) Important Local Government Infrastructure
 - d) A Sustainable Environment for Our Communities

PURPOSE

The purpose of this report is for Council to consider WALGA's submission on the 2020-21 State Government Budget, and support the Town's response regarding WALGA's position in the sector's priorities listed in the submission.

DETAIL

Each year, WALGA prepares a submission to the State Government outlining the sectors' priorities for the upcoming budget. For WALGA's submission to be considered in the 2019-20 Budget process, it must be submitted to the State Council in December 2019 for endorsement. The final State Budget submission is to be presented to Treasury in 2020.

Local Governments are to provide their advice and specific examples on the priority issues to WALGA by 27 September 2018, however the Town has been granted permission to submit its final submission following its October Ordinary Council meeting.

Submitting feedback on the above proposed strategic themes and priorities, will enable the Town to raise awareness in its local community about the need for continued funding for priority programs and infrastructure.

The Town has reviewed WALGA's Budget Submission to the State Government and has prepared a response which is outlined in Attachment 1 of this report. A brief overview of what the Town supports and provided comment on, in relation to the sector's priorities, are as follows:

- Legislative amendments and policy implications need to be considered by the sector and the appropriate levels of consultation.
- The removal of fees and charges from legislation and empowerment of Councils to set fees and charges for local government services.
- Develop a Regional Economic Development Strategy and Sports and Culture Infrastructure Strategy.
- Increase in State roads funding and prioritise funding in the Road Trauma Trust Account to maximise achievement of road safety outcomes.
- Funds raised from the Waste Levy are directed into strategic waste initiatives identified in the State Waste Strategy Action Plan.
