The Presiding Member declared Public Question Time open at 4:32pm.

Mayor, what was the date and the time when Cr McRae became a councillor?

The Mayor provided the following response:

He was sworn in on 27 March 2024 at 11am.

This whole matter occurred before he was sworn in. Why then, are we having this meeting, because he was not a representative of the electors of Port Hedland at that time?

The Mayor provided the following response:

He was actually a councillor on the date he elected. He actually won the election.

This whole meeting is based on the fact that he acted as a councillor. Why then are we having this meeting? He attended as a private citizen and as a citizen, we can do whatever we like in our lives and it doesn't affect the council. Why have you gone down this pathway when he wasn't even a councillor at the time? The fact he stood for election didn't matter. His role did not begin until he was sworn in.

The Mayor provided the following response:

Thank you for your question, please sit down.

I haven't had an answer though. It's a question that is relevant.

The Mayor provided the following response:

I told you that he was a councillor on the date he was elected as a councillor.

Note: The following questions were read by an English-speaking local Ukrainian community member, for several other community members.

4.1.2 Nataliya (surname not provided) – via interpreter

Regarding Cr McRae's statements, made after he was sworn in, in particular, his interview with "Aussie Cossack" on 6 April 2024. Was Cr McRae aware of charges against Simian Boicof (Aussie Cossack) in Sydney, laid by the NSW Police? That he has assaulted a 76 year old Ukrainian man at the Ukrainian support rally at Sydney's Town Hall?

Cr McRae provided the following response:

I'm aware of the charges against him in Sydney - He's been charged in absentia, as you're probably aware. I have seen the footage and the guilty charge was basically because he didn't show up in court as he wasn't in Sydney - the footage shown shows him being attaked by a Ukrainian flag bearer and he pushed him away and the man fell over. I'm not the judge in this case, I'm aware of that situation.

4.1.3 Yuri (surname not provided) – via interpreter

In his interviews after being sworn in as a councillor, Cr McRae made numerous comments on Ukrainian issues. According to the Department of Local Government, Sports and Cultural Industries, councillors should attempt to remain informed about current affairs at a state and national level. Since the full-scale Russian invasion, thousands of displaced Ukrainians have come to Australia seeking refuge, including me. This was widely covered in the press. Cr McRae, have you tried to contact and consult with your local Ukrainian community before making media statements? It could be done through the Town of Port Hedland Community engagement team, or the Association of Ukrainians in Western Australia.

Cr McRae provided the following response:

I have friends from Ukraine and Russia that I talk to often. I've studied and followed this horrible situation in Ukraine. I don't support Russia, I don't support Ukraine, I hate the war and the situation that's happening in your country right now. I also understand the geo-political situation that's manifested itself, particularly since 2014 in the Miyadon. I'm well aware of the US Undersecretary of State boasting at spending 5 billion US dollars to cement that coup and there was also a lot of violence that took place. As you would be aware ,when Gorbachev and Reagan made the agreement in the late 80s that NATO would not move a single inch to the east, there would be no militarisation creeping in around Russia's borders. The situation that happened in the Ukraine with them wanting to join NATO, that was Russia's red line. It doesn't make all this right and it's a horrible situation.

Okay so the answer is no? We need to know as a local community - you could have consulted with us.

Cr McRae provided the following response:

I'm sorry I didn't even know you were here. I'd love to talk with you about it, but I had no clue you were in Port Hedland.

As I said with the Town of Port Hedland engagement team, you can just google or find on Facebook, associations of Ukrainians, it wouldn't be a difficult task, thank you.

4.1.4 John Ashenden

Mayor Peter Carter, did the idea to push for a no confidence vote against Cr McRae come from your own thinking?

The Mayor provided the following response:

Yes, it did, thank you. Next question?

Do you think it is appropriate to propose a motion of no confidence against Cr McRae without discussing it with the rest of the council or other stakeholders? And why are you focusing on Cr McRae's trip to Russia when he wasn't even a council member at the time? Are there any specific laws he's broken?

The Mayor provided the following response:

I wouldn't say he's broken any laws, what I'm saying is I moved the vote of no confidence, it was my decision only to do that. I didn't consult any of the other councillors. It was my own decision at that time to do so.

Why did you propose to do that when he wasn't even a councillor - he hadn't even accepted?

The Mayor provided the following response:

He was elected.

Cr McRae, the media is suggesting you're a threat to national security, just because you're on the council. What's your take on that?

Cr McRae provided the following response:

I went to Russia to observe as an international foreign observer. When I reported back the truth of what I saw; that is the threat to the national narrative rather than a threat to the National Security. There's obviously a narrative being put out there and you

know we in the west beat the drums of war with Russia, and of course you know to get public support on side for any type of war, particularly a war with Russia, they need to have public support and the public need to think that Russia is not a democracy, but it clearly is a democracy.

4.1.5 Jillian Fisher

Councillor McRae, Channel 7, in their introduction to the news segment on Thursday the 28th of March, stated that the Russian government paid for your trip. Is this true? What expenses did they cover?

Cr McRae provided the following response:

I paid for my entire trip, paid for my hotel, paid for my food, even paid for my translator's meals at every lunch and dinner on every day through the election process but no, there was not a single cent paid for by the Russian government except for they did supply me a car and a driver to go anywhere and visit any voting booth over the election day process. Other than that, there was nothing. I was given nothing. It was all out of my own pocket.

And that car and driver was standard to the other servers?

Cr McRae provided the following response:

Yes, all 1,300 foreign observers had a car and driver provided.

To the Mayor and council - Why has this special meeting been called when it was satisfactorily answered on Thursday the 29th March by the CEO's statement that Adrian McRae travelled to Russia in a personal capacity. The Town does not comment on the personal activities of elected members. All elected members are subject to the Town's Code of Conduct. Can you explain why we are here tonight?

The Mayor provided the following response:

Yes, I called the Special Council Meeting for a vote of no confidence, next question?

Can you please cite specific sections of the Local Government Act that Cr McRae has breached?

The Mayor provided the following response:

That will come up later on in the meeting.

What's the difference between your private capacity in travelling to Vietnam, and Cr McRae's travelling to Russia?

There's a lot of difference, and I'm not going to get into it but there is a lot of difference.

As clearly stated by Cr McRae, he was over there to oversee an election process only and he has clearly stated he does not align with the values of what Putin stands for but merely took the opportunity to go over there to be able to see what happens during the election process in another country. Is WA aligned with the Victorian councils, that international conflicts are not he role of Local Councils?

Cr Blanco responded:

The local governments across WA and even across Australia have four things in common - roads, rates, rubbish and recreation. Local governments are not supposed to get involved in international affairs, climate change, all of the stuff that they seem to be getting involved in, so our mandate is the four Rs. Everything else is nothing to do with us -this should be a federal conversation.

When this motion was actually put ahead, had you prior before this motion, taken the time come out to have the conversation with councilor McRae whilst there was recently a briefing in which councilors had an opportunity to go ahead and ask councilor the questions if any concerns that they had including councilors assume uh allegedly saying that they too if they were given an opportunity would have gone over and seen an election process. So, when this was put up had you had a discussion with the councilor at the time?

The Mayor provided the following response:

No, I've had no discussion with Cr McRae.

Judging by the newspaper article that was written just recently that was out prior before in regard to this particular motion coming forward; was that the view of every single councillor? Was the rest of the council aware of what was said, and do they align to what was actually written in that particular article?

The Mayor provided the following response:

I approved the statement myself, that's all.

4.1.8 Jan Gillingham

Councillor McRae, I'd like to ask how many other worldwide representatives were either invited or attended to be scrutineers for the other candidates running in the recent elections in Russia and the elections overall?

Cr McRae provided the following response:

Over 2000 were invited, but there was just about 1299 from over 130 countries that included current and past US congressmen. It had members of current members of parliament from almost every country in Africa, almost every country in South America, what we call the "global south". There were over 1 million central election commission workers. There were over 300,000 volunteer observers working across all eleven time zones of Russia working on the election and they come from all the various parties and all the various candidates.

I'd like to ask mayor and councillors, but I'd just like to take everybody back to the Northwest Telegraph of March 13, which says, welcome mat out for the Town's new councillor. I was at the swearing in ceremony for newly elected councillor McCrae and the meeting that was held. I'd like to ask how many councillors, mayor included, actually welcomed councillor McCrae and reached out to welcome Councillor McRae at that swearing in ceremony? Because I did take the numbers down. So how many of you did actually go up and personally welcome newly elected councillor McRae?

Deputy Mayor Christensen provided the following response:

Unfortunately, I wasn't able to be present on the night. However, I did give a phone call to Cr McRae to congratulate him on his appointment and wish him all the best. I asked if he had any questions or concerns.

Cr Turner provided the following response:

Sorry, at the time I was unable to attend the ceremony due to a work commitment, but it's not a case of not welcoming or not being civil - I was simply not able to attend.

<u>Cr Rebello provided the following response:</u>

On the night in question, it had to be cancelled because Cr McRae was not in Town. But on the day it was set up, it was a morning and was very little notice to attend. However, when I came into chambers, the first thing I did was shook Cr McRae's hand and congratulated him.

My final question is to Cr McRae. Since this information is circulating around Australia and the world, how may councillors have you been able to reach out to, to discuss what is going to be discussed tonight? What I have heard was that there has been no consultation with the councillors at tonight's meeting; you've not been able to sit down and talk and maybe we would not be here this evening if there had been a consultation.

Cr McRae provided the following response:

I've spoken with most of the councillors here, either personally, one-on-one or we had a meeting in the back of the room here only a few weeks ago, as soon as I got back. And certainly Crs Christensen, Blanco and Butson have been the most proactive in reaching out to me. But everyone else, except for the Mayor - has actually sat down with me and we've had long discussions about it around the table. As mentioned, I accepted going on the trip in January, before I even put my name in the ring to run for council. I was quite shocked when, at our pre-meeting briefing it was said there would be a vote of no confidence. The Mayor has said it was just his doing, but he's the only one who hasn't spoken to me about it.

- Her migration story of coming to Australia 12 years ago, calling Hedland home for 10 years and becoming an Australian citizen 8 years ago.
- Her views on the Kremlin.
- Her views that Cr McRae is using the same "Kremlin generated narratives" that
 are manipulating opinions of Australians and when councillor McRae repeats
 Kremlin narratives, it amplifies the reach and credibility of the disinformation,
 as his words carry weight and are often trusted by his audience.
- The Ukrainian community's appeal to the council to condemn statements made by Cr McRae.

4.2.4 Yuliya – Ukrainian Community Member

Via interpreter - Yuliya spoke to:

- Being from Ukraine and now living in Port Hedland.
- Her thoughts on Cr McRae's statement in the media that there is discrimination against Russian speakers.
- That Ukraine's constitution guarantees rights and freedoms to all citizens, regardless of language preferences and recited a list of reasons why the Russian speaking people in Ukraine are not oppressed as stated by Cr McRae.
- Receiving all of her education in Russian despite Ukrainian being her state language.
- Ukrainian culture represented as inferior.

4.2.5 Svetlana – Ukrainian Community Member

Svetlana spoke to:

- Her journey from Belarus to escape antisemitism and to seek better opportunities. Migrating to the US and then coming to Australia on a visa, and eventually becoming a citizen of Australia.
- Living in Port Hedland for over three years.
- Her views on Russia and Cr McRae's views on Russia, questioning how he can represent the government body in Port Hedland.
- There being no benefit to keeping Cr McRae on council

Councillor Adrian McRae (Cr McRae) was elected to the Council at the 8 March 2024 Town of Port Hedland Extraordinary Election.

A notice of a Special Meeting of the Council dated 15 April 2024 (attachment 1) was received with the purpose of the meeting to consider a motion of no confidence in Councillor Adrian McRae. The rationale states;

To demonstrate to the Town of Port Hedland community that Cr McRae's public comments in relation to the Russian election are his own personal views and are not endorsed by the Town of Port Hedland Council.

It is important to note that there is no power under the *Local Government Act 1995* (the Act) for the Council to remove a Councillor from office and the Council decision would have no legal effect on the position or role of the Councillor. The Councillor is appointed by electoral processes under the Act and the role of Councillors is defined by section 2.10 of the Act.
